NOTICE OF PUBLIC WORKSHOP TO SOLICIT COMMENTS ON PROPOSED REGULATIONS

The Private Investigators Licensing Board of the State of Nevada is scheduled to hold a workshop proposing amendments/creation of regulations pertaining to chapter 648 of the Nevada Administrative Code:

1. Public Comment

Members of the general public may comment on matters appearing on the agenda and may bring matters not appearing on the agenda to the attention of the Board. The Board may discuss the matters not appearing on the agenda, but may not act on the matters at this meeting. If the Board desires, the matters may be placed on a future agenda for action. Public comments may be limited to 5 minutes per person at the discretion of the Chair but will not be restricted according to viewpoint.

Note: In addition to Public Comment taken at the beginning and end of the meeting, Public Comment may be accepted after each agenda item prior to the Board taking action. However, prior to the commencement and conclusion of a contested case or a quasi-judicial proceeding that may affect the due process rights of an individual, the board will not consider public comment, pursuant to NRS 233B.126.

Presentation and Public Comment Regarding Proposed amendments to Regulations

- 1. Continued discussion on training requirements for all work card holders and additional training requirements for persons working armed.
- 2. NAC 648.120 Proposed language will require the Executive Director's salary to be reviewed on an annual basis.
- 3. NAC 648.140 Proposed language will add to the duties of the Executive Director to serve as the custodian of records for the agency.
- 4. NEW NAC Proposed language will define the role of a Qualifying Agent.
- 5. NEW NAC Proposed language will establish annual license renewal fees.
- 6. NAC 648.260 Proposed language will clarify the requirement for a background investigation if a license holder has had their individual license placed in abeyance.
- 7. NAC 648.265 Proposed language will clarify the requirement of a license holder to place their license in abeyance to become a qualifying agent for a company.
- 8. NAC 618.310 Proposed language will establish who will conduct the examinations for licensure.
- 9. NAC 648.330 Proposed language will clarify the expectation of a license holder to place his or her individual license in abeyance to become a qualifying agent for a corporate license holder.
- 10. NAC 648.338 Proposed language will give authority to the Executive Director or designee to grant an exception for a work card to someone eligible to contribute to any public employee's retirement system.
- 11. NAC 648.3385 Proposed language will require a registered employee to have their provisional registration or registered work card on them while performing his or her duties and will require them to produce it upon request.
- 12. NAC 648.339 Proposed language will add the requirement of a registered work card holder to have his or her work card or provisional Identification on their person while performing his or her duties.
- 13. NAC 618.3403 Proposed language will increase the registration fees due from an applicant.
- 14. NAC 648.341 Proposed language will require all work card applicants to pass an examination and will adjust the passing score from 100% to 80%.
- 15. NAC 648.342 Proposed language will clarify who is responsible for ensuring each registered employee has passed the examination.
- 16. NAC 648.343 Proposed language will eliminate outdated requirements and establish audit procedures for the Board and a fine for failure to furnish the requested information in a timely manner.
- 17. NAC 648.3435 Proposed language will add the requirement of the Board to include completed firearm training in the system of records.
- 18. NAC 648.344 Proposed language will require a licensee to notify the Board of a new employee being added to their roster. This language will bring the number of days into compliance with the NRS and will establish how long an employee may stay on a company roster.

- 19. NAC 648.345 Proposed language will clarify the firearm prerequisites for license holders and registered work card holders working armed.
- 20. NEW NAC Proposed language will establish the Certification of firearm instructors and the renewal requirements while increasing the fee.
- 21. NAC 648.346 Proposed language will remove the actual course of fire from the NAC and establish the requirement of following an approved course of fire established and maintained by the Board.
- 22. NAC 648.350 Proposed language will establish the requirement of certified firearm instructors to record the completion of the firearm course in the participant's record in the agency's system of records.
- 23. NAC 648.431 Proposed language will increase the amount of fines for violations of provisions of Chapter 648 and establish mandatory Board review for certain infractions.
- 24. NAC 648.433 Proposed language will allow for credit or debit card payments of fines.
- 25. NAC 648.439 Proposed language will allow for credit or debit card payments of unlicensed activity citations.
- 26. NAC 648.530 Proposed language will clarify the need for licensees to add their license number to any vehicles associated with their work and will clarify badge requirements.
- 27. NAC 648.570 Proposed language will allow unlicensed persons to submit a bid on a Federal or State contract for activities regulated by this chapter; however, it does not permit that person to conduct any activity in the State prior to obtaining a license to do so.
- 28. NEW NAC Proposed language will establish a process for license by endorsement.
