5	activating that individual. It'll stay in abeyance for
6	him to become the qualifying agent. I just wanted to
7	qualify that for the record. Thank you.
8	BOARD CHAIRMAN ZANE: Mr. Nadeau?
9	BOARD MEMBER NADEAU: There was a question last
10	meeting, it seems, also dealing with the Secretary of
11	State. And I'm not real clear. But, Chairman Zane, I
12	believe, you brought it up, but something about the
13	corporate officers that were approved in this were not
14	on the Secretary of State's listing. I don't remember
15	the exact issue, but that do you recall what your
16	question was, or what? There was a question about the
17	corporate officers.
18	BOARD CHAIRMAN ZANE: I believe, on those two,
19	on this particular one, I believe that there was an
20	issue whether or not, I think, whether or not Ms. Hulett
21	was a member at the time.
22	MR. STEWART: I think, that might have been one
23	of the questions. But I did buy out my partner of 35
24	years. And I believe that his name and his wife's name
25	were on the old documents. So we've got those all

1 cleared up now. 2 BOARD CHAIRMAN ZANE: Okay. MR. INGRAM: Mr. Maxwell confirmed that. 3 BOARD CHAIRMAN ZANE: What's that? 4 MR. INGRAM: Investigator Maxwell did confirm 5 that. 6 7 BOARD CHAIRMAN ZANE: Okay. Apparently, the Secretary of State issue was resolved through staff. 8 Investigator Maxwell just indicated that the questions 9 were resolved. 10 BOARD MEMBER NADEAU: Great. I just wanted to 11 make sure that that was cleared up. Thank you, 12 Mr. Chair. 13 14 BOARD CHAIRMAN ZANE: Thank you, sir. 15 Any public comment regarding the motion? Is there any Board comment regarding the 16 motion? 17 All in favor of the motion, say "aye." 18 (Board members said "aye.") 19 20 BOARD CHAIRMAN ZANE: Any opposed, say "no." 21 Carries unanimously. 4	MR. FETROW: Yes. Hi.

6	have a seat and state your name for the record, please.
7	MR. FETROW: Yes. My name is Jack Fetrow.
8	BOARD CHAIRMAN ZANE: Okay. And what reason
9	did we have for bringing this over from December?
10	MR. FETROW: There was a mix-up internally in
11	our company on the dates. And my travel schedule was
12	scheduled in the wrong week.
13	BOARD CHAIRMAN ZANE: Okay. You couldn't make
14	it.
15	MR. FETROW: Well, I could have if we would
16	have not made a mistake.
17	BOARD CHAIRMAN ZANE: I see. Okay. All right.
18	Does staff have anything to add other than the
19	fact that we didn't hear it in the December meeting
20	MS. DONALD: No.
21	BOARD CHAIRMAN ZANE: regarding that?
22	MS. DONALD: I gave it all, nothing to add.
23	BOARD CHAIRMAN ZANE: Okay. All right. Can
24	you tell us a little bit about what your company is
25	about and what you're hoping to do in Nevada?

1	MR. FETROW: Absolutely. We are a nationwide
2	forensic engineering and fire investigation company. We
3	have recently opened offices in the western portion of
4	the United States, in Los Angeles, Phoenix, Seattle.
5	And we want to have a presence in the state of Nevada,
6	of course. And, of course, to do that, we must comply
7	with the licensure and laws. And that's what we're
8	doing, hoping to grow our business into the state of
9	Nevada.
10	BOARD CHAIRMAN ZANE: Okay. Is there any
11	public comment regarding the application, item number
12	eight?
13	Any Board comment regarding the application?
14	I'll entertain a motion.
15	BOARD MEMBER COLBERT: Mr. Chair?
16	BOARD CHAIRMAN ZANE: Yes, sir.
17	BOARD MEMBER COLBERT: I move that Donan
18	Engineering Company, Inc. be approved for a new
19	corporate private investigator's license, and that
20	Jack C. Fetrow be approved for his individual private
21	investigator's license, and that his individual license
22	be placed into abeyance so he can become the qualifying
23	agent, and the corporate officer to be approved is James
24	Lyle Donan, and this subject to all statutory and
25	regulatory requirements.

1	BOARD CHAIRMAN ZANE: Thank you.
2	We have a motion. Is there a second?
3	BOARD MEMBER NADEAU: I'll second that.
4	BOARD CHAIRMAN ZANE: We have a motion and a
5	second. Any Board comment regarding the motion?
6	All in favor, say "aye."
7	(Board members said "aye.")

9	Carries unanimous. Congratulations.
10	MR. FETROW: Thank you very much.
11	BOARD CHAIRMAN ZANE: Thank you.

13	Ms. Corral for all of her help, since I'm quite a few
14	miles away from here, and she was absolutely fantastic
15	to work with.
16	BOARD CHAIRMAN ZANE: That's great to hear.
17	MR. FETROW: And many times, I know people hear
18	when bad things happen. But when good things happen, we
19	appreciate that, too.
20	BOARD CHAIRMAN ZANE: Thank you.
21	MR. FETROW: Thank you.
22	BOARD CHAIRMAN ZANE: Item number nine,
23	corporate, or the heading of Corporate Officer.
24	BOARD MEMBER NADEAU: Mr. Chair, would you
25	accept a motion for a block vote?

1	BOARD CHAIRMAN ZANE: Yes, sir.
2	Let me throw an explanation out. Mr. Nadeau is
3	indicating that he wants to, he would like to make a
4	block vote, which means that he would take any number of
5	these agenda items that he personally doesn't see any
6	issue with where there may need to not be back-and-forth
7	extended testimony, everything's kind of fell in line
8	with these applicants, according to his point of view.
9	And then he'll get a second probably. And then each,
10	well, each individual Board member has the opportunity
11	to pull an agenda item out of that block vote
12	consideration, if there's something that we individually
13	had that we wanted to address regarding that
14	application.
15	So if the public has anything to say about any
16	of these, it's important for you to listen to what
17	Mr. Nadeau would like to include in his block vote.
18	Because if we don't see any opposition to any of the
19	things that he's considering, this will go like
20	lightning, and we'll be done with all of those items.
21	So if you want to be heard, and you hear that number,
22	you better interrupt us, because we'll go ahead and
23	vote. Any questions?

6	11, Steven E. Boehm, changing licensing status. Item

10	BOARD CHAIRMAN ZANE: We have a motion. Is
11	there a second?
12	BOARD MEMBER COLBERT: Second.
13	BOARD MEMBER NADEAU: Mr. Chair, I probably
14	need to include
15	BOARD CHAIRMAN ZANE: Yes.
16	BOARD MEMBER NADEAU: that this is subject
17	to all statutory and regulatory requirements.
18	BOARD CHAIRMAN ZANE: Thank you.
19	We have a motion and a second. Is there any
20	public comment about the agenda item numbers that were
21	just recited by Mr. Nadeau? Is there public comment in
22	the south?
23	I see none. Is there public comment in the
24	north?

22	BOARD CHAIRMAN ZANE: Okay. Mr. Kodba, could
23	you tell us a little bit about the change in the
24	corporate status of the or the license?
25	MR. KODBA: Superior is wanting to they have

1	a corporate office in California and two in Arizona.
2	And they're wanting to start a business in Nevada. So
3	they're asking me to be the qualifying agent.
4	BOARD CHAIRMAN ZANE: Okay. I've got to pull
5	it up here. I've to pull up the application on my
6	computer. Is there Board questions that can
7	BOARD MEMBER NADEAU: Mr. Chair?
8	BOARD CHAIRMAN ZANE: Yes, sir.
9	BOARD MEMBER NADEAU: Thank you Mr. Chair. I
10	just, in the investigation there it indicates that there
11	were two student loans that were outstanding and that
12	the investigator indicated that Mr. Kodba had worked out
13	an arrangement with the U.S. Department of Education. I
14	just wanted to confirm. And supposedly he was going
15	bring documentation to that effect to the meeting. And
16	I just wanted to follow up. Thank you.
17	BOARD CHAIRMAN ZANE: Thank you, sir.
18	MR. KODBA: Yes, I have, I have the
19	documentation from the student loan with me.
20	BOARD CHAIRMAN ZANE: Okay. If you will give
21	it to the investigator. Investigator Donald?
22	MS. DONALD: Investigator Donald. He's already
23	supplied it to me, and I have it. And he has a payment
24	plan worked out, to be on track.

6	BOARD MEMBER NADEAU: And if there's no other
7	Board concerns, I'd make a motion.
8	BOARD CHAIRMAN ZANE: Let me is there any
9	public comment regarding the license application number
10	13?
11	BOARD CHAIRMAN ZANE: Seeing none, please,
12	Mr. Nadeau.
13	BOARD MEMBER NADEAU: Thank you, Mr. Chair.
14	I'd move that Superior Protection Services NV, LLC be
15	granted a new private patrol license, that Walter P.
16	Kodba, license number 1674, be granted his that his
17	individual license be kept in abeyance and so that he
18	may become the qualifying agent for Superior Protection
19	Services Nevada, LLC. Corporate officers to be approved
20	are Victor Polek and Daniel J. Vincent. This is subject
21	to all statutory and regulatory requirements.
22	BOARD MEMBER COLBERT: Second.
23	BOARD CHAIRMAN ZANE: We have a motion. And,
24	Mr. Colbert, did you give a second?
25	BOARD MEMBER COLBERT: Yes, sir.

BOARD CHAIRMAN ZANE: 1 Thank you. Is there any Board comment or questions on the 2 3 motion? All in favor, say "ave." 4 (Board members said "aye.") 5 BOARD CHAIRMAN ZANE: Any opposed, say "no." 6 7 Carries unanimous. Congratulations. Thank 8 you. MR. KODBA: Thank you. I'd also like to 9 publicly thank Investigator Shelly Donald and Gisela 10 from the PILB Board. They did a wonderful job. 11 Thev helped me through that process. And I just wanted to 12 13 thank you publicly. Thank you. BOARD CHAIRMAN ZANE: Thank you, we appreciate 14 15 it. Item number 14, Bulwerks L.L.C. Is there 16 anybody here for Bulwerks? 17 MR. HUEBNER: Yes. 18 BOARD CHAIRMAN ZANE: Have a seat. 19 20 MR. WHITFIELD: Good morning. 21 BOARD CHAIRMAN ZANE: Can you each, one at a time, identify yourself? 22 MR. WHITFIELD: William Whitfield. 23 24 BOARD CHAIRMAN ZANE: How do you spell your last name? 2.5

1	MR. WHITFIELD: W-H-I-T-F-I-E-L-D.
2	BOARD CHAIRMAN ZANE: Okay.
3	MR. HUEBNER: Kenneth Huebner, H-U-E-B-N-E-R.
4	BOARD CHAIRMAN ZANE: Thank you.
5	Okay. What is the can you give us a little
6	bit of background and then tell us what you intend to do
7	with the license, if you were granted one?
8	MR. WHITFIELD: Well, I'm currently a PILB
9	license holder, an individual license, and I am going
10	into business with a new company, Bulwerks, and I'll
11	become the qualifying agent for them.
12	BOARD CHAIRMAN ZANE: Okay. Is there any
13	public comment regarding the license, or the agenda item
14	number 14?
15	None. Okay. Board comments, questions?
16	BOARD MEMBER COLBERT: Mr. Chair?
17	BOARD CHAIRMAN ZANE: Yes.
18	BOARD MEMBER COLBERT: I have a question with
19	Mr. Huebner there with this recent violation status on
20	conducting business without the license.
21	BOARD CHAIRMAN ZANE: Can we address that,
22	please?
23	MR. HUEBNER: Oh, yeah, you asked a specific
24	question. No, we actually it was a miscommunication.
25	We definitely were in the wrong. We had a company that

1	needed us to come and assist them and help them. They
2	had a prior security company. All their employees were
3	in 1099 status. We came in. We thought we were able to
4	function already under William's license. We found out
5	that was not the case. We didn't try to appeal it. I
6	immediately paid the citation so that we were back in
7	the good graces.
8	We were not trying to do anything that we were
9	not supposed to do. And, hopefully, you guys will
10	forgive us for that miscommunication and misinformation.
11	BOARD CHAIRMAN ZANE: Who's the staff
12	investigator that worked on the citation?
13	Okay. The nature of the violation, is
14	Mr. Huebner's representation here pretty much your
15	thoughts on the violation, the miscommunication?
16	MS. DONALD: Well, I found out about it when I
17	ran the queue, and there was an employee that didn't
18	have a work card, and he stated he was working for
19	Bulwerks. So Investigator Saladino and I went down to
20	the dispensary where this guard was working at, and they
21	had an armed guard working down there. And we spoke
22	with the owners, and they had had employees working down
23	there. And their company, they had the company hat and
24	whatnot on. And, you know, they weren't licensed yet.
25	So they did, the owners did say that they would

1	put their employees on, you know, the roster as W-2
2	employees. They did stop working them under Bulwerks
3	immediately. And we did issue the citation. And they
4	paid it the next day. So I felt they did, you know,
5	they took it seriously. They did stop working.
6	BOARD CHAIRMAN ZANE: Okay.
7	MS. DONALD: I feel like Mr. Huebner, you know,
8	felt he was working under Kenny's license, but I don't
9	know.
10	BOARD CHAIRMAN ZANE: Okay.
11	MR. INGRAM: Mr. Chairman, for the record
12	BOARD CHAIRMAN ZANE: Yes.
13	MR. INGRAM: Kevin Ingram. At the time that
14	we issued the citation, both Mr. Huebner and
15	Mr. Whitfield came into the office to discuss their
16	application and what they were trying to, what they were
17	trying to do with the license. And Mr. Huebner was very
18	straightforward. He made the same statements to me in
19	my office that he made here on the record. I counseled
20	him and educated them on how they need to do business
21	and how to move forward from this. He was apologetic.
22	He, again, paid the citation the next day and in the
23	hopes that the Board would consider their request.
24	BOARD CHAIRMAN ZANE: Thank you.
25	Any other Board questions?

1	Mr. Colbert, did that satisfy your request?
2	BOARD MEMBER COLBERT: Yes, sir, it does.
3	Thank you.
4	BOARD CHAIRMAN ZANE: Thank you.
5	Any other Board questions?
6	BOARD MEMBER NADEAU: Mr. Chair?
7	BOARD CHAIRMAN ZANE: Did I ask for public
8	comment already? Yes.
9	Yes, sir.
10	BOARD MEMBER NADEAU: Thank you, Mr. Chair.
11	Mr. Whitfield, were you you were under
12	contract for Bulwerks at the time; is that correct?
13	MR. WHITFIELD: Not as of accepting work
14	until after this hearing.
15	BOARD MEMBER NADEAU: Okay. So even though you
16	and Mr. Huebner entered into or signed contracts in
17	November, you were not actually employed by Bulwerks; is
18	that what I'm understanding?
19	MR. WHITFIELD: Correct.
20	BOARD MEMBER NADEAU: Okay. So you were not
21	advising them or you were not acting as far as an
22	advisor, as a qualifying agent. Were you aware that
23	they were doing business without a license? I guess,
24	that's my question, were you aware they were doing
25	business without a license?

1	MR. WHITFIELD: No, sir.
2	BOARD MEMBER NADEAU: Okay. And you do realize
3	you're under oath, right?
4	MR. WHITFIELD: (Nodded head affirmatively.)
5	BOARD MEMBER NADEAU: You swore and you took
6	the oath at the beginning of this meeting, correct?
7	MR. WHITFIELD: Yes, sir.
8	BOARD MEMBER NADEAU: Okay. Thank you. No
9	more questions, Mr. Chair.
10	BOARD CHAIRMAN ZANE: Okay. Any other Board
11	questions?
12	Entertain a motion.
13	Second call for a motion.
14	I'll make a motion that Bulwerks L.L.C., who is
15	applying for a new private patrol license, be approved.
16	William H. Whitfield, licensee number 2303B, is
17	requesting that his individual license be placed into
18	abeyance so that he may become a qualifying agent.
19	Member to be approved would be Kenneth C. Huebner. This
20	is subject to all statutory and regulatory requirements.
21	Is there a second?
22	BOARD MEMBER COLBERT: Second.
23	BOARD CHAIRMAN ZANE: Okay. We have a motion,
24	and we have a second. Board comments and questions
25	regarding the motion?

I have a comment. I make the motion so that the matter can be resolved. But, secondarily, and this has been an issue in the history of this Board, and that's whether or not we consider a license application at the point in time that there was previously disciplinary action discharged and whether or not that should interfere with the application process.

8 We have had different views, points of view 9 from legal counsel over time as to whether or not 10 someone that comes in, admits the violation, pays the 11 fine should be subject to any further type of discipline 12 like the postponement of any possible consideration for 13 license, licensure.

So it's one thing to say, well, we caught you, 14 and now we're going to punish you, and we're going to 15 stretch you out for six or eight months and maybe ruin 16 whatever opportunity you may have had. Would that 17 punishment fit the violation. We are considering some 18 different regulatory issues currently that would provide 19 20 us with the ability to say, for example, issue 21 discordsman orders, which would mean we come in and investigate, and we'd also have the ability, once we 22 convicted you, to also take all the money that you got 23 during the period of time that you were involved in 24 whatever nefarious activity you were involved in. 2.5 That

1	could be a seriously big discipline issue.
2	But we don't have that right now. What we have
3	is we've got the ability to give you a fine. You have
4	the ability to fight us and appeal it and take it
5	through the system. And then it'll work its way
6	through. But, of course, you're not going to be subject
7	to licensure anytime soon while that appeal is pending.
8	So, for the most part, people that have an
9	issue, we decide to take disciplinary action in the form
10	of a citation, and they pay it, our only quandary at
11	this time, and you can probably feel that with the
12	silence with the lack of a motion, is quite possibly we
13	may be dealing with somebody that we might not license.
14	But, on the other hand, without anything additional,
15	further, or extraneous than what we've heard here today
16	or what the staff has provided us for in the application
17	packet and their investigation, do we move forward and
18	treat people with the same level of fairness and treat
19	them contemporaneous with the calendar.
20	So that's why we're here now at this juncture.
21	Is there any other Board comment regarding the
22	motion?
23	BOARD MEMBER NADEAU: Mr. Chair?
24	BOARD CHAIRMAN ZANE: Yes, sir.
25	BOARD MEMBER NADEAU: Thank you, Mr. Chair.

1	I'm going to support the motion, only based on the
2	testimony that the Bulwerks was not under the was not
3	being guided, I guess, by the qualifying agent. And I'm
4	certainly hoping that the now that they have a
5	qualifying agent, they won't be acting in this regard.
6	So I will support the motion.
7	BOARD CHAIRMAN ZANE: Thank you.
8	Any other Board questions, comment?
9	All in favor of the motion, say "aye."
10	(Board members said "aye.")
11	BOARD CHAIRMAN ZANE: Any opposed, say "no."
12	Carries unanimous. Thank you.
13	MR. WHITFIELD: Thank you.
14	BOARD CHAIRMAN ZANE: If I'm not mistaken,
15	we're moving to item number 17, Merge Investigations,
16	Inc.
17	Can you state your name, please?
18	MR. NOTTOLI: David Nottoli.
19	BOARD CHAIRMAN ZANE: Okay. And the spelling
20	is correct on the agenda, N-O-T-T-O-L-I?
21	MR. NOTTOLI: Yes.
22	BOARD CHAIRMAN ZANE: Okay. All right. What's
23	your background and what are you hoping to accomplish
24	with your applications?
25	MR. NOTTOLI: My background, I've been, I

1	guess, a legal stalker for 27 years now. And I started
2	my own company six years ago. We have in the last six
3	years, we probably subbed out maybe a million dollars in
4	revenue to other licensed Nevada PIs, and I just thought
5	it's time to get that revenue back. And so we went
6	through the process of getting licensed and hiring our
7	own staff out here. Plus, I have several customers that
8	are doing a lot of construction work out here, and one
9	signed a it's a four-year multimillion-dollar
10	project, and so I feel it's better if I have my own
11	people out here to do that work.
12	BOARD CHAIRMAN ZANE: Okay. Is there any
13	public comment regarding the item number 17?
14	Don't see any in the south. Any in the north?
15	BOARD MEMBER NADEAU: No, sir.
16	BOARD MEMBER COLBERT: No.
17	BOARD CHAIRMAN ZANE: Okay. Any Board comment
18	regarding item number 17?
19	Entertain a motion.
20	BOARD MEMBER COLBERT: Mr. Chair, I'd move that
21	Merge Investigations, Inc. be approved a new corporate
22	private investigator's license and that David J. Nottoli
23	be approved for his private investigator's license, and
24	that his individual license be placed into abeyance so
25	that he may become the qualifying agent. This is

1	subject to all statutory and regulatory requirements.
2	BOARD CHAIRMAN ZANE: We have a motion. Do we
3	have a second?
4	BOARD MEMBER NIXON: Second.
5	BOARD CHAIRMAN ZANE: We have a motion and a
6	second. Any Board comment or questions regarding the
7	motion?
8	All in favor, say "aye."
9	(Board members said "aye.")
10	BOARD CHAIRMAN ZANE: Any opposed, say "no."
11	Carries unanimous. Thank you.
12	MR. NOTTOLI: Thank you.
13	BOARD CHAIRMAN ZANE: Appreciate it.
14	Number 18, Dorris & Associates LLC.
15	Good morning.
16	MR. DORRIS: Good morning.
17	BOARD CHAIRMAN ZANE: Give us your name for the
18	record, please.
19	MR. DORRIS: Michael P. Dorris, D-O-R-R-I-S.
20	BOARD CHAIRMAN ZANE: Thank you. Can you tell
21	us a little bit about your background and what you have
22	planned for Nevada?
23	MR. DORRIS: Yes, sir. I retired from the FBI
24	after 26 years, at which time I was doing extensive
25	investigations in a lot of different fields and a lot of

1	international investigations. Subsequently, I went to
2	work for a bank in Singapore, Credit Suisse AG, where I
3	managed corporate security across the Asia-Pacific
4	region. So I developed some experience in the security
5	consulting business.
6	Now that I've retired from both the FBI and
7	Credit Suisse, I would like to be able to conduct
8	investigations mostly internationally that's where
9	most of my client base should come from and also some
10	security consultancy, that I think I've learned how to
11	do both these craft over the years.
12	BOARD CHAIRMAN ZANE: All right. Is there any
13	public comment regarding item number 18 on the agenda?
14	Any Board comment?
15	Entertain a motion.
16	BOARD MEMBER NADEAU: Mr. Chair?
17	BOARD CHAIRMAN ZANE: Yes, sir.
18	BOARD MEMBER NADEAU: Thank you, Mr. Chair. I
19	would move that Dorris & Associates LLC be granted a new
20	corporate private investigator license, Michael P.
21	Dorris be granted his individual private investigator
22	license, that that license, his individual license be
23	placed in abeyance so that he may become the qualifying
24	agent for Dorris & Associates LLC. This is subject to
25	all statutory and regulatory requirements.

1	BOARD CHAIRMAN ZANE: We have a motion. Do we
2	have a second?
3	BOARD MEMBER COLBERT: Second.
4	BOARD CHAIRMAN ZANE: Move and a second. Any
5	Board comment or question regarding the motion?
6	All in favor, say "aye."
7	(Board members said "aye.")
8	BOARD CHAIRMAN ZANE: Any opposed, say "no."
9	Carries unanimous. Congratulations. Thank
10	you.
11	MR. DORRIS: Thank you.
12	BOARD CHAIRMAN ZANE: Item number 19, William
13	Bertain, Brattain.
14	MR. BRATTAIN: Brat.
15	BOARD CHAIRMAN ZANE: Brat. Okay. Good
16	morning.
17	MR. BRATTAIN: Good morning. Can you give us a
18	little bit of background and tell us what you are hoping
19	to accomplish?
20	MR. BRATTAIN: I've been a sole proprietor
21	private investigator for just a little over 20 years. I
22	worked for two different agencies before that. And what
23	I'd like to do is build a clientele here in Nevada and
24	quit traveling so much. I'm licensed in some other
25	states. And spend more time with my wife. So.

1	BOARD CHAIRMAN ZANE: Is there any public
2	comment regarding agenda item number 19?
3	Any Board comment regarding agenda item number
4	19?
5	BOARD MEMBER NADEAU: Mr. Chair?
6	BOARD CHAIRMAN ZANE: Yes, sir.
7	BOARD MEMBER NADEAU: I just had a question.
8	It's probably with staff or the investigator. If your
9	investigation office is located in the state of Nevada,
10	aren't you required to have a private investigator's
11	license with the State of Nevada?
12	And I understand that, Mr. Brattain, all of
13	your clients are outside the State of Nevada. But did
14	you have a business license in the State of Nevada?
15	MR. BRATTAIN: No, I didn't. I operated solely
16	on my licensing in the other states. And I didn't
17	advertise here. I only did investigations in like
18	Arizona, Indiana, Michigan. The only thing I had here
19	was a P.O. box to get my payments. But I had nothing
20	affiliated with doing any investigations in Nevada or
21	advertise such advertisement for Nevada.
22	BOARD MEMBER NADEAU: Kevin, did you understand
23	my question?
24	MR. INGRAM: Yes, I think I did. And that was
25	one of the things that we reviewed. There was no

1	indication of any advertisement or business actually
2	being conducted here in Nevada, on Nevada residents or
3	for companies here in Nevada. Therefore, based on the
4	laws and with counsel input, we felt he would not be
5	required to have a license here, just that he's solely
6	based here. If he had been advertising here, if he had
7	been conducting investigations here, then, by all means,
8	he would have needed to be licensed.
9	MR. BRATTAIN: Could I add something?
10	BOARD CHAIRMAN ZANE: Please.
11	MR. BRATTAIN: All right. I moved out here.
12	My wife is a recovering cancer patient. And this was
13	supposed to be a temporary thing, because they didn't
14	think my wife was going to survive. And she
15	miraculously is cancer-free. And I had always planned
16	on moving back to Indiana, because I have a son that
17	lives here with my grandkids, and she wanted to be
18	closer to the grandkids for that reason. And so,
19	basically, that's and now she wants to stay.
20	BOARD MEMBER NADEAU: Thank you, Mr. Chair.
21	That's all I have.
22	BOARD CHAIRMAN ZANE: I think, we visited this
23	one time briefly before, I believe, with another
24	licensee, Stealth Partners in Laughlin, Laughlin,
25	Nevada, where they are licensed in different states, but

they get their mail and the person individually lives in 1 Laughlin, Nevada because of its retirement nature. But 2 they do no advertising, nor any type of work in Nevada, 3 and that type of thing. 4 So, I think, we broached it before. I mean 5 it's a fine line to dance around. But as long as you're 6 7 not doing anything untoward that we can catch you doing. MR. BRATTAIN: I'm not. 8 BOARD MEMBER NADEAU: I'm good. Thank you. 9 BOARD CHAIRMAN ZANE: Thank you. 10 Any other questions? 11 Entertain a motion. Or do we have a motion? 12 Ι 13 forgot. MR. INGRAM: 14 No. BOARD CHAIRMAN ZANE: No motion. 15 Okav. Entertain a motion. 16 BOARD MEMBER COLBERT: Mr. Chair, I would move 17 that William L. Brattain, dba, Brattain Investigations, 18 be approved for his individual private investigator's 19 20 license. This is subject to all statutory and 21 regulatory requirements. BOARD CHAIRMAN ZANE: We have a motion. Is 22 there a second? 23 BOARD MEMBER NIXON: Second. 24 BOARD CHAIRMAN ZANE: We have a motion and a 2.5

8	MR. INGRAM: Glad to hear your wife's doing
9	well.

11	BOARD CHAIRMAN ZANE: Item number 20, Brosnan
12	Risk Consultants, Limited. Good morning.
13	MR. MCCLUSKEY: Good morning. John McCluskey.
14	BOARD CHAIRMAN ZANE: Okay. Mr. McCluskey, can
15	you tell us a little bit about your background and what
16	the company would like to do in Nevada?
17	MR. MCCLUSKEY: So Mr. Brosnan is a former NYPD
18	detective from the Bronx. I'm a former NYPD captain. I
19	moved out here a year and a half ago. His businesses
20	started in 1985. It's an investigative intelligence
21	business, security consulting as well. It's grown
22	tremendously over the last few years. He has recently
23	secured a contract with a major corporation that does
24	business in Nevada. And he will be taking security
25	operations over there. So he reached out to me and

1	asked if I can become his qualifying agent, which I have
2	no issues with, and then I'd run his business.
3	As I said, I did 23 years with the NYPD.
4	Fourteen years I ran a bank as a director of their
5	investigations, on a top 10 bank in the U.S. I'm
6	currently doing private I have my private
7	investigator's license in Nevada. I was here last June
8	for that. I haven't really taken any work with that.
9	I'm still a regional investigator with Cash America
10	SuperPawn. Which I will probably be separating from
11	them once Mr. Brosnan has me running the business.
12	And he apologizes for not being here. He's got
13	some well, they have a beautiful Nor'easter, which we
14	don't have experience with out here. So he was unable
15	to attend.
16	BOARD CHAIRMAN ZANE: He's done very well with
17	that Nevada pronunciation, too.
18	MR. MCCLUSKEY: Yes, I always said it right.
19	My guy that moved up here two years prior to me never
20	said it right. That has been since corrected.
21	BOARD CHAIRMAN ZANE: Is there any public
22	comment regarding item number 20?
23	Any Board comment regarding item number 20?
24	Entertain a motion.
25	BOARD MEMBER NADEAU: Mr. Chair?

1	BOARD CHAIRMAN ZANE: Yes, sir.
2	BOARD MEMBER NADEAU: Mr. Chair, I'd move that
3	Brosnan Risk Consultants, Limited be granted a new
4	corporate private patrol license, John G. McCluskey be
5	granted an individual private patrol license, and that
6	that license, his individual license be placed in
7	abeyance so that he may become the qualifying agent for
8	Brosnan Risk Consultants, LLP, or Limited, I guess.
9	Corporate officer to be approved is Patrick J. Brosnan.
10	This is subject to all statutory and regulatory
11	requirements.
12	BOARD CHAIRMAN ZANE: We have a motion. Do we
13	have a second?
14	BOARD MEMBER COLBERT: Second.
15	BOARD CHAIRMAN ZANE: Any Board comment or
16	question on the motion?
17	All in favor, say "aye."
18	(Board members said "aye.")
19	BOARD CHAIRMAN ZANE: Any opposed, say "no."
20	Carries unanimous. Congratulations.
21	MR. MCCLUSKEY: Thank you, Mr. Chair. Thanks,
22	ladies and gentlemen. And also for Shelly and Gisela
23	for the great job that they've always done in handling
24	my needs quickly, and this was a time-sensitive thing,
25	and it was a great job by them.

1	BOARD CHAIRMAN ZANE: Thank you.
2	MR. MCCLUSKEY: Thank you, appreciate it.
3	BOARD CHAIRMAN ZANE: Item number 21, Kerberos
4	International, Inc.?
5	Good morning.
6	MR. SMITH: Good morning.
7	MS. COLE: Good morning.
8	BOARD CHAIRMAN ZANE: Could you both state your
9	name for the record.
10	MR. SMITH: Sammy J. Smith.
11	MS. COLE: And Myra Cole.
12	BOARD CHAIRMAN ZANE: Okay. Welcome.
13	MS. COLE: Thank you.
14	BOARD CHAIRMAN ZANE: Okay. Can you give us a
15	little bit of background and what you'd like the company
16	to do out in Nevada?

20	military. And the other provides security guard
21	services mostly for federal facilities. So in Nevada,
22	we currently operate, or we have we're licensed in 11
23	states. We operate in four. There are a number of
24	federal facilities here in Nevada that we would like to
25	be able to provide security services for.

1	So we are, we would be honored to be licensed.
2	BOARD CHAIRMAN ZANE: Is there any public
3	comment regarding agenda item number 21?
4	Public comment?
5	Okay. Any Board comment regarding item number
6	21?
7	Entertain a motion.
8	BOARD MEMBER NADEAU: Mr. Chair?
9	BOARD CHAIRMAN ZANE: Yes, sir.
10	BOARD MEMBER NADEAU: Thank you, Mr. Chair.
11	I'd move that Kerberos International, Incorporated be
12	granted a new corporate private patrol license, Sammy J.
13	Smith be granted an individual private patrol license,
14	and that that license be placed, that individual license
15	be placed in abeyance so Sammy J. Smith can be the
16	qualifying agent. Corporate officer to be approved is

SMITH: Thank you. 11 BOARD CHAIRMAN ZANE: Item number 22, R & G 12 13 Securities LLC. Is there anybody here for R & G Securities LLC? 14 Okav. We'll trail item number 22 to the end of 15 the meeting. 16 Item number 23, 705 Investigations, LLC? 17 Good morning. 18 MR. DUNN: Good morning. 19 20 BOARD CHAIRMAN ZANE: Can you introduce 21 yourself and give us a little bit of background and tell us what you're hoping to accomplish? 22 MR. DUNN: Victor L. Dunn, retired Deputy 23 Chief, North Las Vegas Police Department, did over 25 24 years as police officer there. Before retirement, 2.5

1	worked for the North Las Vegas Constable's Office. What
2	I'm hoping to accomplish now, I have obtained my PI

17	that his individual license be placed into abeyance so
18	that he may become the qualifying agent. This is
19	subject to all statutory and regulatory requirements.
20	BOARD MEMBER NADEAU: Second.
21	BOARD CHAIRMAN ZANE: We have a motion. Do we

7	process, we get staff reports based upon the nature of

6	have a second?

8	BOARD CHAIRMAN ZANE: We have a motion and a

And I want to thank everybody up front for all the work they've done helping us. 16 So we're a couple of military veterans. Cary 17 and I have about 50 years of experience, primarily in 18 lots of high-consequence management experience in 19 20 Afghanistan and Iraq. Jenny, extensive canine training 21 experience. So our intent is to provide, stand up a new company here in Las Vegas for security services to 22 really focus to high-consequence events. 23 Unfortunately, our belief is there's a new norm 24 in America -- shootings, bombings, people running over 2.5

1	folks. That's what we have to defend ourselves against.
2	And our intent is to try and do that here, start here.
3	We think Las Vegas is particularly vulnerable in a way.
4	If you look at Cairo, Istanbul, their tourism business
5	went just to the rock bottom because of terrorist
6	events. And, frankly, I think Las Vegas has that same
7	sort of vulnerability. And we want to try and come in
8	there and start a new business to work that. Canines in
9	particular are a great way to defend against that.
10	So our intent as a business is to come in and
11	try and really focus on deter, defend and defeat
12	high-consequence events against the beautiful city of
13	Las Vegas here in Nevada. This would just be our first
14	step. We'd do other licensing applications after that.
15	Thank you, sir.
16	BOARD CHAIRMAN ZANE: Thank you. Anything
17	else?
18	Okay. Any public comment regarding item number
19	26?

11	little, police dogs, sight dogs and that sort of thing.
12	From there, when I started working, I worked all sorts
13	of dogs, sports dogs, obedience. And then I moved back
14	into the working dog realm in North Carolina and in Utah
15	working police dogs and detection dogs for government
16	agencies, private companies, that sort of thing.
17	BOARD CHAIRMAN ZANE: Okay. Is there any
18	public comment regarding item number 28?
19	Any Board comment regarding item number 28?
20	BOARD MEMBER NADEAU: Again, Mr. Chair?
21	BOARD CHAIRMAN ZANE: Yes, sir.
22	BOARD MEMBER NADEAU: Did you drive all the way
23	from Montello to Vegas?
24	MS. GUTHRIE: No, I did not. I was staying
25	with a friend.

1	BOARD MEMBER NADEAU: Okay. You don't have to
2	go into everything. I was just curious. Because I know
3	where Montello is.
4	MS. GUTHRIE: Yeah, it's a bit of a drive.
5	BOARD MEMBER NADEAU: The other question is,
6	obviously, the canine exam was administered and
7	completed?
8	MR. MAXWELL: Investigator Maxwell. Yes,

18	that her individual license be placed into abeyance so
19	that she may become the qualifying agent. This is
20	subject to all statutory and regulatory requirements.
21	BOARD CHAIRMAN ZANE: We have a motion. Is
22	there a second?
23	BOARD MEMBER NIXON: Second.
24	BOARD CHAIRMAN ZANE: Any Board comments or
25	question on the motion?

1	All in favor, say "aye."
2	(Board members said "aye.")
3	BOARD CHAIRMAN ZANE: Any opposed, say "no."
4	Carries unanimous. Congratulations. Thank
5	you.
6	Okay. It would be this time on the agenda that
7	we're going to take about a 15-minute break. And then
8	we will proceed on to registration appeals.
9	* * * * *
10	A break was taken, 10:20 to 10:34 a.m.)
11	* * * * *
12	BOARD CHAIRMAN ZANE: All ready in the north?
13	BOARD MEMBER COLBERT: Yes, ready to go.
14	BOARD CHAIRMAN ZANE: Thank you.
15	Everybody here? Okay.
16	MR. INGRAM: All right. Just for the record,
17	we have legal counsel Rosalie Bordelove on a speaker
18	phone, so I've got that close to the mic as well.
19	BOARD CHAIRMAN ZANE: All right. Now we're
20	going to move into that portion of the agenda titled
21	Registration Appeals.
22	For those of you that have been here throughout
23	the morning and saw the way the process worked, this is
24	a little bit different. These are considered to be
25	adversarial proceedings. So, therefore, the public

1	doesn't have any way to participate in any one of these
2	items. Now, if a person calls a witness or has somebody
3	that they want to introduce that has information that's
4	relative to the issue and needs to be heard, that's one
5	thing. The Board has the ability to call witnesses and
6	have testimony regarding their position on the
7	registration process. And the applicant has the
8	ability. But the public doesn't necessarily have any
9	input available at this stage, since it's an adversarial
10	portion of the proceedings. Before, you could jump up
11	and say I want to talk about this applicant. Here,
12	that's not the case.
13	So is there any question about that?
14	MR. INGRAM: Do we want to have Shannon go
15	ahead and swear everybody in?
16	BOARD CHAIRMAN ZANE: Yes, earlier we had
17	everybody sworn in, so that your testimony is taken
18	under oath, under the penalty of perjury. So we need to
19	make sure that everybody here that's going to be talking
20	or who's on the agenda or any witness that may be
21	brought along is also, likewise, sworn in.
22	So if you weren't sworn in this morning, please
23	stand, raise your right hand. And, hopefully, I can
24	impose upon the stenographer to issue an oath.
25	(Potential participants and witnesses in

1	Las Vegas and Carson City were sworn in by the
2	Reporter.)
3	BOARD CHAIRMAN ZANE: All right. Give me a
4	second so I can pull up the right one.
5	Okay. The first item is item number 29.
6	That'll be Eugene Brown. Is Eugene Brown here?
7	MR. BROWN: Yeah.
8	BOARD CHAIRMAN ZANE: Please come forward.
9	Good morning.
10	MR. BROWN: Good morning.
11	BOARD CHAIRMAN ZANE: Have a chair.
12	We'll ask the staff investigator on these on
13	how it came to be that we're here. And the staff
14	investigator will give a presentation. And then the
15	appellant will have the opportunity to discuss it and
16	answer questions or give testimony, whatever the case
17	might be. And then the Board has the ability to
18	question and answer, all that kind of stuff. So that's
19	the process.
20	So at this point in time, we'd say who's the
21	investigator that handled Mr. Brown, and they'd say?
22	MS. DONALD: Investigator Donald.
23	BOARD CHAIRMAN ZANE: And please proceed.
24	MS. DONALD: At the time when I submitted the
25	report, we had not received Mr. Brown's fingerprints

back. We have since received them. And there were no, 1 2 there was no new information to add. Mr. Brown did disclose his arrest. He had been convicted around 3 the --4 (The Reporter indicated it was difficult to 5 hear Ms. Donald in Las Vegas.) 6 MS. DONALD: Yes. So he had disclosed all of 7 his arrests. In 1993, he was convicted of his fourth 8 DUI. He was sentenced to 10 months in prison. And that 9 was all that he had on his arrest record. He hasn't had 10 anything since, and he disclosed it. And it was a 11 felony. That's why I had to deny him. 12 13 BOARD CHAIRMAN ZANE: Okay. Mr. Brown, do you 14 have anything to say? MR. BROWN: Yes, I do. First of all, I'd like 15 to thank the Board for allowing me this appeal. 16 I haven't had any traffic infractions since 17 then. And I feel that I've been gainfully employed, 18 until my retirement, working with -- I was a healthcare 19 20 provider, dialysis technician. I worked in a hospital 21 atmosphere. I'm good with people. And, therefore, I decided to apply for a guard card, to be gainfully 22 employed. 23 24 BOARD CHAIRMAN ZANE: Are there any Board 2.5 questions?

1	Entertain a motion.
2	BOARD MEMBER NADEAU: Mr. Chair?
3	BOARD CHAIRMAN ZANE: Yes, sir.
4	BOARD MEMBER NADEAU: Mr. Chair, I'd move that
5	Mr. Eugene Brown be granted registration and that the
6	denial be overturned.
7	BOARD MEMBER COLBERT: Second.
8	BOARD CHAIRMAN ZANE: We have a motion, and
9	there is a second. Any Board comment or question
10	regarding the motion?
11	BOARD MEMBER NADEAU: Mr. Chair, the time and
12	distance, no additional violations is all justification
13	for this motion. Thank you.
14	BOARD CHAIRMAN ZANE: Thank you, sir.
15	Any other Board question or comment?
16	All in favor, say "aye."
17	(Board members said "aye.")
18	BOARD CHAIRMAN ZANE: Any opposed, say "no."
19	Congratulations, sir.
20	MR. BROWN: Thank you very much.
21	BOARD CHAIRMAN ZANE: Thank you.
22	Item number 30, Timothy Todd Confair.
23	BOARD MEMBER COLBERT: He's up north.
24	BOARD CHAIRMAN ZANE: Item number 30. Okay.
25	Good morning.

1 MR. CONFAIR: Good morning. Who's the investigator on BOARD CHAIRMAN ZANE: 2 3 this? MR. MAXWELL: Investigator Maxwell. 4 BOARD CHAIRMAN ZANE: Can you give us a 5 briefing, please? 6 7 MR. MAXWELL: Yes. Mr. Confair was not made provisional in Nevada. In 2000, he was charged with 8 felony embezzlement, to which he pled guilty and 9 received a suspended sentence. The applicant did 10 disclose the arrest, and it was confirmed with the 11 12 fingerprint report. 13 BOARD CHAIRMAN ZANE: Mr. Confair, is there 14 anything that you'd like to discuss regarding the 15 conviction? MR. CONFAIR: First of all, I'd like to say 16 thank you for hearing my appeal. I appreciate that. 17 Ι know you all have a busy schedule. 18 In the investigation, when I did make my 19 20 mistake in 2000, I cooperated with the police every step 21 of the way during the investigation. I paid back the court-ordered restitution, and I completed all the 22 criteria that they gave me. And I've maintained my -- I 23 haven't done anything wrong since then, you know. I've 24 2.5 tried, you know, to just be a good citizen, a good

1	person. And I've raised two kids. And I haven't, you
2	know, I haven't done anything wrong.
3	I feel like I deserve a second chance. I don't
4	want to act like I'm entitled to it. But, like I said,
5	I appreciate you all's time on this. And, you know, if
6	I get my card, guard card, I've got a really good job
7	lined up with Securitas, and that's kind of what I'm
8	going for.
9	BOARD CHAIRMAN ZANE: Thank you.
10	Is there any Board questions?
11	When were you completely off paper, when were
12	you all done with the criminal justice program?
13	MR. CONFAIR: Well, because the restitution
14	took me a minute to pay back, it was probably '05. That
15	would be my best guess. I don't know the exact date.
16	BOARD CHAIRMAN ZANE: Okay. And what was the
17	nature of the act itself, what did they charge you with
18	doing?
19	MR. CONFAIR: It was embezzlement through
20	Boomtown. And I don't know all the criteria. It wasn't
21	my idea. I ended up wearing a wire on the person that
22	was in charge, and he got caught because of it.
23	BOARD CHAIRMAN ZANE: Thank you.
24	MR. CONFAIR: I'm not that smart. I don't know
25	that much how to, how to hide the money from anything

1	like that, you know, I have no idea.
2	BOARD CHAIRMAN ZANE: Well, that was
3	MR. CONFAIR: It was two credit cards, I know
4	that.
5	BOARD CHAIRMAN ZANE: Well, how do we make the
6	public feel comfortable if we're giving you a guard card
7	to protect something that you previously took off with?
8	MR. CONFAIR: Because I'm not that kind of
9	person. I learned my lesson, and I haven't done
10	anything wrong in almost two decades. I've been living
11	a clean life. And I don't break the law. I don't want
12	to end up in jail. I don't want anybody to not trust
13	me. My word is it's got to mean something. And for
14	the past two decades, it has, or almost two decades, it
15	has.
16	BOARD CHAIRMAN ZANE: Okay.
17	BOARD MEMBER NIXON: Mr. Chairman?
18	BOARD CHAIRMAN ZANE: Yes.
19	BOARD MEMBER NIXON: What have you been doing
20	for employment since?
21	MR. CONFAIR: Mainly working in warehouses. I
22	am certified to operate a forklift. And, you know,
23	warehouses, they'll do a background check, but it
24	usually only goes back, you know, seven to 10 years, or
25	whatever.

1	BOARD MEMBER NIXON: Okay.
2	BOARD CHAIRMAN ZANE: Any other Board
3	questions, comments?
4	MR. CONFAIR: I'd like to say I'm sorry for
5	what I've done. I know that that's not me. And that's
6	not how I live my life anymore. I don't want to be that
7	person. That's not me. And I hope I could put you at
8	ease.
9	BOARD CHAIRMAN ZANE: Okay. Any other Board
10	questions, comments?
11	Entertain a motion.
12	BOARD MEMBER COLBERT: Mr. Chair, I move that
13	Timothy Todd Confair, his denial be reversed based upon
14	time and space and no further issues with law
15	enforcement since this time.
16	BOARD CHAIRMAN ZANE: There's a motion. Is
17	there a second?
18	BOARD MEMBER NIXON: I second.
19	BOARD CHAIRMAN ZANE: We have a motion and a
20	second. Any Board discussion on the motion?
21	All in favor, say "aye."
22	(Board members said "aye.")
23	BOARD CHAIRMAN ZANE: Any opposed, say "no."
24	Carries unanimous. Congratulations.
25	MR. CONFAIR: Thank you very much. I

1	appreciate it. That's awesome.
2	BOARD MEMBER NADEAU: You're done.
3	BOARD MEMBER COLBERT: You're done. Thank you.
4	MR. CONFAIR: Thank you very much.
5	BOARD CHAIRMAN ZANE: Item number 31, Kisha
6	Cooley?
7	Good morning.
8	MS. COOLEY: Good morning.
9	BOARD CHAIRMAN ZANE: Have a chair, please.
10	Who's the investigator on this?
11	MS. DONALD: Investigator Donald.
12	BOARD CHAIRMAN ZANE: Please.
13	MS. DONALD: I attached a spreadsheet to the
14	report. The applicant failed to disclose any arrests.
15	She stated on her denial letter that because she got
16	married she didn't know she was supposed to report any
17	since her name changed. She had 51 undisclosed arrests;
18	however, none of them appear to be felonies.
19	BOARD CHAIRMAN ZANE: Okay. Ms. Cooley, was
20	there something in the process well, actually, can
21	you respond to that?
22	MS. COOLEY: My arrests?
23	BOARD CHAIRMAN ZANE: Yes, how come you didn't
24	list all your arrests?
25	MS. COOLEY: Because I changed my last name,

1	and I didn't know that they had to go there, under a new
2	last name. So I didn't put it. It wasn't I it
3	wasn't something I was hiding. I just didn't know.
4	BOARD CHAIRMAN ZANE: Okay.
5	MS. COOLEY: And if from the past, my past,
6	that I changed my life. I got married. I just had two
7	kids, two more kids, twins. So I don't live that life
8	no more.
9	BOARD CHAIRMAN ZANE: Okay.
10	MS. COOLEY: That's the past life that I lived.
11	And I moved out here to get my life better. And I've
12	been doing, I've been working at U.S. Security
13	Associates in California since August. And before that,
14	I was doing in-home care for an elderly lady. So I
15	moved here to change my life for me and my four kids.
16	BOARD CHAIRMAN ZANE: Was there some part of
17	the application process where it led you to believe that
18	you didn't need to disclose your criminal history past,
19	although you've changed your name?
20	MS. COOLEY: Yeah, but it yes. I mean I
21	didn't know if I was supposed to put it, because my last
22	name is changed. But it wasn't like I was hiding it,
23	because I knew it was going to come up when they ran my
24	name. I just didn't know if I was supposed to state it.
25	That was the only reason. Like California, I would not

1	put it on the application in California. I was under a
2	last name, my new last name, and I didn't put it there.
3	BOARD CHAIRMAN ZANE: Okay.
4	MS. COOLEY: And I have a guard card in
5	California still, to this day.
6	BOARD CHAIRMAN ZANE: Okay. Anything else?
7	MS. COOLEY: Well, I just wanted to be able to
8	go to work and take care of my family and provide for my
9	kids.
10	BOARD CHAIRMAN ZANE: Okay.
11	MS. COOLEY: And, B, instead of me going back
12	to California every Sunday to go to work, I want to just
13	stay at home and be able to go to work from here, doing
14	security, like I've been doing in California. Like
15	that's a big gap between. I could be home for two days,
16	and then I have to go back to California for another
17	five days. That's inconvenient for my kids, you know.
18	Like I'm really trying to change my life. I
19	know I have a past, and I know it's a lot. But I'm
20	willing to change my life as I've been changing my life.
21	It doesn't happen overnight, if you guys give me a
22	second chance to prove it to you that I'm a better
23	person. I don't live that life that I was living
24	before.
25	BOARD CHAIRMAN ZANE: All right. Any other

1	Board questions?
2	Entertain a motion.
3	BOARD MEMBER COLBERT: Mr. Chair, I move that
4	Kisha Cooley, her denial be upheld based upon her
5	failure to disclose and a history of failure to comply
6	with law enforcement over the years.
7	BOARD CHAIRMAN ZANE: Okay. Is there a second?
8	BOARD MEMBER NIXON: I second.
9	BOARD CHAIRMAN ZANE: Okay. We have a motion
10	and a second. Any Board comment or question regarding
11	the motion?
12	All in favor, say "aye."
13	(Board members said "aye.")
14	BOARD CHAIRMAN ZANE: Any opposed, say "no."
15	Okay. Unfortunately, the appeal has been
16	denied. You can reapply for consideration in a year.
17	At that point, you'd want to make sure to make full
18	disclosure on the application, no matter what your name
19	might be.
20	MS. COOLEY: All right.
21	BOARD CHAIRMAN ZANE: All right. Thank you.
22	Darryl Davis, item number 32.
23	Good morning.
24	MR. DAVIS: Good morning.
25	BOARD CHAIRMAN ZANE: How are you?

1	Who's the investigator?
2	MS. SALADINO: Investigator Saladino.
3	BOARD CHAIRMAN ZANE: Please.
4	MR. SALADINO: The applicant was denied for a
5	June 2nd, 2017 misdemeanor CCW in vehicle, where the
6	applicant received three years of probation and 120 days
7	suspended sentence from jail. And he's currently on
8	probation for the misdemeanor CCW charge.
9	BOARD CHAIRMAN ZANE: Okay. Mr. Davis, can you
10	tell us a little bit about the circumstances surrounding
11	your arrest and ultimate conviction?
12	MR. DAVIS: Well, at the time, I was homeless
13	in Pasadena, California. And I had just gotten my gun,
14	my gun license, which I could show you right now. I had
15	a gun license. So I just purchased a gun license, and I
16	decided to buy a gun from somebody but didn't check out
17	the background on the gun, so, and it came back stolen.
18	So the gun was in my home, in my car with all of my
19	stuff, because I didn't have nowhere to put it.
20	Everything I had, it was in my car.
21	I got stopped at 7:00, 8:00 in the morning for
22	a taillight. So they took me out of my car and
23	everything. And I even showed them my gun license, and
24	I'm like, "Man, you guys can take the gun, like I don't
25	care, but I have a gun license." It's not like I'm just

1	riding around with stolen guns or anything. So they
2	take me to jail. They said it was concealed. But
3	everything was just how I did it with the rules and the
4	gun laws in California. My clip was away from the gun.
5	It was all separate.
6	So I don't know what this, I don't know why
7	they gave me the concealed. What you guys tell me now,
8	I didn't even know it was that deep. I thought I was on
9	summary, I always thought I was on summary in the court.
10	So I didn't know I was on like CCW probation. I
11	wouldn't even like, I probably wouldn't even have tried
12	to like come, because that's like kind of serious. And
13	he already told me about the probation thing. So it's
14	like, it's crazy.
15	BOARD CHAIRMAN ZANE: Were you represented by
16	an attorney in the case?
17	MR. DAVIS: No, I wasn't represented by an
18	attorney in the case.
19	BOARD CHAIRMAN ZANE: Okay.
20	MR. DAVIS: But, like I said, I mean I got my
21	gun license. And I've never had a felony. I've never
22	had a misdemeanor, too. I've been doing security since
23	2014. This year, they all let me work for about three
24	months. So I'm thinking everything is okay. I'm
25	thinking I'm on summary probation. I talked to people,

1	and they said, "Okay. It's okay. You're on summary
2	probation." And then I get the denial letter. And the
3	next thing you know, I can't do anything at all for
4	Christmas. I have a one I mean I have a six-year-old
5	son. I couldn't do anything for him for Christmas. I
6	couldn't do anything.
7	And this is the first time I ever got in
8	trouble and with the law. And then, too, I have a gun
9	license to back up my case. But it just seemed like
10	they didn't want to take that into consideration in the
11	court, so.
12	Basically, that's all I want to say. Besides
13	that I'm on probation, I'm not a bad person. I've never
14	gotten in trouble. I have no felonies on my record or
15	misdemeanors. So that's all I got to say.
16	(Cell phone ringing.)
17	MR. DAVIS: Sorry.
18	BOARD CHAIRMAN ZANE: How long are you on paper
19	for, when did this thing get resolved?
20	MR. DAVIS: Well, 120 days, and it's already
21	up. That's for sure.
22	BOARD CHAIRMAN ZANE: Well, that was the
23	suspended sentence. But that comes back into play if
24	you violate the terms of your probation. So it's never
25	up until you're done, because if you violate, you go to

1	jail for 120 days.
2	MR. DAVIS: Yeah, and I haven't got in trouble.
3	I'm not a troublemaker. I don't get in trouble. The
4	only reason why I got caught up like that, because I was
5	homeless and living out my car. I had two jobs living
6	out of my car. I couldn't live with my aunt because she
7	was on Section 8. And you know how that goes. My mom
8	is damn near homeless. I can't stay with my mother. So
9	I'm out there. I've just been trying to get everything
10	by myself.
11	BOARD CHAIRMAN ZANE: Right.
12	MR. DAVIS: And after I went to jail, I came
13	out here, because I was homeless, to my cousin's house.
14	And he said I he was already doing security. He
15	said, "I got a security company I can put you. You just
16	need to get your guard card and everything." And I got
17	my guard card in California right now. So I came out
18	here so I wouldn't be sleeping on the streets. Came out
19	here, went and applied for my guard card. I had a
20	hundred dollars. Somebody helped me with the other
21	hundred. I got my guard card. They said I can work
22	for three months, whatever, the probation period. And
23	I've been working. I haven't been in trouble. It's
24	been 10 months now. I haven't gotten into no police
25	contact.

1	BOARD CHAIRMAN ZANE: What California agency?
2	I mean you said you had a California guard card. But
3	that was before you got in trouble, right? You got the
4	guard card before you got in trouble?
5	MR. DAVIS: Yeah, I got it before I got in
6	trouble.
7	BOARD CHAIRMAN ZANE: Okay.
8	MR. DAVIS: I got my guard card and my gun
9	license. Before, I didn't have it.
10	BOARD CHAIRMAN ZANE: Okay.
11	MR. DAVIS: Like I said, it was just an
12	unfortunate event that I got caught up in my car, being
13	homeless, and I had to have all my stuff with me.
14	BOARD CHAIRMAN ZANE: Okay. Then, it's your
15	position, you say you have a concealed weapons permit?
16	MR. DAVIS: I don't have a I have a gun
17	license, a gun registration.
18	BOARD CHAIRMAN ZANE: A gun registration.
19	Okay.
20	MR. DAVIS: But, like I said, I wasn't trying
21	to conceal nothing.
22	BOARD CHAIRMAN ZANE: Right.
23	MR. DAVIS: Everything was how the law was
24	supposed to be, the gun law supposed to be, because I
25	had the clip away from the gun and no bullets, and

1	everything was just how it was. The clip wasn't in the
2	gun, and it wasn't loaded, nothing. I just had the gun
3	in my trunk, because, and I even told the police that
4	like, "I'm homeless. All of my stuff is there." They
5	went through my I had two, three bags of clothes in
6	there and everything. Basically, that was my apartment.
7	BOARD CHAIRMAN ZANE: I'm not able to pull it
8	up. What does the rap sheet indicate as the actual?
9	MR. SALADINO: The original charge started off
10	as grand theft of a firearm, and then it got reduced
11	down to the misdemeanor CCW.
12	BOARD CHAIRMAN ZANE: So the gun you bought
13	ended up being stolen?
14	MR. DAVIS: Yeah. And, you see, they reduced
15	it because, I guess, I showed them my gun registration.
16	I have a gun registration. So they reduced it to being
17	concealed. But I wasn't concealing when it's in my car.
18	Like where was I supposed to have it, on me?
19	BOARD CHAIRMAN ZANE: Okay. So the conviction
20	is for a misdemeanor?
21	MR. SALADINO: Yes, sir.
22	MR. DAVIS: It's crazy.
23	BOARD CHAIRMAN ZANE: So according to what
24	information we have, when would he be done with the
25	system?

1	MR. SALADINO: It would be June, June of 2020.
2	BOARD CHAIRMAN ZANE: June of 2020.
3	MR. DAVIS: And now I want to say I appreciate
4	you all giving me the appeal and to speak my piece,
5	because I just felt like I was just down in a different
6	way. So I'm glad you all were giving me an appeal and
7	letting me talk to you guys. I appreciate that.
8	BOARD CHAIRMAN ZANE: Okay. Any other Board
9	questions?
10	MR. DAVIS: No matter the outcome.
11	BOARD CHAIRMAN ZANE: For me, you kind of
12	present a quandary. Because as a general rule, we've
13	hold that if you're in the middle of a criminal justice
14	incident, that we don't give you a lot of consideration
15	until that is expired, you know. Not even a compelling
16	case for the fact that if they had the goods on you,
17	they would have charged you and you'd be doing time
18	right now for that particular type of charge.
19	MR. DAVIS: Yeah.
20	BOARD CHAIRMAN ZANE: You know, and the fact
21	that it went all the way down to a misdemeanor
22	violation. I mean that would be the judge's position
23	that they could summarily, as you put it, give you a
24	fine and, you know, somebody who wanted to make sure
25	that you were on the hook for a little while. So that's

1	a quandary that I have is whether or not you should be
2	given the opportunity to work in a security field or
3	related field while you're pending a misdemeanor
4	criminal conviction matter.
5	MR. DAVIS: And, like I say, I've been doing
6	security from '14, since 2014, and I have never had an
7	issue. That's how I supported my son. This is the
8	first year I've couldn't really, I didn't even see him
9	for Christmas, and I just
10	BOARD CHAIRMAN ZANE: Well, for me, I got to
11	set aside I understand the hardship, but I got to set
12	it aside, because there's a lot of people that we deal
13	with, and a lot of them are under some criminal penalty,
14	and they've had a hard time as well, but.
15	Any other Board questions?
16	Entertain a motion.
17	BOARD MEMBER COLBERT: Mr. Chair, I'd move that
18	Daryl Davis' denial be upheld based upon the fact that
19	he's still currently on probation.
20	BOARD MEMBER NADEAU: I'll second that motion.
21	BOARD CHAIRMAN ZANE: We have a motion. Do we
22	have a second? Okay. We have a motion and a second.
23	Any Board comment or questions regarding the motion?
24	BOARD MEMBER NADEAU: Mr. Chair?
25	BOARD CHAIRMAN ZANE: Yes, sir.

1	BOARD MEMBER NADEAU: Thank you, Mr. Chair.
2	This Board has consistently tried to give someone an
3	opportunity. But we have consistently held that if
4	someone is currently serving probation or some type of
5	court supervision or something of that nature, that we
6	will uphold the denial.
7	BOARD CHAIRMAN ZANE: Any other Board
8	questions, comment?
9	All in favor of the motion, say "aye."
10	(Board members said "aye.")
11	BOARD CHAIRMAN ZANE: Any opposed, say "no."
12	Passes unanimous. Sorry. You're eligible to
13	reapply in a year.
14	MR. DAVIS: In a year?
15	BOARD CHAIRMAN ZANE: Yes.
16	MR. DAVIS: Thank you. Appreciate it.
17	BOARD CHAIRMAN ZANE: Number 33, Adam help
18	me out here. Adam.
19	MR. ELHIFNY: Elhifny.
20	BOARD CHAIRMAN ZANE: Elhifny?
21	BOARD MEMBER COLBERT: Yes, sir. He's up
22	north.
23	BOARD CHAIRMAN ZANE: Thank you.
24	Who's the investigator?
25	MR. SALADINO: Investigator Saladino.

1	BOARD CHAIRMAN ZANE: Please.
2	MR. SALADINO: The applicant was denied for a
3	two thousand let's see. It was a 2007 grand larceny
4	where he received 12 to 32 months in NSP. And also for
5	a weapons charge in '05 for possession of nunchucks
6	where it was a gross misdemeanor, and it was later
7	reduced to breach of peace.
8	BOARD CHAIRMAN ZANE: Okay. Can you tell us
9	about the criminal history?
10	MR. ELHIFNY: Yes, Mr. Chairman. The
11	possession of nunchucks got dropped down. It was
12	actually just a minor pocketknife, one of those ones you
13	can buy at a 7-Eleven. And I'm not sure why the
14	arresting officer kind of wrote it up like that.
15	The following convictions were more serious. I
16	did have a serious drug problem I developed since a
17	teenage age that moved into my 20s, and it's gotten me
18	in into a lot of serious trouble.
19	Since, since the last conviction, since the
20	last time I've been to prison, I've been sentenced to
21	house arrest, rehab, adult drug court, probation,
22	parole. And I've completed everything. And not only
23	completed it, I've completed one of the toughest adult
24	drug court outpatient programs here in Nevada with
25	honors. And I've actually been offered employment with

1	that adult drug court program to help other ex-felons
2	and recovering drug addicts, in that industry.
3	Since, since that time, I've maintained gainful
4	employment, constantly. I'm currently a heavy equipment
5	operator with the Operating Engineers Union, Local 3,
6	and I have been for the last year.
7	I've turned down the employment opportunity to
8	work with the adult drug court program only because at
9	time I was already making more money than what they'd
10	offered me. But I've been volunteering with them since.
11	And I'm currently a board member on the steering
12	committee for a violence prevention program called
13	United Against Violence here locally in Reno, Nevada.
14	I just moved out here in Carson City. We've,
15	I've just bought a house out here in Carson City, and
16	I've moved out here since. I have a list of character
17	reference letters, everything from my probation officer
18	that was supervising me, to my case manager through my
19	adult drug court program, and my drug and alcohol abuse
20	counselor, all the way to current and previous employers
21	as well.
22	And I can honestly say that life is definitely
23	behind me. Employment isn't the issue for me,
24	Mr. Chairman. It's I have a passion for this industry.
25	I was good at being a bad guy, or I thought I was back

1	then. But I found out very quickly I make a better good
2	guy. And I would like to get into security consulting
3	to help prevent future incidents and to bring the
4	adversarial mindset to the industry. I have a great
5	passion for the industry.
6	I have a list of accomplishments and
7	certifications that I have accomplished, that I
8	submitted to the Board. I'm not sure if you guys have
9	that, but I have another copy of that, along with a list
10	of character reference letters as well.
11	BOARD CHAIRMAN ZANE: Okay. Thank you.
12	Any Board questions?
13	BOARD MEMBER NADEAU: Mr. Chairman?
14	BOARD CHAIRMAN ZANE: Please.
15	BOARD MEMBER NADEAU: Thank you, Mr. Chairman.
16	So there's a selling there for you, Schedule 1
17	and 2 controlled substance. What were you and that
18	was we don't have a disposition on that. Was that
19	just tied into the conspiracy to commit grand larceny,
20	or what?
21	MR. ELHIFNY: I was in possession of a
22	controlled substance. And they did try to say that
23	there was a you know, the amount that I had with me,
24	they said it's not just personal use, you have to be
25	selling it.

1	BOARD MEMBER NADEAU: Okay.
2	MR. ELHIFNY: And like I did say, I was in a
3	dark place in my past, and I did have serious issues,
4	absolutely.
5	BOARD MEMBER NADEAU: What was the disposition
6	of that charge?
7	MR. ELHIFNY: It got dropped down to these
8	charges. I do have a fingerprint FBI background
9	printout of my history. What they did was they that
10	final disposition, they said rehab; upon completion of
11	rehab, to be released into adult drug court program
12	while on house arrest. No. Sorry. Before the house
13	arrest, I had to do a halfway house. And upon
14	completion of the halfway house, I had to do the house
15	arrest.
16	The adult drug court program, when I entered
17	it, had a 97 failure percent ratio when I entered it.
18	And I'm shocked that I passed it actually. It was just
19	one of the toughest things I've ever done, between the
20	counseling, the therapy, the groups, the meetings, check
21	in, check out, ongoing drug testing. I think that a
22	sober person would have a hard time completing that
23	program. But by the grace of God, I was able to get
24	through it and come out a better man for it.
25	BOARD MEMBER NADEAU: Thank you.

1	BOARD MEMBER NIXON: Mr. Chairman?
2	BOARD CHAIRMAN ZANE: Yes, ma'am.
3	BOARD MEMBER NIXON: On the investigator's
4	summary, it says that you were issued a cease and desist
5	letter, that you were advertising on Craigslist to be a
6	bodyguard?
7	MR. ELHIFNY: Yes. So I was working just as a
8	bouncer. And I sought out more and more training. I
9	got training in executive protection, security
10	consulting, crisis management, disaster recovery. And
11	I've traveled for this training, and it's costed me a
12	lot of money. Unfortunately, and this was due to my
13	negligence, I did not do my due diligence. And just,
14	you know, being so pumped up about the industry, I
15	didn't do the proper research, and I was not aware that
16	I had to, had to have a PPO license. As soon as the
17	investigating officer did call me and give me that cease
18	and desist, I immediately went straight down to the PILB
19	Board and applied for a work card.
20	And if granted the opportunity, I would like to
21	continue to further in my in the field the right way.
22	And that's why I am here today, to do things the right
23	way, and to not only further my interest in the career,
24	but to further the Board, you know, to further, to
25	further the industry, industry as well.

1	BOARD CHAIRMAN ZANE: Okay. Anything further,
2	any other questions?
3	I'm not able to pull it up on mine. When was
4	he done with all of his conviction responsibilities and
5	sentencing and probations?
6	MR. ELHIFNY: I kind of
7	MR. SALADINO: It's 2013.
8	BOARD CHAIRMAN ZANE: And you said?
9	MR. SALADINO: It's 2013.
10	BOARD CHAIRMAN ZANE: 2013. Okay.
11	Any other Board questions?
12	Entertain a motion.
13	Second call for a motion.
14	BOARD MEMBER COLBERT: Mr. Chair, I'd move that
15	Adam Elhifny's denial be reversed, and based upon all
16	the information he's presented here today and that
17	there's been no further issues since that date and time,
18	and it was all disclosed to the Board.
19	BOARD CHAIRMAN ZANE: Is there a second?
20	BOARD MEMBER NIXON: I'll second based on time.
21	BOARD CHAIRMAN ZANE: We have a motion and a
22	second. Any Board discussion on the motion?
23	BOARD MEMBER NADEAU: Mr. Chair?
24	BOARD CHAIRMAN ZANE: Yes, sir.
25	BOARD MEMBER NADEAU: I'm going to support the

1	motion in this case. I think, the applicant has been
2	forthright, or at least appears to be forthright, and
3	disclosed all the information. He's it looks like
4	he's trying to turn things around. And so for that
5	reason, I'll support the motion.
6	BOARD CHAIRMAN ZANE: Any other Board comment
7	or question?
8	And I would I will not support the motion,
9	based upon a lack of time and the boldness of the
10	previous criminal history. I fully understand the
11	motion itself. But with the secondary approach with
12	regard to the cease and desist, that causes me some
13	issue. So I won't be supporting it. But I understand
14	the motion. So.
15	Any other Board questions, comments?
16	All in favor, say "aye."
17	(Board members said "aye.")
18	BOARD CHAIRMAN ZANE: Any opposed, say "no."
19	No.
20	Carries three to one. Congratulations.
21	MR. ELHIFNY: Thank you, Mr. Chairman.
22	BOARD CHAIRMAN ZANE: You're welcome.
23	MR. ELHIFNY: Thank you, sir.
24	BOARD MEMBER COLBERT: Don't let us down.
25	MR. ELHIFNY: I won't. Thank you.

1	BOARD CHAIRMAN ZANE: Item number 34, Nicholas
2	Giaquinto ("Gee-ah-kwin-toe").
3	MR. GIAQUINTO: "Jee-ah-kwin-toe."
4	BOARD CHAIRMAN ZANE: Giaquinto. Good morning.
5	MR. GIAQUINTO: Good morning.
6	BOARD CHAIRMAN ZANE: Okay. Who was the
7	investigator?
8	MR. SALADINO: Investigator Saladino.
9	BOARD CHAIRMAN ZANE: Please.
10	MR. SALADINO: The applicant was denied for a
11	2005 felony aggravated arson. The applicant did
12	disclose it. And he received five years of probation
13	for it.
14	BOARD CHAIRMAN ZANE: Can you tell us a little
15	something about that?
16	MR. GIAQUINTO: Absolutely. So, at the time, I
17	just got out of high school, 2004. I was already taking
18	several medications for my ADHD, ADD and depression.
19	And at the time of me being in high school, my curiosity
20	of history was at a peak, so I was doing multiple
21	things, like going into abandoned buildings to
22	investigate history for myself, by writing down things.
23	And I became attached to a ShopRite that was around the
24	corner from my current living in Lakehurst, New Jersey,
25	where I proceeded to, you know, go in there on a daily

1	basis, de-stress, because sometimes my mental would kick
2	in, you know, to the fullest extent. And I get
3	depressed, and this would cheer me up, because I would
4	have memory from the loss of my grandpa.
5	Come 2005, I found out that they were knocking
6	the building down. There were several other issues
7	going on, and which, also, one of them was my
8	psychiatrist or yeah, psychiatrist then kind of went
9	on vacation, so I could not get any of my meds. And it
10	was a tough imbalance between just about to start
11	college back up again for my graphic design degree.
12	And I, I guess you could say, flipped the
13	switch. I ended up, you know, talking to a friend who I
14	was on good terms with, but he was a very disturbed
15	individual, even when I knew him in high school, and it
16	kind of gave me the push to, you know, use a little
17	fire, to like, you know, just set let's set
18	something, you know, on fire, not necessarily burn the
19	building down, but to, you know, set a pallet or
20	something by the ShopRite, do something.
21	So I my reasoning wasn't intact at the time.
22	I was 19. So we went in there with only the intention
23	to actually only burn, you know, a pallet, you know,
24	which we did. We were just unaware that it caught, you
25	know, all the wires and everything that was kind of

hanging down from the ceiling and ended up burning the building with it. No one was injured in the process, but I was caught. Let's see. I committed the act at like 8:00 or 9:00 o'clock at night, was caught at 2:00 in the morning.

I complied with the police. Because at the 6 7 time before this, when I was in high school, I had made a small group for myself. We were wanting to be, 8 wanting to be a vigilante group that would want to do 9 good. You know, we've always heard, you know, people 10 getting into fights, all kinds of weird noises around 11 the town that indicated that people were in trouble. 12 So 13 we wanted to do something like that.

So I wasn't -- I didn't fight with the police. I knew I was caught. And I was straight up about what happened. Me and my friend ended up going to jail, where I was in there for three months before I was bailed out.

And since then, you know, I learned that I --I've been -- I was on medication up until I came out here, in which case I had a gentleman, who I'm living with, who we were living with, with my girlfriend at the time, now my wife, showed me what I'm missing in my life. Outside counseling that I'm doing and the counseling I was doing during my probation, I feel like

1	I had the new control that I didn't have before, when I
2	was on the medication, in which case now I want to do
3	some good for the community like I've been doing
4	without, that I was doing without the private
5	investigator part.
6	I've taken time, I take time to help friends
7	who I've known that were on drugs that are now off them.
8	I've been there for shoulders to cry on. I just want to
9	do some good in the community by taking this card, and
10	show the community that I am a different person.
11	This has bound me from background checks to
12	better jobs I could have gotten. And this is the first
13	time I can actually come forth and prove to you guys
14	that I can do something more myself than what I've been
15	doing.
16	These are papers from public records in
17	New Jersey. That just gives any information, I think,
18	that can be possibly get from it. I've done absolutely
19	nothing except for maybe a couple of traffic violations
20	and minor things like that, that I was either unaware of
21	or was being dumb about at the moment.
22	But I'm a completely different person. This is
23	something I'm wanting to do, especially since my father
24	passed two years ago. He was a security guard, and he
25	was a darn good one. So I kind want to follow in his

1	footsteps. And this is something that's entrusted me.
2	I have a security guard I'm also friends with. We've
3	been friends for the past eight years, nine.
4	MAN IN LAS VEGAS: About 10.
5	MR. GIAQUINTO: About 10. I've talked to him,
6	and I feel like it's he's a straight honest person.
7	He's never gotten in trouble, except for maybe his
8	mother. And other than that, we've been really close on
9	that. And he can vouch for everything I told you.
10	BOARD CHAIRMAN ZANE: Any Board questions?
11	BOARD MEMBER NADEAU: No.
12	BOARD MEMBER COLBERT: No.
13	BOARD CHAIRMAN ZANE: Well, what, when you were
14	seeing the psychiatrist, what was the diagnosis?
15	MR. GIAQUINTO: The diagnosis was ADD, ADHD and
16	depression.
17	BOARD CHAIRMAN ZANE: And now you're saying at
18	a certain point you no longer have medication for any of
19	those?
20	MR. GIAQUINTO: Correct. I've been through
21	counseling. I've managed to deeply suppress my
22	depression. And through, I'm going to call it verbal
23	counseling through, you know, several people who are of
24	older age than me and taught me how to control my focus
25	for my ADD, ADHD. It doesn't have that high effect on

1	me like it used to. Where before, I would act without
2	thinking, and now it's all thinking before acting.
3	BOARD CHAIRMAN ZANE: Now, what did you have in
4	mind with this card, what kind of employment were you
5	hoping to achieve?
6	MR. GIAQUINTO: To be honest, my friend is part
7	of a security company called C
8	MAN IN LAS VEGAS: Contemporary Services
9	Corporation.
10	MR. GIAQUINTO: And he's told me that these
11	people looking for work, and that are looking for people
12	to work with them. And I was like, okay, that sounds
13	good to me. You know, if I was able to get this appeal
14	and get the license, I'd probably more likely be working
15	with them and probably with them on several shifts.
16	BOARD CHAIRMAN ZANE: Okay. Did you have in
17	mind that you would be working in an environment in an
18	armed capacity?
19	MR. GIAQUINTO: I wasn't that wasn't my
20	first initial thought. But I figured, you know,
21	security guards, you know, have some sort of armament on
22	them. I would think whatever licenses I needed or
23	anything else I needed at that point, and I would, you
24	know, handle it with, you know, extreme care, doing
25	whatever I had to do to uphold it.

1	BOARD CHAIRMAN ZANE: Again, when was he off
2	his criminal justice?
3	MR. SALADINO: It should have been about 2011,
4	according to my note.
5	BOARD CHAIRMAN ZANE: Okay.
6	MR. GIAQUINTO: The sentence was made on
7	January 1st of 2006, and then ended 1-1-11.
8	BOARD CHAIRMAN ZANE: Okay. And the sentence
9	was what?
10	MR. GIAQUINTO: Aggravated arson.
11	BOARD CHAIRMAN ZANE: No, the sentence.
12	MR. GIAQUINTO: Oh, it was five years
13	probation.
14	BOARD CHAIRMAN ZANE: So the only jail time you
15	did was up until the time you got bailed out?
16	MR. GIAQUINTO: Right.
17	BOARD CHAIRMAN ZANE: Okay.
18	BOARD MEMBER NIXON: Mr. Chairman?
19	BOARD CHAIRMAN ZANE: Yes.
20	BOARD MEMBER NIXON: What have you been doing
21	for employment?
22	MR. GIAQUINTO: Since then, I've executed my
23	best skill, which is customer service, taught to me by
24	my father. So I was doing salesman and restaurant work.
25	There's a lot of things on my resume I don't have, due

1	to the fact that I don't put anything on my resume
2	that's less than six months. But it's a lot of
3	restaurant work. I was a waiter. I was in warehousing,
4	you know, boxes and things, a moving company. I was
5	part of at one point a gas station in New Jersey. A
6	variety of jobs. I had to give myself the edge in doing
7	whatever I needed to do and gain more skills. I
8	enjoyed, I enjoyed every bit of it.
9	But when I came out here, I've been working for
10	a watch company. I worked at one point at New York and
11	Company at the Galleria Mall. Cracker Barrel up on
12	by the Silverton.
13	So that's what I've been doing out here for
14	work.
15	BOARD MEMBER NIXON: Thank you.
16	BOARD CHAIRMAN ZANE: Any other Board
17	questions?
18	BOARD MEMBER COLBERT: Mr. Chair?
19	BOARD CHAIRMAN ZANE: Yes, sir.
20	BOARD MEMBER COLBERT: I have one question for
21	you. How long have you been off all medication?
22	MR. GIAQUINTO: I've been off medication since
23	I moved down here. So that would be January 30th, 2012.
24	BOARD MEMBER COLBERT: Okay. Thank you. No
25	further.

1 BOARD CHAIRMAN ZANE: Any other Board comment 2 or question? Entertain a motion. 3 Second call for a motion. 4 I'll make a motion that we overturn the denial 5 and issue the registration to the appellant. Is there a 6 7 second? I'll second. BOARD MEMBER NADEAU: 8 BOARD CHAIRMAN ZANE: There's a motion and a 9 second. Any Board comments or questions regarding the 10 motion? 11 I have reservations about overturning the 12 13 denial, but it's mostly based upon your interpersonal issues. You know, I don't know you from anybody. 14 You come in, you have this arson conviction, which it's 15 clear you predicate it upon the fact that you had issues 16 dealing with pressure and depression and different 17 things. And then you're wanting us to give you the 18 right to work in an industry that has a profound effect 19 20 on people and their lives. So it's difficult. I mean I make the motion so 21 that we can have it on the floor. But, you know, right 22 as we sit here at this moment in time, I don't even know 23 if I'll support my own motion. But I make it, because, 24 25 you know, I do have a little bit of concern about what I

1	hear, based upon the history. And not so much the
2	history on the criminal event. Because I understand you
3	did the right thing. They caught you, they had you, and
4	you squared it up. But from a mental health
5	perspective, for me, it would almost be better if you
6	came in and said "I'm under current care, and I have a
7	professional here that has said I'm all good." But from
8	everything I see, you decided to go cold turkey and fix
9	yourself. Get a support mechanism, and you're doing
10	what appears to be pretty good.
11	MR. GIAQUINTO: I have, I have a counselor I am
12	seeing. I actually have her card in my wallet. Her
13	name is Jenna. I was seeing her for the past four
14	years, so two years after I came out here. But you're
15	right, I did go cold turkey, you know, just completely
16	off the meds. I was convinced I didn't need them, with
17	just a little bit of mental focus for myself. And when
18	I tried to adjust it, I was able to do that.
19	I figured out, also, a lot of working at
20	PlayStation, for tech support, that I ended up how I
21	got over my depression, because it was a very
22	high-stress environment, mind you. You know, it may not
23	seem like it was, even dealing with just the call
24	center. I learned how to deal with my depression better
25	by just doing things, that even if they even if they

1	didn't sound good to me at the time, something I'd like
2	to do actually reduced it drastically, to the point
3	where I didn't feel anything. And I also have my wife
4	to support me. And I haven't even nothing normal lately
5	to harm myself in over it'll be now 12, 20 years, you
6	know. So I haven't. There has been no record of it
7	anywhere, because it's, it was all minor injuries, and I
8	failed that, and that was when I was even younger than I
9	was during the conviction.
10	But it's I needed to be up front with you
11	with this. You know, I wasn't going to hide it.
12	Because somewhere, some way, you know, I know it'll come
13	back and bite me if I omit it. So I know that now. I
14	have that carved into me.
15	But I would understand from your perspective
16	why you would be hesitant in your own decision. But I'm
17	asking. I'm not a big nerd. That's what it comes down
18	to. I use gaming, I use it as a necessary means to have
19	fun, and it reduced my depression, actually helps me
20	with my focus. So I've become almost way better than I
21	was before in this. And that's why I'm asking for the
22	appeal.
23	BOARD CHAIRMAN ZANE: Okay. Any other Board
24	comments, questions?
25	BOARD MEMBER NADEAU: Mr. Chair?

1	BOARD CHAIRMAN ZANE: Yes, sir.
2	BOARD MEMBER NADEAU: I seconded the motion so
3	that we could have this discussion. It's been over 10
4	years. Granted, he was on probation. I don't know that
5	I heard when he got off probation. But he was on
6	probation for a period of time. It's been 10 years.
7	So, I guess, that's where I'm at on that as far
8	as the discussion goes.
9	BOARD CHAIRMAN ZANE: Anything else?
10	BOARD MEMBER COLBERT: Mr. Chair, I have
11	concerns, also, with it being a high-stress environment
12	and how he'll be able to cope with that environment and
13	what would happen when the pressure is on.
14	BOARD MEMBER NIXON: Mr. Chair?
15	BOARD CHAIRMAN ZANE: Yes.
16	BOARD MEMBER NIXON: I agree with you. I have
17	an issue or a concern with him going off the meds.
18	I'm happy to hear that you are seeing a
19	counselor formally. But I also have some concern.
20	BOARD CHAIRMAN ZANE: Okay. We have a motion.
21	All in favor, say "aye."
22	BOARD MEMBER NADEAU: Aye.
23	BOARD CHAIRMAN ZANE: Aye.
24	BOARD MEMBER NIXON: Aye.
25	BOARD CHAIRMAN ZANE: Any opposed, say "no."

1	BOARD MEMBER COLBERT: No.
2	BOARD CHAIRMAN ZANE: Okay. Three to one.
3	Congratulations. Don't make a fool out of us.
4	MR. GIAQUINTO: I won't. Thank you very much.
5	Thank you very much for your time.
6	BOARD CHAIRMAN ZANE: Number 35, Ivan Hamilton?
7	You're Mr. Hamilton?
8	MR. HAMILTON: Yes, sir. Good morning.
9	BOARD CHAIRMAN ZANE: Have a chair. Thank you.
10	Who's the investigator?
11	MR. MAXWELL: Investigator Maxwell.
12	BOARD CHAIRMAN ZANE: Please.
13	MR. MAXWELL: Mr. Hamilton was made
14	provisional. When we received his fingerprints, we
15	found several arrests, all out of Florida. 2003, he had
16	a trespass. The type was unknown. 2003, petty larceny
17	theft, type unknown. Also 2003, trespass again, type
18	unknown. 2006, cocaine purchase attempt, which was a
19	felony. He was convicted and served 32 days in jail.
20	2008, larceny petty theft, misdemeanor, which he entered
21	a plea of nolo contendere and was found guilty.
22	None of the arrests were disclosed. All were
23	found on the fingerprint report. The applicant did
24	state that the drug charge was supposed to have been
25	expunged on completion of the drug program that he

attended in Miami, Florida. 1 BOARD CHAIRMAN ZANE: Okay. Mr. Hamilton, can 2 3 you address all of that? MR. HAMILTON: Yes, sir. Good morning to the 4 I was accomplishing -- I'm recovered now five Board. 5 years. I pulled through. I'm moved two years ago with 6 7 my significant other. (The Reporter indicated an inability to clearly 8 hear this applicant in Las Vegas.) 9 MR. HAMILTON: Okay. I moved down here two 10 years ago with my significant other. I have five years 11 clean time. I go to meetings. I am looking forward to 12 13 being a good security -- a guard. I have my pass, and I'm hoping to. 14 BOARD CHAIRMAN ZANE: What made you not 15 disclose all of those different things when you applied, 16 how come you didn't list them all? 17 MR. HAMILTON: Okay. I thought I did list them 18 And I listed that I was a -- that I was convicted all. 19 20 of a felony of attempted on some drug charge. I listed. 21 They said I didn't list them? I thought I did list them. I'm pretty sure I did. 22 BOARD CHAIRMAN ZANE: I believe, within --23 24 then, wasn't there an issue about not listing 2.5 everything?

1	MR. MAXWELL: Correct, sir, nothing.
2	BOARD CHAIRMAN ZANE: Okay. Thank you.
3	MR. HAMILTON: Okay. My and after 12 years,
4	you know, after 12 years, you can get it expunged. I
5	mean I wasn't aware of that, you know. I mean I
6	wouldn't have had no problem listing. But when I got
7	that paper, you know, to be a guard, rather than try to
8	come up with Gower (phonetic), Magnum (phonetic) and the
9	tri-county, I wasn't aware that I needed to put it in
10	this county. When it showed, I picked, when you list
11	the felony, I list it.
12	BOARD CHAIRMAN ZANE: Okay. Were the felonies
13	listed and then we missed the misdemeanors, or is it
14	MR. MAXWELL: No, sir, I listed everything that
15	was on the report that was on the application.
16	BOARD CHAIRMAN ZANE: Okay.
17	MR. INGRAM: Do you have a copy of the
18	application?
19	MR. MAXWELL: Not with me.
20	BOARD CHAIRMAN ZANE: What have you been doing
21	for employment?
22	MR. HAMILTON: I work for Atlas, Atlas, Atlas,
23	Atlas grocery store.
24	BOARD CHAIRMAN ZANE: Okay.
25	MR. HAMILTON: And I work there. Hang on. I

1	got this for this right here. It's a paper, CSN, CSN,
2	just right here for the award.
3	BOARD CHAIRMAN ZANE: You had some certificate
4	there from CSN?
5	MR. HAMILTON: Yes, sir. I want to
6	(appellant handed papers to the Board). Thank you.
7	And this. Thank you. Thank you.
8	BOARD CHAIRMAN ZANE: Describe those for the
9	Board members.
10	MR. INGRAM: Yeah. Okay. So we have a DD-214
11	that shows an honorable discharge for the military.
12	There's a certificate of completion signed by one of our
13	license holders, Vincenzo Esposito, that he successfully
14	completed 16 hours of security orientation training for
15	the position of security officer in the state. And we
16	have a certificate of achievement from the College of
17	Southern Nevada, successfully completed the Soft Skills
18	for Workplace Success. Doesn't give a number of hours.
19	It's signed by Business Services Coordinator of the
20	Division of Workforce and Economic Development. That
21	was in 2017.
22	BOARD CHAIRMAN ZANE: So, as I understand it,
23	there's a single felony conviction?
24	MR. MAXWELL: Yes, sir.
25	BOARD CHAIRMAN ZANE: Okay. And then the rest
	1.0.7

1	are a mishmash of misdemeanor violations?
2	MR. MAXWELL: Yes, they are.
3	BOARD CHAIRMAN ZANE: Okay. And it's your
4	position that you didn't list the felony conviction
5	because you thought it would go away after a certain
6	period of time?
7	MR. HAMILTON: I was told that when complete
8	the program, I complete the program, didn't need to put
9	a felony. Again, that when you complete your
10	certificate, you get it expunged. I would have had no
11	problem listing it, because I know they would have
12	certified in the computer. When I completed I did
13	the program for a whole year. And I went to a ceremony,
14	and they gave you an achievement, an award. And when I
15	went to that ceremony, it was supposed to be expunged
16	off of my record.
17	I would have had no problem listing it. When
18	you got an application, that's the only way that I found
19	out. When you do the application, you can't deny it,
20	you know. I would have had no problem listing it, you
21	know.
22	BOARD CHAIRMAN ZANE: Okay. That conviction
23	was in what state?
24	MR. HAMILTON: Um, um, um, uh not
25	BOARD CHAIRMAN ZANE: Florida?

5	And I've working with him since June 27th. And all the
6	training and security and all that, we went through the
7	whole process.
8	On one of his papers he has, one of the things
9	that I looked at from Social Security, they did all the
10	investigations and found nothing, felony or misdemeanor.
11	So I said, well, I couldn't tell exactly what happened
12	in Florida. But it sounded like he no longer had a
13	case. And that's why, I guess, he figured it wasn't all
14	that.
15	And as far as character, I'm retired police and
16	ATF. And I'm also a security manager. So. And, plus,
17	he's, you know, he's an Army vet. So that's what I
18	wrote down. But that's part of character, you know.
19	So he does have, you know, employment waiting.
20	In fact, I had three positions open. So if he does get
21	back on, then we already have a job for him.
22	And that's it.
23	BOARD CHAIRMAN ZANE: Any Board questions for
24	the witness?
25	BOARD MEMBER COLBERT: No.

21	BOARD MEMBER NADEAU: I'm still concerned about
22	the lack of disclosure. And it's not just a lack of
23	disclosure on a misdemeanor or something that's 20 years
24	ago. It's pretty recent, and it was a felony. And so
25	that concerns me, I guess, from my perspective. I

1 understand that he has a job waiting for him, you know,
2 if this is reversed. But I'm still troubled with this
3 disclosure aspect. It's not like -- it doesn't even
4 fall under, that I'm aware of, because nothing was said,
5 it doesn't even fall under that California statute.
6 It's just lack of disclosure. So, I guess, that's where
7 I'm struggling.

BOARD CHAIRMAN ZANE: Well, for me, I tend to 8 give a little bit, a little bit of a benefit of the 9 doubt for the individual's personal experience in the 10 criminal justice system and their wherewithal to 11 understand the consequences and the actions. And it's a 12 13 fairly typical response from many people across the country about the quick resolution of their criminal 14 case comes with the caveat that 10 years from now you 15 don't have to care. And I understand that it doesn't 16 limit them or require anything further of them except 17 for the disclosure. But for some folks, it seems like 18 that disclosure period automatically goes by the wayside 19 20 after 10 years. And I don't know if you have to be 21 totally sophisticated to get it or not, but, I think, 22 sometimes it does tend to fall through the cracks. So that's one of the reasons I'm supporting the 23 24 motion.

1	BOARD MEMBER NIXON: Mr. Chair?
2	BOARD CHAIRMAN ZANE: Yes.

4	supporting it as well is his work with the State in
5	trying to get through a program and then doing the
6	Social Security check and not finding anything. I
7	think, that would lead him to believe that it had been
8	expunged after he was done.
9	MR. HAMILTON: Thank you.
10	BOARD CHAIRMAN ZANE: Any other Board
11	questions, comments?
12	MR. HAMILTON: Thank you.
13	BOARD CHAIRMAN ZANE: All in favor of the
14	motion, say "aye."
15	(Board members said "aye.")
16	BOARD CHAIRMAN ZANE: Any opposed, say "no."
17	It carries unanimous. Congratulations.
18	MR. HAMILTON: Thank you. Thank you.
19	BOARD CHAIRMAN ZANE: Thank you.
20	BOARD MEMBER NIXON: Good luck.
21	BOARD CHAIRMAN ZANE: I'm missing a page. Do
22	you have the agenda handy?
23	MR. INGRAM: We're on 36.
24	BOARD CHAIRMAN ZANE: Johnny Hardwick? Johnny
25	Hardwick, number 36?

1	Okay. We'll trail number 36 to the end.
2	Tracy Holman?
3	Have a seat.
4	Who's the investigator?
5	MR. SALADINO: Investigator Saladino.
6	BOARD CHAIRMAN ZANE: Please.
7	MR. SALADINO: The applicant was denied for a
8	1988 wrongful possession and distribution of cocaine.
9	And this was a military conviction, but this conviction
10	carried over into the civilians, civilian world where he
11	had to register as a felon with the local PD.
12	BOARD CHAIRMAN ZANE: And the conviction was in
13	'88?
14	MR. SALADINO: Right.
15	BOARD CHAIRMAN ZANE: What was the disposition?
16	MR. SALADINO: The military, I guess, issued
17	some sanctions and stuff. But he just had to register
18	then with the county as an ex-felon.
19	BOARD CHAIRMAN ZANE: Mr. Holman, can you let
20	us know what
21	MR. HOLMAN: It's only, it's going to be really
22	simple. Like I say, I was standing off post. And one
23	of the soldiers you know, we were always down to get
24	together. And one day, he came by the house. This was
25	so long ago, I can't remember all the circumstances, but

1	I'll tell you what I did. He came by, you know, and
2	asked me if I can go get him some cocaine. And I
3	happened to know a guy. I went to the guy, came back,
4	gave him that, took the money back to the guy, and that
5	was it.
6	And for that, they waited two years, before
7	like a week before I was getting ready to go, come back
8	to the states. They arrested me. I went to my first
9	sergeant's office, and I was arrested for something I
10	did. For that, I did like five months when I first got
11	to jail. And then that was it.
12	BOARD CHAIRMAN ZANE: Okay.
13	MR. HOLMAN: And I was you know, they
14	really I liked being a soldier. And, you know, I was
15	kicked out, took my money, you know, took my own
16	cottage, you know took everything. And that was it.
17	That's what I did.
18	BOARD CHAIRMAN ZANE: Right. So did you have
19	anything once you got out?
20	MR. HOLMAN: Well, I'm you know, I'm
21	classified as a drug dealer. I wasn't a drug dealer
22	then. I ain't a drug dealer now. I don't have no drug
23	possessions. And I ran in the streets for 15 years,
24	didn't sell no drugs. I'm not a drug dealer. And I
25	didn't sell drugs then, and I don't sell drugs now.

1	BOARD CHAIRMAN ZANE: Okay.
2	MR. HOLMAN: But I did do that, so.
3	BOARD CHAIRMAN ZANE: All right. Any other
4	Board questions?
5	BOARD MEMBER NADEAU: No.
6	BOARD MEMBER NIXON: What have you been doing
7	for employment?
8	MR. HOLMAN: I'm disabled. I'm a hundred
9	percent disabled, three bad surgeries on my knee. And
10	my wife, you know, basically, my wife died in July of
11	last year. I have two girls to raise, you know. And my
12	disability check is not doing anything. The little help
13	I get from Welfare is just not doing it. And I have a
14	15-year-old girl and a and it's not you know, I
15	need money. You know, I got to get a job.
16	And I have, you know, my brothers. You know, I
17	have a job waiting for me. This is a six-month process
18	for me, you know. I was misposted on the last appeal
19	board. But something happened. You know, things
20	happen. But, like I say, I got to let these people know
21	even though I'm not I'm still disabled, I'm still
22	working, I let them know that, you know. I'm well, but
23	I'm not well, because I have to get a job.
24	BOARD CHAIRMAN ZANE: Okay. Any other Board
25	questions?

1	Entertain a motion.
2	BOARD MEMBER NADEAU: Mr. Chair?
3	BOARD CHAIRMAN ZANE: Yes, sir.
4	BOARD MEMBER NADEAU: Thank you, Mr. Chair.
5	I'd move that the registration for Tracy Holman be
6	reinstated and that the denial be overturned.
7	BOARD MEMBER COLBERT: Second.
8	BOARD CHAIRMAN ZANE: We have a motion and a

19	BOARD CHAIRMAN ZANE: Any opposed, say "no."
20	Carries unanimous. Congratulations.
21	MR. HOLMAN: Thank you. Thank you.
22	BOARD CHAIRMAN ZANE: Number 38, Wesley Jones?
23	Good morning.
24	MR. JONES: Good morning, gentlemen and staff
25	and investigators.

1	BOARD CHAIRMAN ZANE: Let me find it here.
2	Okay. Who's the investigator on this one?
3	MR. SALADINO: Investigator Saladino.
4	BOARD CHAIRMAN ZANE: Please.
5	MR. SALADINO: The applicant was denied for a
6	2000 domestic violence with a weapons charge. It was a
7	misdemeanor. And he was placed on probation. He was
8	scheduled to be here December 16 for the appeal, but he
9	wasn't. And now he's moving forward with his
10	application again. The applicant did disclose it the
11	second go-round on his application.
12	He also has a gaming card and made note to us,
13	to the Board that, Board staff, that he has had
14	employment with Circus Circus, and he did receive his
15	gaming card as well.
16	BOARD CHAIRMAN ZANE: Well, what would you like
17	to say, Mr. Jones?
18	MR. JONES: Well, number one, I appreciate the
19	time here, of being here. I take full responsibility
20	for my actions that I did in this situation.
21	The long and short of it is that I'm not
22	going to go through the whole thing because it's kind
23	of personal. I had caught my wife cheating. I made a
24	comment to her. I was in security at the time, and
25	knowing full well, in Aurora, Colorado, and we just had

1	a briefing on domestic violence about a week before.
2	So when I confronted her, I made sure that I
3	was getting to go out the door to go to work, because I
4	didn't want her to have the issues of standing there
5	arguing and getting in this situation. So what happened
6	was, you know, she saw that she couldn't get me to
7	engage with her, you know. So she made a comment about
8	she's going to get her man to kick my ass and all this.
9	Well, that triggered my, you know, not using good
10	judgment. I made a mistake, and I told her I had
11	something, whatever that was, which it was a weapon,
12	which I had in a closet, which was in a box. Which all
13	I did was take the box down and showed her, showed it to
14	her. There was no ammunition, nothing in it or nothing
15	like that.
16	And she commenced to get on the phone and call
17	nine-one-one and went through the whole nine yards.
18	Which I stood right there, and I didn't even leave.
19	They came, and I explained to them what happened.
20	Somebody told me, "Well, you know, she felt like she was
21	threatened for her life because of, you know, you
22	showing her the weapon." I said, "Well, I had no
23	intentions of doing anything. I just wanted to let her
24	know that, you know, she triggered my thing."
25	And that's what caused my thing. I'd been in

1	security for three years when that happened. I went
2	through court order, and I did everything the court
3	requested. I went to drug, drug rehabilitation. You
4	know, I had to go to anger management courses. I took
5	the urinalysis every week. I did all that. I was on
6	probation for a year.
7	And then I moved from Colorado to Texas. And
8	it took me five years to get my guard card back in
9	Texas, but I did do it.
10	And I think that I have done everything that I
11	needed to do. And I have a different outlook on staying
12	out of those type of situations. I'm remarried now.
13	I'm not even married to her anymore. And I think that
14	I've done well.
15	BOARD CHAIRMAN ZANE: Okay. And this, the
16	offense was listed on the application?
17	MR. SALADINO: Yes, sir.
18	BOARD CHAIRMAN ZANE: Okay. Any other Board
19	questions?
20	Entertain a motion.
21	BOARD MEMBER NIXON: Mr. Chairman?
22	BOARD CHAIRMAN ZANE: Yes, ma'am.
23	BOARD MEMBER NIXON: I move that Mr. Jones'
24	license be granted, based on time.
25	BOARD CHAIRMAN ZANE: Okay. We have a motion.

1	Do we have a second?
2	BOARD MEMBER NADEAU: I'll second.
3	BOARD CHAIRMAN ZANE: Any Board comment or
4	question on the motion?
5	All in favor, say "aye."
6	(Board members said "aye.")
7	BOARD CHAIRMAN ZANE: Any opposed, say "no."
8	Unanimous. Congratulations.
9	MR. JONES: Thank you. Thank you, you all.
10	BOARD CHAIRMAN ZANE: Steve Larkey? Steve
11	Larkey, item number 39?
12	We're going to trail it.
13	Wade Alonzo Manning?
14	MR. MANNING: Good morning, everyone.
15	BOARD CHAIRMAN ZANE: How are you?
16	MR. MANNING: Good.
17	BOARD CHAIRMAN ZANE: Good.
18	Who's the investigator?
19	MR. MAXWELL: Investigator Maxwell.
20	BOARD CHAIRMAN ZANE: Please.
21	MR. MAXWELL: Mr. Manning was made provisional
22	initially. All these arrests were taken from the
23	fingerprint report, and they were out of California.
24	1990, vandalism, convicted, 12 months of probation.
25	'99, battery of spouse, convicted, three years

1	probation, 25 days jail. 2002, domestic violence.
2	2004, attempted murder, felony, convicted, five years
3	prison. There's also another one listed for Susanville,
4	High Desert State Prison, Susanville, California,
5	another attempted murder. 2009, inflict corporal injury
6	on a spouse.
7	No arrests where disclosed. The applicant did
8	disclose the 2004 assault arrest out of California, with
9	a disposition as a fine, but this was not reflected on
10	the fingerprint report.
11	BOARD CHAIRMAN ZANE: Mr. Manning?
12	MR. MANNING: Yes.
13	BOARD CHAIRMAN ZANE: What's your point of view
14	on this?
15	MR. MANNING: I plead guilty to those charges.
16	And I also, since I've been out for almost 11 years, I
17	haven't been involved in no kind of activity with the
18	police or nothing, ever since then. And I've been
19	working since I got out.
20	BOARD CHAIRMAN ZANE: What have you been doing?
21	MR. MANNING: I was working with my uncle he
22	was a contractor, cement contractor for like six
23	years. And now I've been doing temp agency services,
24	for the time that I've been out. I just recently
25	relocated from California here, in September of '17.

1	And I started working immediately as soon as I got here.
2	So my background had passed because of that reason,
3	because of the attempted murder.
4	BOARD CHAIRMAN ZANE: Now, there's two
5	different counts. Is there two different events?
6	MR. MANNING: No, I only know about one. That
7	was in 2004.
8	MR. INGRAM: One of them was while he was
9	incarcerated.
10	BOARD CHAIRMAN ZANE: Was there, was there a
11	charge while you were incarcerated?
12	MR. MANNING: No, sir.
13	BOARD CHAIRMAN ZANE: No? From the fingerprint
14	report, it's indicated that there was an attempted
15	murder charge while you were in High Desert at
16	Susanville.
17	MR. MANNING: No, sir, that's not true.
18	BOARD CHAIRMAN ZANE: That's not true?
19	MR. MANNING: No, I've never been in trouble
20	since I've been incarcerated.
21	BOARD CHAIRMAN ZANE: Okay. Is there a
22	disposition on the fingerprint report?
23	MR. MAXWELL: One second, sir.
24	BOARD CHAIRMAN ZANE: Well, working backward,
25	what, you have a charge of infliction of corporal injury

1	on spouse, cohabitation, in 2009.
2	MR. MANNING: Yes, sir. And I can explain it,
3	too, because I was with a jealous girlfriend, and I had
4	went to jail. Because I never was charged with those
5	charges, because she explained it to them that she lied
6	to the police because she was mad at me, and they
7	dropped the charges. I went to jail for them, but they
8	was reduced, they were dropped. And that's what that
9	was.
10	BOARD CHAIRMAN ZANE: Do you recall being on
11	probation for five years, from 2009 till 2014?
12	MR. MANNING: Yes, sir, it was close to that.
13	I was on probation and parole, and I've cleared both of
14	those.
15	BOARD CHAIRMAN ZANE: Okay.
16	BOARD MEMBER NIXON: Mr. Chairman?
17	BOARD CHAIRMAN ZANE: Yes, ma'am.
18	BOARD MEMBER NIXON: Was there a reason that
19	none of this was disclosed?
20	MR. MANNING: You mean on the application?
21	BOARD MEMBER NIXON: Yes.
22	MR. MANNING: Yes, ma'am. I probably didn't
23	say nothing about it because I didn't really think it
24	mattered, because I wasn't charged with it.
25	BOARD MEMBER NIXON: I just have another

1	question. From what I'm understanding, then, you're
2	saying you weren't charged with them, but you were
3	convicted?
4	MR. MANNING: Well, yes, ma'am, because I
5	you know, like I say, because when I went to jail for
6	those, like I said, she called down and she admitted to
7	them that she just did it because she was mad at me and
8	that they just needed to let me go. But I still was
9	convicted for it, like you said, yes.
10	BOARD MEMBER NIXON: Was there a
11	misunderstanding on the application when it asked have
12	you ever been arrested or convicted?
13	MR. MANNING: No, ma'am.
14	MR. INGRAM: Mr. Chairman?
15	BOARD CHAIRMAN ZANE: Yes.
16	MR. INGRAM: I believe, Investigator Saladino
17	has some additional.
18	MR. SALADINO: In regards to the second
19	attempted murder, sometimes the fingerprint reports will
20	double up a charge, just like there's some kind of
21	hearing or something going on, so it's here on the
22	fingerprint report. So it's not necessarily another
23	attempted murder. It's just reiterating the other one
24	as to why he was sent to prison.
25	The spousal abuse one from 2009, that one fell

1	under a felony category as well, where he received five
2	years of probation.
3	BOARD CHAIRMAN ZANE: Okay. Anything else
4	you'd like to add?
5	MR. MANNING: Well, actually, I'm actually,
6	I just want to just to try to get my guard card and go
7	to work and try to carry on with my life. Because I've
8	been, like I said, I haven't been in any kind of trouble
9	since I've been out in 2008. I've been doing volunteer
10	work for the hospital in the Englewood district in L.A.
11	I'm just trying to carry on with my life farther, you
12	know, just trying to make a better life.
13	BOARD CHAIRMAN ZANE: Okay. Any other Board
14	questions, comments?
15	Entertain a motion.
16	BOARD MEMBER NIXON: Mr. Chairman?
17	BOARD CHAIRMAN ZANE: Yes.
18	BOARD MEMBER NIXON: I move to uphold the
19	denial of Wade I'm sorry, I lost my place here
20	Wade Alon Manning
21	MR. MANNING: Alonzo.
22	BOARD MEMBER NIXON: Alonzo Manning's denial
23	of his registration card.
24	BOARD CHAIRMAN ZANE: We have a motion. Do we
25	have a second?

1	BOARD MEMBER NADEAU: If I'm understanding the
2	motion it was a little bit broken up for me. If I'm
3	understanding the motion, it's to uphold the denial; is
4	that correct?
5	BOARD MEMBER NIXON: (Nodded head
6	affirmatively.)
7	BOARD CHAIRMAN ZANE: That's correct.
8	BOARD MEMBER NADEAU: I'll second that.
9	BOARD CHAIRMAN ZANE: Okay. We have a motion
10	and a second. Any Board comment or question on the
11	motion?
12	I'll make a comment. I'm going to support the
13	motion because it wasn't listed. And with the time
14	that's gone by, most likely you probably would have
15	gotten reasonably decent reception had it been
16	disclosed. So I'm going to support the motion.
17	Any other Board comment?
18	All in favor, say "aye."
19	(Board members said "aye.")
20	BOARD CHAIRMAN ZANE: Any opposed, say "no."
21	Carries unanimous. You're free to reapply in a
22	year.
23	MR. MANNING: A year?
24	BOARD CHAIRMAN ZANE: A year. And make full
25	disclosure. Otherwise, we'll be back here again.

1	MR. MANNING: All right.
2	BOARD CHAIRMAN ZANE: Thank you.
3	Bryan Neely?
4	Hello.
5	MR. NEELY: Hello.
6	BOARD CHAIRMAN ZANE: Who was the investigator?
7	MR. MAXWELL: Investigator Maxwell.
8	BOARD CHAIRMAN ZANE: Please.
9	MR. MAXWELL: He was made provisional. And he
10	has a 2008 charge in Nevada of carrying a concealed
11	weapon. It was a misdemeanor, reduced from a gross
12	misdemeanor. The arrest was confirmed on SCOPE. And
13	the applicant did disclose the arrest. He also provided
14	court documents and an appeal that was provided at the
15	time of application. And this is all confirmed with the
16	fingerprint report.
17	BOARD CHAIRMAN ZANE: So, ultimately, he was
18	denied simply because of the nature of the charge?
19	MR. MAXWELL: Yes.
20	BOARD CHAIRMAN ZANE: Thank you.
21	Okay. Mr. Neely, what was your recollection,
22	what's your recollection?
23	MR. NEELY: I was pulled over, and I was
24	made a, apparently, too quick of a right turn getting
25	off the 95 onto Eastern. I didn't really come to a full

stop at the stoplight. I made a turn. The police
officer pulled me over. I immediately pulled over.
They asked me to search the vehicle. I didn't believe
there was anything in there. So I didn't have any
reason to tell them not to. And when he searched the
car, he happened to find a pair of brass knuckles that
were underneath the seat that I, honestly, had no idea
were even in there. I'd lost them five years prior to
that. They were just wedged up in the little where
my seat rolls back and forth on the front. And he found
them in there.
And that was about it. That was they
arrested me right there on the spot for it. And they
charged me with possession of brass or possession of
a dangerous weapon. Went to jail, I believe, two days,
or a day and a half or so I sat in jail. And then they
brought me before video court. They told me, they asked
me how I pleaded on it. I pleaded no contest. They,
you know, they were in there. I took responsibility for
it. And that was it.
And then they released me after the two days of
being in jail. I believe, I got a suspended sentence,
if I'm not mistaken, I believe that's what it was, and
just to stay out of trouble is what they told me. And
that's exactly what I did.

1	I mean it was literally 10 years and four days
2	ago. I mean, yeah, 10 years and four days to the day
3	since that happened. And between now and then, I've
4	gotten maybe a couple, a handful of traffic violations.
5	And outside of that, I've had zero contact with law
6	enforcement.
7	BOARD CHAIRMAN ZANE: Okay. Any Board
8	questions or comments?
9	Entertain a motion.
10	BOARD MEMBER COLBERT: Mr. Chair, I'd move that
11	Bryan Neely's denial be reversed, based upon time and
12	distance and the fact that he did disclose this arrest
13	on his paperwork.
14	BOARD CHAIRMAN ZANE: Thank you.
15	BOARD MEMBER NIXON: I second.
16	BOARD CHAIRMAN ZANE: We have a motion and a
17	second. Any Board discussion or questions on the
18	motion?
19	All in favor, say "aye."
20	(Board members said "aye.")
21	BOARD CHAIRMAN ZANE: Any opposed, say "no."
22	The motion carries unanimous. So good luck.
23	MR. NEELY: Thank you very much.

16	MR. PERKINS: As of today, you know, I like to
17	be trusted. I'm trying to pursue a career in
18	corrections. I believe, out of all my experience over
19	the years, I believe and I know that I have what it
20	takes to help people turn their lives around. I did it
21	in a negative sense. I know I can do it in a positive
22	sense, you know. And I'd like to help build that wall.
23	BOARD CHAIRMAN ZANE: You're not thinking that
24	anything, a surprise is going to get you in 2021, then,
25	right?

1	MR. PERKINS: Not at all. I'm scared of the
2	dark side. These days, I'm walking a straight line.
3	BOARD CHAIRMAN ZANE: Well, but when I look
4	here, about every 10 years there seems to be a mishap.
5	MR. PERKINS: Yeah. Yeah. I take full
6	responsibility to that. I had a dysfunctional family,
7	for starters. You know, I wasn't was one of those honor
8	roll students, you know, dysfunctional family that led
9	me downhill. Picked myself back up. And next thing you
10	know, getting older, my mom died. And, you know, I
11	thought that the streets could take me under their wing.
12	But I'm one of the ones you guys helped by putting
13	together this program so I can reform myself into a
14	better self, a better man, you know. I take the
15	responsibility and take responsibility for my actions.
16	And this is all I'm trying to do. So now I'm
17	trying to give back, you know, to the community. I
18	would like to get inside law enforcement so I can help
19	protect and serve. You know, I'll probably try to get
20	back into college to get a degree so I can jump on the
21	bandwagon with you guys and be on a team so I could help
22	people understand that narcotics, substance abuse,
23	slash, alcohol ain't the way. And I know I can do that,
24	you know, if somebody could give me an opportunity, you
25	know, because I haven't been in trouble since.

1	BOARD CHAIRMAN ZANE: Okay. Any Board comment,
2	questions?
3	Entertain a motion.
4	Second call for a motion.
5	BOARD MEMBER COLBERT: Mr. Chair, I move that
6	Charles Perkins' denial be reversed, based upon the time
7	and distance and the fact that he listed all his crimes,
8	was forthright with all that.
9	BOARD CHAIRMAN ZANE: Okay. We have a motion.
10	Do we have a second?
11	BOARD MEMBER NIXON: I second.
12	BOARD CHAIRMAN ZANE: Motion and a second. Any
13	Board comment or question on the motion?
14	All in favor, say "aye."
15	(Board members said "aye.")
16	BOARD CHAIRMAN ZANE: Any opposed, say "no."
17	Carries unanimous. Congratulations.
18	MR. PERKINS: Thank you, sir. And thank the
19	team. Thank you, Chairman. Thank you, sir.
20	BOARD CHAIRMAN ZANE: Thank you.
21	Romeo Robinson?
22	Who's the investigator on this?
23	MR. MAXWELL: Investigator Maxwell.
24	BOARD CHAIRMAN ZANE: Please.
25	MR. MAXWELL: He was issued a provisional. All

1	of his arrests were out of California. In 1993,
2	attempted burglary, type unknown, 24 months probation.
3	2009, manufacture and sell a weapon without a handle,
4	type unknown, three days jail. '96, carrying a loaded
5	firearm in a public place, type unknown, convicted, two
6	years probation, 30 days suspended jail sentence. And
7	in 2000, felony theft, type unknown, convicted, three
8	years probation under 1982.
9	The applicant did not disclose any arrests.
10	The history for all the arrests were found on the
11	fingerprint report.
12	BOARD CHAIRMAN ZANE: Okay. Mr. Robinson.
13	MR. ROBINSON: Yes, sir.
14	BOARD CHAIRMAN ZANE: Is there a particular
15	reason that you didn't disclose this on the application?
16	MR. ROBINSON: Well, California, you go back 10
17	years. Okay. Nevada is different. I didn't know that,
18	but I should have put it anyway.
19	The weapon without a handle, that was a little
20	Chinese tin throwing star, and they said that was a
21	weapon without a handle.
22	As far as the gun in a public place, I don't
23	know why that's on there, because I have my guard card,
24	I have my gun permit. I had a rental car too long. On
25	my way taking it back, they said driving without owner's

1	consent, when I was taking it back. But I had it too
2	long. Okay. I had went to go see a guy in Texas, came
3	back late. I was going to drop it off when I went to
4	work, because it was right around the corner from my
5	job.
6	I've done security from '86 and training, LAPD,
7	I did all the training and everything.
8	The rental car, stupid mistake. Okay. I'm 54
9	now. The only reason that I want to get back into my
10	career, something at work. Okay. I don't know if we're
11	permitted to show a video or I have a video of an
12	incident that happened to me. And that's why I decided
13	I wanted to get back into security, because my training
14	kicked in, in one situation.
15	BOARD CHAIRMAN ZANE: But I don't know that we
16	could admit the video, because we don't have any real
17	way of recording it and capturing it in video format.
18	So it wouldn't play well, if the stenographer is trying
19	to type
20	MR. ROBINSON: Right.
21	BOARD CHAIRMAN ZANE: what all took place.
22	And so I don't think that that would be something we'd
23	be able to do.
24	MR. ROBINSON: All right.
25	BOARD CHAIRMAN ZANE: But the catalyst would be

1	that you undertook a serious situation, and it got you
2	back into thinking that you want to be in security?
3	MR. ROBINSON: Yes, sir.
4	BOARD CHAIRMAN ZANE: Okay.
5	MR. ROBINSON: I haven't been in trouble with
6	the law. I wasn't doing pretty well in California. I
7	was homeless for awhile, looked for a job, couldn't find
8	anything. Came out here in January 2015, started
9	working at 7-Eleven and Rebel gas station. And it's
10	pretty much that I'm doing security, because I'm
11	catching people stealing out of the facility. So the
12	last incident where I caught somebody stealing, and I
13	was attacked, and I handled the situation and held them
14	for the police and everything, that's what just got me
15	wanting to get back into security.
16	And as far as disclosing, I was pretty much
17	scammed when I trusted somebody to try to get everything
18	expunged for me, and it didn't pan out. Like I said, I
19	thought it was a 10-year thing. And that was over 10
20	years. But I take responsibility for it. If I thought
21	it would hurt me, you know, I would have went back 30
22	years, you know, putting it on there, you know, if it
23	would have helped me, but.
24	BOARD CHAIRMAN ZANE: Okay.
25	MR. ROBINSON: Since I thought it was just 10

1 years, I just didn't do it. BOARD CHAIRMAN ZANE: Okay. These convictions, 2 3 they were all California, correct? MR. MAXWELL: Yes, sir. 4 BOARD CHAIRMAN ZANE: Okay. A lot of people 5 become better people when they leave California and come 6 7 over here. MR. ROBINSON: Yeah. I mean, you know, I found 8 a job right away, and I kind of liked what I was doing, 9 you know, customer service and everything. But when it 10 got into the homeless people coming in and trying to 11 steal, and all that, and I mean I just jumped back into 12 13 security mode. Because I did 15 weeks of training with, like I said, the LAPD, Los Angeles Sheriff's, a 14 firefighter, a judge, a lawyer. They trained us on all 15 type of techniques. 16 BOARD CHAIRMAN ZANE: Okay. Any other Board 17 questions, comments? 18 Entertain a motion. 19 20 Second call for a motion. 21 I'll make a motion to uphold the denial, based upon lack of disclosure. Is there a second? 22 BOARD MEMBER COLBERT: Second. 23 BOARD MEMBER NIXON: I second. 24 BOARD CHAIRMAN ZANE: There's a motion and a 2.5

second to uphold the denial. Any Board question or 1 2 comment on the motion? BOARD MEMBER NIXON: Just a quick comment. 3 You know, I think, due to time, I would have granted had it 4 been disclosed. So that's my concern. 5 BOARD CHAIRMAN ZANE: Any Board comment, 6 7 question? MR. ROBINSON: I have a question, sir. 8 BOARD CHAIRMAN ZANE: Please. 9 MR. ROBINSON: Okay. Is it, is it the fact 10 that it was a weapons charge that wasn't disclosed, or I 11 mean how far back do I have to go as far as listing 12 13 everything on the application? BOARD CHAIRMAN ZANE: The application said list 14 15 everything. MR. ROBINSON: No matter what year? 16 BOARD CHAIRMAN ZANE: No matter what year. 17 That's the problem that I've got. 18 MR. ROBINSON: Yeah. 19 20 BOARD CHAIRMAN ZANE: If you would have listed all that --21 MR. ROBINSON: Yeah. 22 BOARD CHAIRMAN ZANE: I mean we haven't voted 23 But I would not have made this motion had you 24 vet. 2.5 disclosed all these things.

1	MR. ROBINSON: Right. And, like I said, coming
2	from California, I didn't think I was going to get back
3	into security until that incident. Okay. I thought
4	pretty much my security career was over. And once that
5	happened, I thought I'd try it again. And, like I said,
6	in California, list 10 years. Okay. Nevada is
7	different, and you have to list everything. Okay.
8	Didn't know. Will know next time.
9	BOARD CHAIRMAN ZANE: Any other questions from
10	the Board?
11	All in favor, say "aye."
12	(Board members said "aye.")
13	BOARD CHAIRMAN ZANE: Any opposed, say "no."
14	It carries unanimous. You're entitled to
15	reapply in a year. In the meantime, this doesn't bar
16	you from seeking employment as a proprietary security
17	guard. Our only authority is over security companies
18	that are for hire. You can go to work for anybody on
19	their property securing their stuff.
20	MR. ROBINSON: I'd rather do security in the
21	right way.
22	BOARD CHAIRMAN ZANE: I mean that's the right
23	way.
24	MR. ROBINSON: The right way is a company with
25	benefits, with 401K, looking to expand. You know, I

1	mean you can't so much, you can't too much learn
2	anything just by protecting other people's stuff when
3	there's no room for advance. You know, I'd like to
4	advance, get more knowledge, get more experience and,
5	therefore, working with my own company.
6	BOARD CHAIRMAN ZANE: Well, you're welcome to
7	reapply in a year. And I'm sure, if you put all this
8	stuff down, you would have had a different response here
9	today.
10	MR. ROBINSON: Yes, sir. Thank you.
11	BOARD CHAIRMAN ZANE: Thank you.
12	Ronnie Junior Saunders?
13	Good afternoon.
14	Who's the investigator?
15	MR. MAXWELL: Investigator Maxwell.
16	BOARD CHAIRMAN ZANE: Please.
17	MR. MAXWELL: Mr. Saunders was made
18	provisional. 2006, he had a felony theft of property
19	out of Tennessee, guilty as charged, once year suspended
20	sentence. He also had three misdemeanor arrests out of
21	Tennessee, two in 2008 and one in 2010. And a 2016
22	misdemeanor arrest out of Nevada, possession of drug not
23	for interstate commerce.
24	The applicant did not disclose his arrests.
25	All arrests were found on the fingerprint report.

1	BOARD CHAIRMAN ZANE: Mr. Saunders, what's your
2	reply?
3	MR. SAUNDERS: The felony that happened in
4	2006, somebody had an idea, something. I was young.
5	He, my friend, brought me a stolen DVD player. I was
6	broke. I took it to the pawnshop. And when I pawned
7	it, they charge you with everything. So I got charged
8	with the felony. I paid it. I did the probation. I
9	thought it was being expunged. I paid the 250 for it to
10	be expunged, but it never did.
11	And when I went down there to put the
12	application in for the guard card, they told me 10 years
13	that I'd have to put in that statement, it would pop up
14	in 10 years. So I broke it down and told it. I said,
15	"On my other application, if you go and ask her, on my
16	other application I submitted, I put all my charges
17	down. I put it down." She said, "Well, it ain't going
18	to pop up because it was 10 years ago." I was like,
19	"Okay. My misdemeanor is another one." They gave me
20	guard card. I was happy.
21	I've got two kids. I'm trying to start fresh.
22	I've been working at McDonald's and DQ. It can't
23	support my family. It ain't going to do nothing. But,
24	see, this security guard is supportive. And, I like
25	they say, if you like doing what you if you like, if

1	you like doing what you do, you're going to do it every
2	day. So that's what I like. I like security. I don't
3	mind doing it, easy work. I'm living. I take care of
4	my family and feed the family.
5	BOARD CHAIRMAN ZANE: And when you say that you
6	had two separate applications, was one a hard copy
7	paper?
8	MR. SAUNDERS: Yes, the paper, yes. Okay. I
9	had it filled out and everything, brought it in there to
10	her. She looked at it, she said, "Oh, well." And I
11	broke it down. She said, "Well, it's passed. This
12	happened in 2006. It's been over 10 years. Well, it
13	might not pop up." If you ask her, I resubmitted it. I
14	redid it over. And guess what, missed out. I redid it
15	over.
16	And my misdemeanors, I was riding in the car
17	with somebody, and they had marijuana in the car, and he
18	didn't want to take the charge. It just so happened, I
19	was right by it. Technically, it was his car.
20	But as far as the job, boy, I really do, I
21	really do need it. It is beneficial. I came out here
22	for a fresh start. You guys, help me out, this meeting.
23	BOARD CHAIRMAN ZANE: Is there any record of
24	two separate applications in the file, do we know?
25	MR. MAXWELL: No, sir.

1	BOARD CHAIRMAN ZANE: Any other Board
2	questions, comments?
3	Entertain a motion.
4	BOARD MEMBER COLBERT: Mr. Chair, I would move
5	that Mr. Saunders' denial be upheld.
6	BOARD MEMBER NADEAU: Second.
7	BOARD MEMBER COLBERT: I base that on
8	BOARD CHAIRMAN ZANE: We have a motion.
9	BOARD MEMBER COLBERT: Excuse me. I based that
10	on his failure to disclose and with even the recent
11	charge of 2016.
12	BOARD CHAIRMAN ZANE: Okay. We have a motion
13	and a second. Any Board comment or question on the
14	motion?
15	All in favor, say "aye."
16	(Board members said "aye.")
17	BOARD CHAIRMAN ZANE: Any opposed, say "no."
18	Carries unanimous. The denial has been upheld.
19	You can come back and reapply in a year, and disclose
20	all of this stuff.
21	MR. SAUNDERS: Yes, sir.
22	BOARD CHAIRMAN ZANE: Thank you.
23	MR. SAUNDERS: Thank you.
24	BOARD CHAIRMAN ZANE: Sarah Schayes? Sarah
25	Schayes?

Okay. We will trail. 1 2 BOARD MEMBER NADEAU: Mr. Chair? 3 BOARD CHAIRMAN ZANE: Yes. BOARD MEMBER NADEAU: May we take a biological 4 break? 5 BOARD CHAIRMAN ZANE: Okay. Ten minutes? 6 7 BOARD MEMBER NADEAU: Yeah. now, I've had zero police contact at all. And I've been 1 raising a family. I've had a wife for seven years now, 2 two kids, six and four. So I've done everything right 3 since that time up until now. 4 I've been working with Alpha for -- was working 5 with Alpha for two and a half years. And it was 6 7 required to get a guard card. Submitted it, denied for the felony. So I've been waiting for this day for about 8 six weeks now, hoping that things would go my way. 9 BOARD CHAIRMAN ZANE: Okay. What would you 10 like to add, sir, anything? 11 MR. BRAVO: Well, yeah. Mitch came to work for 12 13 us. We weren't in the quard scenario at the time, so he was hired, brought in as a -- you know, as a contractor 14 to learn the business. He didn't know anything about 15 it. And he's been an exemplary employee for us. And I 16 consider him very honest. He's straightforward. 17 And I got to understand that you did something 18 wrong when you were younger. I didn't walk on water, 19 20 either. So. 21 But he's really been a good employee, and he's got a great family. And I would, from a character 22 standpoint, I think it would be detrimental if he got 23 denied. 24 25 BOARD CHAIRMAN ZANE: Okay. All right.

1	MS. DONALD: I would also like to add that he
2	did provide three character reference letters. One is
3	from Mr. Bravo. One is from Michael Loomis, which is
4	the qualifying agent. And then another was from a
5	friend, I think.
6	MR. STILTNER: He's a sales manager for Alpha
7	as well.
8	MS. DONALD: Yeah.
9	BOARD CHAIRMAN ZANE: Okay. Any Board question
10	or comment?
11	Entertain a motion.
12	BOARD MEMBER NADEAU: Mr. Chair?
13	BOARD CHAIRMAN ZANE: Yes, sir.
14	BOARD MEMBER NADEAU: I'd move that the that
15	Mitch Stiltner be granted his registration and that the
16	denial be overturned. And if there is a second, I'll
17	explain.

3	BOARD CHAIRMAN ZANE: Thank you.
4	Any other Board question, comments?
5	Okay. All in favor, say "aye."
6	(Board members said "aye.")
7	BOARD CHAIRMAN ZANE: Any opposed, say "no."
8	It carries unanimous. Congratulations.
9	MR. STILTNER: Thank you.
10	MR. BRAVO: Thank you very, very much.
11	BOARD CHAIRMAN ZANE: Tyger Summerise? Is that
12	right?
13	MR. SUMMERISE: That's me, yes. Let's keep the
14	overturn momentum going here, all right? You guys are
15	actually pretty brave. It seems like you guys should
16	definitely have a bailiff in here. I mean I'm sure
17	you've had your experiences over the year where somebody
18	just kind of snapped after getting the denial upheld,
19	I'm assuming? No?
20	BOARD CHAIRMAN ZANE: Most of us spend a lot of
21	time putting people in jail in our previous life. So I
22	think we can clear the table pretty fast.
23	MR. SUMMERISE: I was like, no bailiff in here?
24	BOARD CHAIRMAN ZANE: Who's the investigator?
25	MR. MAXWELL: Investigator Maxwell.

1	BOARD CHAIRMAN ZANE: Please.
2	MR. MAXWELL: Mr. Summerise was initially made
3	provisional. All these arrests were out of California.
4	In 1997, he was arrested for carrying a loaded firearm
5	in a public place, the type unknown, two years
6	probation, five days, a five-day suspended jail
7	sentence.
8	And he was also arrested for four misdemeanor
9	arrests, the last one being intoxication. He did
10	disclose this arrest on his application. He put it down
11	as a battery charge, but it was found to be just
12	intoxication on the fingerprint report.
13	All the arrests were found on or confirmed by
14	the fingerprint report.
15	BOARD CHAIRMAN ZANE: Okay. What's your
16	response?
17	MR. SUMMERISE: Very surprised the
18	intoxication, but, you know, if it's there. I'm just,
19	intoxication, I don't do drugs, and I don't even like to
20	drink.
21	But as far as the firearm, I did make a
22	mistake. I was 20 years old at the time. I was working
23	as a security guard in a very bad area. I never wanted
24	to take the position. But, however, my father was never
25	there, and my mom needed help with money. So when I

1	applied for this company, I'm thinking, what if they
2	hired me. They called me several days later. And the
3	first week of working a security position I was actually
4	stabbed. And I was really concerned at this point, you
5	know, considering, you know, I do need the job. I'm not
6	sure if I want to stay there. However, I did stay
7	there.
8	Now, I did make a stupid mistake after about
9	two or three incidents in working at this bowling alley.
10	And I did actually have a friend whose father was
11	actually in the service, and he had a couple of firearms
12	in his possession. And what I did is got a holster and
13	put this firearm and walked around with it, and nobody
14	questioned that I was not supposed to have it. Nobody,
15	didn't ask for permits. I even talked to law
16	enforcement officers when I had this weapon, you know,
17	several times, even at that bowling alley.
18	Now, however, I was taking my girlfriend to
19	school at Kelsey Northridge, California, where some law
20	enforcement officers were driving out of the location,
21	and they stopped to ask me for my license. And I told
22	them I don't have it. And they said, you know, "You got
23	to come with us." They took the firearm immediately,
24	and they told me to get in the backseat. I wasn't even
25	sure whether they were going to arrest me, because they

1	didn't handcuff me, but I went to the station there, and
2	they did actually charge me with it.
3	Now, it was a really dumb mistake. I was doing
4	this probably for about four months, walking around with
5	this firearm in the holster, and nobody questioned it.
6	I just wanted to protect myself. I didn't want to be
7	murdered as I you know, working this job. I really
8	felt that something probably was going to happen here,
9	so.
10	I was given, I think it was a year or two
11	probation and did some community service. But I was
12	very fortunate because this could have turned out to be
13	a lot worse than what it was. I could have got a felony
14	easy.
15	And I do recall now. I mean after denial, I
16	started thinking about it. Because after so many years,
17	I thought that this wasn't even on my record anymore.
18	Because when I moved to Nevada, I applied for a CCW. I
19	was granted. Even before that, I went into a gun store,
20	and I purchased a firearm legally, and they gave it to
21	me.
22	So I wasn't even thinking about that. Even
23	when I'm applying for the CCW, the reason I put it on
24	that application and not this is because I remember the
25	instructor telling me, "Be very careful." Right before

1	we're filling out the paperwork, he said, "Be very
2	careful to put everything on there. If you don't
3	disclose it, we're going to, it's going to be denied and
4	you're not going to get your CCW." So it was very fresh
5	in my mind at the time.

And I did work security at a school about 10 6 7 years ago. And I worked at a Van Nuys courthouse in California. And this arrest didn't prevent these people 8 from hiring me. I remember the school, they pulled me 9 And I was thinking to myself, okay, probably to 10 aside. make sure this is not going to be on my record anymore. 11 They pulled me aside and said, "You made a dumb mistake. 12 13 We're doing think you're a bad guy, but we're going to hire you anyway," and I got the job. 14

15 Now, I am working security right now, which I planned on working security when I moved to Nevada. 16 However, the security position I'm working right now is 17 in California. Because the company, they have a lot of 18 contracts here in Nevada that they need filled ASAP. 19 20 And when I got the denial, I told them, "Well, I guess, 21 it's going to be a little bit before I actually, you know, come back out here to work." 22

23 So I am working. Because I've got a guard card 24 in California. So I'm working at the Kaiser Hospital 25 and working in the solar industry. I have two jobs

right now. But I don't want to do sales anymore. I
want to get out of the solar industry and move and
eventually work in the corrections, you know, here in
Nevada.
You know, and I do feel that I've become a
better person since I left California. And you're right
about that. But I do want to start fresh. I made a
couple of bad mistakes. They could have turned out a
lot worse than it did. And I hope that you guys can
overturn this and give me a chance to actually start
fresh out here.
You know, I plan on doing security for maybe
another year or two working for the company I'm
currently with right now, and then go on to corrections
after that.
BOARD CHAIRMAN ZANE: Okay. Any Board
comments, questions?
BOARD MEMBER NIXON: Mr. Chairman, I have a
question.
BOARD CHAIRMAN ZANE: Please.
BOARD MEMBER NIXON: You did list the battery
on a person in 2008. And then it seems you did list the
intoxication but then not the other, the other one back
in 2001 and '97. Was there a specific reason why those
weren't listed?

1	MR. SUMMERISE: Yeah, like I said, I wasn't
2	even thinking about it at the time. I didn't even.
3	Just I got a couple jobs, hired. And when I got the
4	CCW, I almost forget about that arrest myself, to tell
5	you the truth.
6	As far as the intoxication, I'm still not sure
7	exactly what that is. But the battery was me and my
8	brother actually got into a fight. It was a family
9	altercation. He was getting into some trouble. And,
10	you now, my father's not there, so I felt like I have to
11	be the father, you know, and kind of talk some sense
12	into him. We had a couple heated conversations that led
13	to blows. And it was meant to be, because we were
14	fighting in the front yard, and an officer was driving
15	down the street at the time and arrested both of us. So
16	some good did come out of it, because he did change a
17	little bit since then. I did get that dismissed. And,
18	you know, it was something that should have happened.
19	Some good did come out of it, but it was a little bit
20	embarrassing and stuff like that.
21	As far this other misdemeanor, you know, it's
22	never stopped me from getting a job or even purchasing a
23	firearm, so I don't even think about it anymore. You
24	know, and even when I got my guard registration in

25 California, it wasn't an issue. They did give it to me,

1 and I even got a license to buy teargas and a pepper gun 2 and all that as well. I don't even think about it 3 anymore.

Now, since I got this denial letter, I went 4 back to the courthouse where that happened, and I did 5 apply for, you know, to get this expunged so it doesn't 6 7 come up anymore. Because I just don't think about it at And they haven't responded to me yet, but I'm 8 all. pretty sure it probably -- you know, they'll grant me 9 it, because I, you know, haven't been in any trouble or 10 anything, or anything like that since. 11

But, you know, I just want to start fresh with that. I don't want to stay in California anymore. You know, it's a major exodus taking place in the state of California. I'm a part of it. I have family here in Nevada. I just want to start over.

And, you know, fortunately for me, I don't have 17 to come and apply for a company. I'm already employed 18 with a security company right now. And, you know, I'm 19 20 going to stay with that same company, you know. As soon 21 as, or if you guys decide to overturn this and grant me this license, I'll stay with that same company and move 22 out here for a year or two, and then go on and work 23 corrections after that. 24

BOARD CHAIRMAN ZANE: Well, what's the

25

1	circumstances in the 2001 conviction for trespass,
2	refused to leave property, and it turned into 24 months?
3	MR. SUMMERISE: Yeah, what that was is when you
4	have a license I was working for a company. We were
5	going door-to-door. We were asking people if they
6	wanted to get us some, you know, home remodeling
7	projects. We didn't have a permit to be in the area.
8	It was the Lennox Division. They came and started
9	asking us for permits. Which, you know, I basically
10	said that, hey, our canvassing manager's around the
11	corner, and they can talk to him. And they arrested me
12	and one other person as well. I felt like it wasn't my
13	fault, you know. I was just trying to do you know,
14	make an honest living. And we didn't have permits to be
15	in the area. So they arrested me and one other person,
16	and they let us out the next day.
17	And it was very embarrassing. Because when I
18	went to the owner, he apologized. And, you know, I
19	didn't know that we were supposed to have permits. It's
20	just something I didn't even ask about. I didn't know.
21	But that's why they arrested me, because we didn't have
22	a permit to be in that area.
23	BOARD CHAIRMAN ZANE: Any other Board
24	questions?
25	BOARD MEMBER COLBERT: No.

1	BOARD CHAIRMAN ZANE: Entertain a motion.
2	Second call for a motion.
3	I'll move to uphold the denial. Is there a
4	second?
5	BOARD MEMBER COLBERT: Second.
6	BOARD CHAIRMAN ZANE: Okay. We have a motion
7	and a second. Any Board comment or question on the
8	motion?
9	My comment is, is that I'm making the motion
10	based upon a lack of disclosure.
11	MR. SUMMERISE: You know why I think you should
12	reconsider this? Here's the thing. We all need favors
13	from people in life, no matter who you are, what
14	position you're in. Now, I do realize I made a couple
15	of mistakes. At the end of the day, you guys have jobs
16	to do. But I can guarantee that if you actually
17	overturn this and give me an opportunity, it's actually
18	a fresh start here, the next time that you need a favor
19	from somebody in life, no what the favor is, it will be
20	granted.
21	You would never see me again. I'm here to make
22	an honest living. And I just want to leave California,
23	come here to be closer to my family, and start over. I
24	would really appreciate if you guys would give me the
25	opportunity to do this and not hold mistakes that we did

1 in the past. Every single person up here on this Board, 2 all of you, we all made mistakes in the past that we 3 regret and wish that we could take back. It probably 4 didn't lead to an arrest, but we all did, or said 5 something to somebody that we wish we could go back in 6 time and change. I think that you should grant me this 7 opportunity, because it would actually mean a lot to me.

I feel like this will be a slight bump, you 8 know, in life for me that has actually prevented me 9 from -- I'm not saying -- it's not going to stop me from 10 making an honest living. But I do have a few family 11 friends who actually did try to apply for this license. 12 13 They were denied. And what they did is turned to a life of crime. I'm not saying I'm going to do that. 14 But I do understand how a lot of people in the street, they 15 tried to walk a straight line, they ended up off the 16 deep end and started committing crime and never got 17 back. 18

Now, I don't plan on doing that. I want to 19 make an honest living. And I think you should give me 20 21 an opportunity and reconsider this. Because I can promise and guarantee all of you, you'll never see me in 22 here again or hear about me being in trouble with the 23 I actually want to work on the other side of the 24 law. That's what I want to do, work corrections. 2.5 law. And I

1	feel like, you know, this is a great time for me to
2	start fresh.
3	I mean it was very surprising to me when I
4	actually got the denial delivered. Because I was
5	curious. I'm walking around as an armed citizen, you
6	know, with a CCW. But I can't be an unarmed security
7	guard. I was very surprised. I was almost shocked when
8	I got it. I needed a license to buy teargas, but I
9	can't be an unarmed security guard. It was surprising
10	to me. But I understand, you guys have rules. But I
11	think that you should reconsider in my case, because,
12	you know, some good will come out of this.
13	BOARD CHAIRMAN ZANE: Well, I from at
14	this point, usually we don't debate it at this point.
15	But in order for you to understand where I'm coming
16	from, I am all about giving people a second chance.
17	Because everybody makes mistakes, as you said. And I
18	would be thoroughly prepared to give you that card had
19	you disclosed everything that existed that was going to
20	come back on your fingerprint report. I mean that's the
21	issue is the lack of disclosure.
22	And I can tell you're an intelligent man. So I
23	can't factor in the fact that you didn't see what was on
24	the application process, that you have to disclose these
25	things.

1	MR. SUMMERISE: I know. But you're right.
2	But, you know, like I said, on a day-to-day basis I'll
3	walk around not looking at myself as a criminal, even
4	dwelling on the mistakes that I made in the past. I
5	move forward from things. And it really was just
6	absentminded at the time, and I wasn't even thinking
7	about these things, you know.
8	Two days before I came and applied for this
9	license, me and my brother, we were actually talking
10	about that time when we got in the fight. So it's very
11	fresh in my mind. And, you know, that was like one of
12	the first things I put on there, you know, because it's
13	very fresh in my find and we were just talking about it.
14	As far as the other things, you know, it wasn't
15	an issue to me or even came into my mind, because I did
16	have jobs where they actually hired me and did the

17 background check, even at a school working with 18 celebrity kids. And, you know, it wasn't an issue.

19 So it's just, you know, I'm walking around, you 20 know, on a day-to-day basis, and I didn't even think 21 about it. I even got traffic citations in the past 22 where, you know, a couple times they wanted me to step 23 out of the car, and they started asking me if I had 24 drugs or weapons in the car. And, you know, go ahead, 25 search. I'm all for the stop and frisk. And so I let

1	them do that. And I remember on two different occasions
2	the officer saying, "He has no criminal history." This
3	is in California, and once was here in Nevada.
4	And so, you know, people ask me have you ever
5	been arrested before, I say, you know, nil, you know. I
6	don't walk around looking at myself or thinking of
7	myself as a criminal. And especially when I was granted
8	the CCW. I never even thought about anything that I've
9	ever been arrested for in the past. I'm moving forward
10	from that point on.
11	You know, and another reason why I don't want
12	to stay in California is that the crime is just you
13	know, it's a number of reasons. But I was carjacked at
14	gunpoint, you know. And I came to Nevada literally two
15	days later, leaving everything I had there, you know, to
16	stay there. I just wanted a fresh start. I felt like
17	I'm going to get hurt out there. And so I moved out
18	here. I purchased a firearm, and I wanted to protect
19	myself, because I don't want to be the victim of a
20	bully.
21	Now, fortunately for me, you know, my
22	grandmother, she owns three properties, you know, one
23	here. My mom lives in one here. And the condo where I
24	was living in the last several years in California.
25	Now, I'm willing to actually leave free rent and come

here and start over and buy a home here, just because I don't want to stay there. I don't like the politics. I felt like something's going to happen to me. And when I was carjacked at gunpoint, I never felt so hopeless in my life. I just wanted to leave the state immediately, and 48 hours later I was gone.

You know, and I came here. And I like the 7 politics here. You know, I like what Governor Sandoval 8 is doing. You know, Joe Barr is doing a pretty good 9 He'll probably be reelected, you know. And, you 10 job. know, I do realize Nevada has its flaws, but I just felt 11 like I'm supposed to be here. And my mom's been telling 12 13 me for years, "Leave California. There's nothing for you there." You know, in addition to the crime and all, 14 via the politics. And I always told her, "No, I don't 15 want to move to Nevada." And then, when it happened, I 16 felt like maybe it's time for me to get out of there. 17

You know, but I want to come out here and make 18 an honest living. And I want to go work at McDonald's. 19 20 And the last year and a half, when I first moved out 21 here, you know, I had a few big months in sales. And so when I came out here, I didn't apply for a job for 22 almost a year. I had a lot of savings. I didn't have 23 any debt. I don't have any kids. And so, recently, I 24 started thinking, well, maybe it might be time for me to 2.5

1	get a job. And so I applied for this. I said, okay,
2	I'll do security for a year, and I'll go, in maybe a
3	year or two, go do corrections.
4	And when I was denied, that's when I started
5	thinking, well, wait a minute. And then I had to go
6	back to California, because I have a guard license in
7	California, and I worked some of those companies, and
8	one of them hired me that I used to work for years ago.
9	And that's the company I'm employed with right now.
10	You know, and I just want to start over. You
11	know, there's no question in my mind that I'll never be
12	arrested again. Now, I do realize that I can be charged
13	for something that's not my fault. There's a lot of,
14	you know, things that happen, you know. I'm not saying
15	there's bad. I do trust law enforcement. But I don't
16	plan on ever being arrested for anything ever in my life
17	again. I'm not a criminal. You know, I actually want
18	to be on the other side and bring criminals in, you
19	know.
20	BOARD CHAIRMAN ZANE: Okay. Any other Board
21	questions, comments?
22	BOARD MEMBER COLBERT: No.
23	BOARD CHAIRMAN ZANE: Let's see. There's a
24	motion. All in favor, say "aye."
25	(Board members said "aye.")

5	We'll trail number 48, Crystal Sunier.
6	Steven Tayrien?
7	Good afternoon.
8	MR. TAYRIEN: Good morning, or afternoon.
9	BOARD CHAIRMAN ZANE: It runs together.
10	Who's the investigator?
11	MS. DONALD: Investigator Donald.
12	BOARD CHAIRMAN ZANE: Please.
13	MS. DONALD: Mr. Tayrien was convicted of a
14	felony DUI in 2001 and was sentenced to two years prison
15	in California. He disclosed the arrest.
16	BOARD CHAIRMAN ZANE: So the denial was simply
17	for the felony?
18	MS. DONALD: Yes, for the felony.
19	BOARD CHAIRMAN ZANE: Okay. Can you tell us a
20	little bit about that arrest and the conviction?
21	MR. TAYRIEN: I had gone out with some friends
22	that night. And I was coming home on the freeway, and
23	came around a curve, and somebody had ran out of gas on
24	the freeway, didn't see them, hit the back of them,
25	causing them an injury, a broken collar bone. So I

1	completed percle and the contense
1	completed parole and the sentence.
2	BOARD CHAIRMAN ZANE: Did you take it to trial,
3	or did you plead?
4	MR. TAYRIEN: Plead. Yeah, the attorney kept
5	saying, "Just wait, just wait, just wait." So I waited
6	for a year, over a year. And I just, you know, I wanted
7	to tell them guilty from the get-go. Let's just get it
8	over with. I drank. I drove. I hit her. I caused her
9	injury. But he just thought he would be able to get a
10	better deal.
11	BOARD CHAIRMAN ZANE: Okay. Nothing since
12	then?
13	MR. TAYRIEN: No.
14	BOARD CHAIRMAN ZANE: What have you been doing
15	with your life?
16	MR. TAYRIEN: I came here in 2008 from
17	California to help my mom and dad. My mom had the
18	beginning stages of Alzheimer's. And when I got here in
19	2008, I moved into a mobile home park just to be in the
20	area, soon noticed that I needed couldn't go to work.
21	I had to help them more. Being in the park, it was
22	mostly a senior park. So I became active in the park,
23	and I started a neighborhood watch program and held
24	monthly meetings.
25	I was able to help her until she died in 2010.

1	Due to my dad's failing health, I actually ended up
2	moving in with him. And he passed in 2017. So I was
3	his main caregiver. The past year, I've had to close
4	our their trust. So I've been doing that. So now I
5	have to be grown up and pay bills again. I'm hoping to
6	try some new things and something I'd like to do now,
7	so.
8	BOARD CHAIRMAN ZANE: Sure. Okay. Any Board
9	questions, comments?
10	BOARD MEMBER NADEAU: No.
11	BOARD MEMBER COLBERT: No.
12	BOARD CHAIRMAN ZANE: Okay. Entertain a

CHEA: Good afternoon, sir, and the Board. 11 BOARD CHAIRMAN ZANE: Who's the investigator? 12 1.3 MR. MAXWELL: Investigator Maxwell. BOARD CHAIRMAN ZANE: Please. 14 MR. MAXWELL: Mr. Chea was issued a 15 provisional. Receiving his fingerprints, we found 16 arrests out of New Hampshire. 1989, felony forgery. 17 That disposition was unknown. Also, in '89, receiving 18 firearms while under indictment, which is a misdemeanor. 19 20 He got six months probation for that. And in 1991, 21 buying a firearm while under indictment, which is also a misdemeanor, convicted, three years probation. 22 None of the arrests were disclosed, all found 23 24 in the fingerprint report. However, once notified, the applicant obtained and provided court documents. And he 2.5

also provided a character reference from Welcome Home in 1 Manchester, New Hampshire, where he worked as a manager. 2 BOARD CHAIRMAN ZANE: Okay. Mr. Chea? 3 MR. CHEA: Yes? 4 BOARD CHAIRMAN ZANE: What can you tell us 5 about these? 6 7 MR. CHEA: Oh, first of all, I just want to say that for the past 30 years, I've dedicated myself to the 8 homeless, families in transaction, the needy, and also 9 disabled veterans. I've been involved in security for 10 30 years. 11 Back in 1989, during those two, roughly two and 12 13 a half years, I was working for a company that, let's say the owner was a little bit shady. Everything was in 14 15 my name for financial reasons and so forth, and the company had signed it by the State of New Hampshire. At 16 the time, I was also the competent person in asbestos, 17 lead and hazardous waste. 18 To make a long story short, my lawyer and I 19 20 went to court. The company went under and so forth. 21 And I got, I got penalized. I got blamed for everything. 22 To make a long story short, my records, okay, 23 were supposed to be squashed, where I was told that by 24 2.5 my lawyer. I didn't know that I had this existing gun

1	charge. And I explained that to Inspector Maxwell. I
2	tried, I got ahold of my lawyer, and here's what he told
3	me, basically, he said his records are gone, he's moved
4	on and so forth. I called up the archives. I finally
5	got a record of all those documents and to forth. I
6	never even went to court on these charges. I went to
7	court with my lawyer on the previous charges with the
8	existing companies. Okay. I didn't know that I was
9	charged. I didn't know that I had these charges,
10	anything like that.
11	I have had numerous, numerous criminal records
12	and checks done by me over the course of the year. I've
13	been, I've worked very closely with the New Hampshire
14	state police, the Massachusetts state police because of
15	the human service field that I was in. Nothing ever
16	came up.
17	I am currently a security officer. I was the
18	master sergeant for the Longhorns for over a year. I
19	have a gun license. My record has been clean. I have
20	no prior. I didn't have any contact with police or
21	anything like that since 1991.
22	And I didn't know, okay, that I had these
23	existing charges, or whatever you want to call it. And
24	when I called up the courts in New Hampshire, I finally
25	got ahold of the lady who was like the clerk of the

courts of archives, and she had a very hard time finding
the records and so forth. She did finally. It cost me
like almost \$200 to get copies of this. Okay. And then
I was reading the indictment, or excuse me, the charges,
okay, and I called her back and so forth. And all she
told me was that it got moved up to Superior Court. And
I explained to her, I said, "I never went to court."
She goes and she looked it up. She says, "Yes, you
know, you never went to court. But somehow, you know,
you got convicted on it." Which I didn't know. If I
had known that, like I said, I'm straightforward and
honest, I would have put it down on my application.
But I had no idea that I had these charges,
number one. Number two, if I had known about it, okay,
I would have put them down. And number three, I just
didn't know. I didn't know that I had these charges on
me. And like I said, I've had criminal checks on me,
you know, I mean lots of them, by lots of police
departments, because, like I said, the field that I was
working in, and none of this ever came up.
She even told me they're so old that they were
sealed in the archives, and they had transferred from
paper to today's technology, computer disk, whatever,
and all that. And I went through, like I told
Mr. Maxwell, I went through like two and a half weeks of

1	calling night and day, to try to get a copy of these
2	records, okay, to find out, you know, why it happened in
3	my record and so forth.
4	That's it, sir, in a nutshell.
5	BOARD CHAIRMAN ZANE: When you, when it says
6	indictment, in Nevada an indictment only happens at the
7	felony level. So I'm a little bit confused. Is that
8	indictment for misdemeanors in New Hampshire?
9	MR. MAXWELL: It didn't really say, sir. I
10	didn't see anything on the fingerprint report that said
11	indictment.
12	BOARD CHAIRMAN ZANE: Okay. There was a buying
13	of a firearm or possession of a firearm while under
14	indictment?
15	MR. MAXWELL: So, yes, while under indictment,
16	receiving firearms, which he got six months probation
17	for, and buying a firearm while under indictment, which
18	he got three years probation. I think, that's, the
19	indictment was for the Class B felony case, which was
20	the first one Mr. Chea explained.
21	BOARD CHAIRMAN ZANE: Okay.
22	MR. CHEA: Could I add something to that, sir?
23	BOARD CHAIRMAN ZANE: Please, yes.
24	MR. CHEA: I was working at a shelter called
25	New Horizons, which is shelter in the city of

1	Manchester. We had a shooting, and we had a couple of
2	stabbings. The board came to me and suggested that I
3	get a firearm, you know, for protection, because some of
4	their staff had been attacked, you know, at the time.
5	Anyway, I purchased a gun, yes, I did, and in a
6	gun shop in southern New Hampshire, okay, while under
7	indictment. Which I didn't know that you couldn't buy a
8	gun under indictment. ATF showed up at my office like
9	two and a half weeks, you know, or two weeks after,
10	knocked on the office, and asked me, "Did you buy,
11	purchase a gun?" blah, blah, blah. And I said, "Yes, I
12	did." I said, "It's right here." And I had it, you
13	know, in my desk in the holster and so forth.
14	And what they said to me was, "You're under
15	indictment. You can't purchase a gun." So I handed
16	them the gun, and I said, "What's going to happen?" and
17	so forth. And, basically, the ATF just says, "We'll get
18	back to you." And that was the last I heard of it.
19	And, like I said, I never went to court on it, sir.
20	BOARD CHAIRMAN ZANE: Okay. Out of all of the
21	documents that he's provided, was there any court
22	minutes of any type, or was it just dispositional
23	documents?
24	MR. MAXWELL: It was the copy of judgment from
25	the district court in Concord, New Hampshire. And it

1 was the judgment. BOARD CHAIRMAN ZANE: Okay. Any other Board 2 3 questions? Entertain a motion. 4 Second call for a motion. 5 BOARD MEMBER COLBERT: Mr. Chair, I move that 6 7 Mr. Chea's denial be upheld, and based upon his failure to disclose. 8 BOARD CHAIRMAN ZANE: Is there a second? 9 BOARD MEMBER NIXON: I second. 10 BOARD CHAIRMAN ZANE: There's a motion and a 11 second to uphold the denial. Any Board questions or 12 13 comments regarding the motion? All in favor, say "aye." 14 (Board members said "aye.") 15 BOARD CHAIRMAN ZANE: Any opposed, say "no." 16 Passes unanimous. We've upheld the denial for 17 failure to disclose the history. You're welcome to come 18 back in a year. I'm sure if you fully disclosed, you 19 20 probably would have seen a different outcome. Thank 21 you. MR. CHEA: Thank you. 22 BOARD CHAIRMAN ZANE: Number 51, Darnell 23 Morris? 24 Are you Mr. Morris? 25

1	MR. MORRIS: Yes. How are you dong today?
2	BOARD CHAIRMAN ZANE: Good. How are you?
3	MR. MORRIS: I'm fine.
4	BOARD CHAIRMAN ZANE: Who's the investigator?
5	MS. DONALD: Investigator Donald.
6	BOARD CHAIRMAN ZANE: Please.
7	MS. DONALD: In 2004, out of the California,
8	Mr. Morris was convicted of a felony for transporting
9	and selling narcotics. He was found guilty and served
10	three years in prison. He did disclose.
11	2000, out of the California, Mr. Morris was
12	found guilty of a felony transporting and selling
13	narcotics, found guilty, two and a half years prison.
14	He did disclose.
15	1994, out of California, found guilty of a
16	felony possession and purchase cocaine, guilty, four
17	years prison. He did disclose.
18	BOARD CHAIRMAN ZANE: Okay. Mr. Morris, can
19	you tell us a little bit, something about those, that
20	criminal activity?
21	MR. MORRIS: Just was unemployed and just
22	started selling drugs.
23	BOARD CHAIRMAN ZANE: Were these trials or
24	pleas?
25	MR. MORRIS: No, these were all pleas.

1	BOARD CHAIRMAN ZANE: Pleas?
2	MR. MORRIS: Yes, sir, m-hm (affirmative).
3	BOARD CHAIRMAN ZANE: What have you been doing
4	with your life since 2004?
5	MR. MORRIS: I got my, through the V.A.,
6	pension. Yeah. When you get everybody in the
7	military, you can file for a pension. So I filed, and
8	they approved it.
9	BOARD CHAIRMAN ZANE: What branch of the
10	military?
11	MR. MORRIS: United States Navy.
12	BOARD CHAIRMAN ZANE: Thank you for your
13	service.
14	MR. MORRIS: Yes, sir.
15	BOARD CHAIRMAN ZANE: And, what, you want to
16	get into the security field?
17	MR. MORRIS: Yeah, I did it back in '91 for a
18	couple of months. And I'm getting bored just sitting
19	around the house. So I said I'm going to try to get me
20	another job.
21	BOARD CHAIRMAN ZANE: I see. Okay. When was
22	the last time you imbibed in narcotics?
23	MR. MORRIS: 2004.
24	BOARD CHAIRMAN ZANE: Did use have anything to
25	do with

1	MR. MORRIS: Oh, no, sir, I never, never, never
2	use, never drink, never smoke, none of that.
3	BOARD CHAIRMAN ZANE: So it was just a matter
4	of economics?
5	MR. MORRIS: Basically, yes, sir.
6	BOARD CHAIRMAN ZANE: All right. Any other
7	Board questions, comments?
8	Call for a motion.
9	BOARD MEMBER NADEAU: Mr. Chair?
10	BOARD CHAIRMAN ZANE: Yes, sir.
11	BOARD MEMBER NADEAU: I move to grant Darnell
12	Morris a registration work card and overturn the denial.
13	BOARD MEMBER COLBERT: Second.
14	BOARD CHAIRMAN ZANE: We have a motion. Is
15	there oh. We got a second. Any comment or question
16	on the motion?
17	BOARD MEMBER NADEAU: Yes, sir.
18	Mr. Morris, thank you for being straightforward
19	and honest.
20	MR. MORRIS: Yes, sir.
21	BOARD MEMBER NADEAU: And for disclosing.
22	MR. MORRIS: Yes, sir.
23	BOARD CHAIRMAN ZANE: Okay. All in favor of
24	the motion, say "aye."
25	(Board members said "aye.")

1	BOARD CHAIRMAN ZANE: Any opposed, say "no."
2	The denial will be overturned, and they'll
3	issue you a card.
4	MR. MORRIS: Thank you, sir.
5	BOARD CHAIRMAN ZANE: Thank you.
6	MR. MORRIS: Take care.
7	MR. INGRAM: We have several trailed items.
8	BOARD CHAIRMAN ZANE: Okay. We'll take them
9	one at a time, so we have a clear record.
10	MR. INGRAM: The first trail I have is item
11	number six, Invictus International Holdings.
12	BOARD CHAIRMAN ZANE: I had the opportunity to
13	go back and check the minutes. And it shouldn't be
14	surprising that I wasn't as clear as I should have been
15	when I was talking and thinking at the same time. So I
16	don't have a firm recollection of the issue that I
17	wanted to raise at the first meeting. I just knew that
18	I wanted an answer regarding the filing at the Secretary
19	of State that caused me some issue when I was doing the
20	homework.
21	So is there any reason why this person wouldn't
22	be here again?
23	MR. INGRAM: They were noticed. They knew the
24	reason for the postponement was that they did not appear
25	the first time.

BOARD CHAIRMAN ZANE: When I make the mistake of handing you back the thumb drive, I also hand you back my memory, so.

MR. INGRAM: I resemble that remark.

4

5 BOARD CHAIRMAN ZANE: So without somebody here 6 to answer a question, it seems to me like my issue was 7 with regard to the Secretary of State. Because I think 8 that that was my mantra that meeting. It was just one 9 of those things I just default, chose to default to when 10 I was doing my homework. So it was just figuring out 11 what was going on with the Secretary of State, so.

MR. INGRAM: And I know that Gisela Corral did have contact with them again and notify them of the meeting. And we fully intend that she intended for them to be present today.

BOARD CHAIRMAN ZANE: I hate to make a denial based upon something that I had in my mind at the time when, I think, I was -- that was the only thing that was raised as a negative. And I don't know that it was a negative. I just needed clarification from somebody. MR. INGRAM: Investigator Maxwell, did you have any notes, additional notes on the background itself?

MR. MAXWELL: Only what was -MR. INGRAM: Previously presented?
MR. MAXWELL: Previously presented, sir.

1	BOARD CHAIRMAN ZANE: I went back again through
2	the minutes of the December meeting, and it's finally
3	I think, I didn't fully explain it because they weren't
4	physically present, so I wasn't you know, I didn't
5	make a good enough record. So. But they had notice
6	that we're here and we're ready to go.
7	I'd move for denial of item number six,
8	Invictus International Holdings, LLC.
9	BOARD MEMBER COLBERT: Second.
10	BOARD MEMBER NIXON: Second.
11	BOARD CHAIRMAN ZANE: Okay. We have a motion
12	and a second. Any Board discussion or question
13	regarding the motion?
14	BOARD MEMBER NADEAU: Mr. Chair?
15	BOARD CHAIRMAN ZANE: Yes, sir.
16	BOARD MEMBER NADEAU: I guess, I'm a little
17	reluctant to vote, or to support the motion, only
18	because this is a member. It's not a qualifying agent
19	or anything of that nature. It doesn't rise to the same
20	level of qualifications as a qualifying agent. So I
21	don't know that I can support the motion.
22	BOARD CHAIRMAN ZANE: That's a good point.
23	Thank you. Now that you've mentioned it, I don't like
24	that, either.
25	BOARD MEMBER COLBERT: Mr. Chair?

1	BOARD CHAIRMAN ZANE: Yes.
2	BOARD MEMBER COLBERT: This is for Mr. Ingram.
3	When you contacted them, did they give any indication
4	why they weren't here the last time, or provide any
5	information?
6	MR. INGRAM: Right. It was a travel deal.
7	They wanted to know if it was absolutely necessary for
8	them to be present. And Board staff tells them the same
9	thing every time. It's not a requirement by statute or
10	regulation. However, we strongly urge them to be
11	present in the event there's a question for
12	clarification. And they chose at that time not to, to
13	show. Board history normally did not require a member
14	or a corporate officer to always be present. It was
15	just individuals that were coming before the Board for
16	licensure.
17	So, as Mr. Nadeau put on the record, those have
18	never been held to the same level of them appearing
19	before the Board, just because they are a member or
20	corporate officer and not actually the licenseholder for
21	the company.
22	BOARD MEMBER COLBERT: Were they notified that
23	there was an issue that needed clarification?
24	MR. INGRAM: Yes, sir.
25	BOARD MEMBER COLBERT: Okay.

1	BOARD MEMBER NADEAU: Mr. Chair?
2	BOARD CHAIRMAN ZANE: Yes, sir.
3	BOARD MEMBER NADEAU: Thank you, Mr. Chair. My
4	recollection was that this item was, then, part of the
5	block vote, except for the question as far as the
6	Secretary of State.
7	BOARD CHAIRMAN ZANE: In looking back, and I
8	have accessed the Secretary of State's website, and in
9	looking back, I think I had a question with regard to
10	MBI Asset Management, LP, because they are listed as a
11	managing member in the corporate documents, but they're
12	not, as I recall, included in our files. So that would
13	be a separate legal entity not being a human being,
14	being a managing member of an organization that seeks to
15	have licensure.
16	So the entity itself is listed as the managing
17	member, which is self-explanatory; a managing member of
18	Matthew Koetting; a managing member of Stephen Krueger.
19	But then the fourth managing member was a separate
20	entity, MBI Asset Management, LP.
21	So, I think, that's what caused my question as
22	to who makes up MBI Asset Management, LP. Because
23	they're a managing member, they would have it would
24	seem like they should be here, whoever those people are
25	that represent that company should be here subject to

1	licensure. That's my recollection now.
2	So we had Invictus International Holdings, LLC,
3	and we're looking to they've already got a licensee.
4	And they were seeking member approval for Mr. Krueger,
5	who is listed as a managing member. And, I think,
6	Mr. Koetting ("Kote-ing") or Koetting ("Keet-ing") or
7	whatever, is the licensee, correct?
8	MR. INGRAM: Yes.
9	BOARD CHAIRMAN ZANE: Yes. So we've got the
10	two principals involved there in Invictus International.
11	That's a taxation issue. But then, with this separate
12	entity, MBI Asset Management, LP, why aren't they on our
13	agenda, and why didn't that entity file an application
14	to be considered? We don't know who they are. We don't
15	know. Well, I guess, we can look around, look them up,
16	right? MBI Asset Management.
17	Without casting aspersions, it seems like the
18	type of foundation that you use to hide things, or to be
19	reasonably crafty anyway.
20	Now, in MBI, we've got a general partner of
21	RD Inc. So we've got another company and another layer
22	of business.
23	So, I think, my point at the time was I can't
24	even consider this without somebody showing up and
25	making it, having them make it make sense to me.

1	So, from the perspective that oh, I'm sorry.
2	BOARD MEMBER NADEAU: No. No, go ahead.
3	BOARD CHAIRMAN ZANE: From the perspective of
4	the action to deny, I would guess that that would only
5	be the denial for that application based upon their
6	wanting Mr. Krueger put into the mix and listed as a
7	member. I don't think that it would do anything to
8	revoke the license or its current operation. However,
9	this might raise enough of an issue that we might have
10	to take a look at it and see who's actually running this
11	company.
12	BOARD MEMBER NADEAU: Mr. Chair?
13	BOARD CHAIRMAN ZANE: Yes, sir.
14	BOARD MEMBER NADEAU: Would an alternative be
15	for the Board to inquire as to who we know, we know
16	Krueger is a member of the LLC.
17	BOARD CHAIRMAN ZANE: Yes.
18	BOARD MEMBER NADEAU: Would it be maybe an
19	alternative route to inquire of them as to who the
20	other, other member or, you know, whatever, the other
21	managers? In other words, shed some light on that
22	rather than deny a member that's an individual. Maybe
23	I'm not being very clear on that, but.
24	And I'm kind of stuttering around here, but,
25	you know, he's a real person. So, therefore, to deny

1	him would then then, we wouldn't have a real person
2	as far as the LLC. You know, because we have another
3	entity. What is it called, MBI Asset Management?
4	BOARD CHAIRMAN ZANE: Right. And then they're
5	owned by a company called RD Inc.
6	MR. INGRAM: We always can open an audit.
7	BOARD MEMBER NADEAU: I'm sorry?
8	MR. INGRAM: I said we can always, if you were
9	to approve him as a member, since he is listed on the
10	Secretary of State, we could always open up an audit
11	from that company, for Invictus, to go down those couple
12	of layers to investigate not only MBI, but the other
13	party, RD Holding, or whatever it was, and audit those
14	records and then report back to the Board at a later
15	time.
16	BOARD CHAIRMAN ZANE: Well, for me, it's kind
17	of like the cart before the horse, though, because I'm
18	not so sure. For a licensee to include someone on the
19	corporate structure, prior to being approved by the
20	Board, seems to me the wrong way to go. I mean if he's
21	already put on the corporation as an officer or a
22	member, before we approve it, that that seems like there
23	was some forgone conclusion that he was qualified to do
24	so.
25	Now, if the company has other holdings, and

1	they produce widgets, and he's in charge of the widget
2	thing, that would cause another question. But if all
3	they do and it may be that there are other avenues
4	for business to operate, since you have three layers of
5	business. There's got to be some reason that you have a
6	corporation that's owned by a limited liability company,
7	which in turn becomes a managing member of a third
8	limited liability company. That's either got to be an
9	accountant's dream or there's some reason for that
10	insulation.
11	MR. INGRAM: Well, we always require that the
12	individuals be added to the Secretary of State, along
13	with their application to become a member or a corporate
14	officer. That's part of the requirement that we provide
15	to the Board for review, is to show that they've gone
16	through the process of adding them through the Nevada
17	Secretary of State, for them to then come before you as
18	an applicant for member or corporate status.
19	I guess, what we could do is go back to that
20	initial investigation that was conducted on Invictus and
21	Mr. Koetting to see if he was added before or after.
22	BOARD CHAIRMAN ZANE: Well, I don't see any
23	problem with that when there's no license in existence.
24	MR. INGRAM: Right.

BOARD CHAIRMAN ZANE: So if you show up with a

Nevada corporation and say this is how we're going to do 1 business if we get a license, well, that presupposing. 2 You're not doing business already as a security in the 3 state with somebody that hasn't been vetted. 4 MR. INGRAM: True. 5 BOARD CHAIRMAN ZANE: Because he's walking into 6 7 an existing license. MR. INGRAM: 8 Right. BOARD CHAIRMAN ZANE: Rather than we formed a 9 corporation, and now we want to come through and be 10 anointed to do the duty. That causes a little bit of 11 trouble. Because, otherwise, theoretically, they just 12 13 throw a couple more officers in. And if it was contemporaneous, that doesn't cause me as much 14 heartburn, you know, but. 15 MR. INGRAM: Right. 16 BOARD CHAIRMAN ZANE: I just, now that's the 17 fog, and the memory is coming back a little bit. And it 18 was just the fact that it caught me as strange that it 19 20 would have those levels of corporate involvement without 21 having included in the application process, so that 22 there would be a disclosure that maybe you need to investigate this company and this company and this 23 company. I doubt that they want to pay all of those 24 2.5 investigative fees.

1	BOARD MEMBER NIXON: Devil's advocate, wouldn't
2	that be the only reason you'd want to be here, to answer
3	the questions, not go through that process, so.
4	BOARD CHAIRMAN ZANE: If the second will allow,
5	I can withdraw my motion.
6	BOARD MEMBER COLBERT: No problem.
7	BOARD CHAIRMAN ZANE: Okay. And ready for a
8	new one if somebody's got one.
9	BOARD MEMBER NADEAU: Mr. Chair, I'll try.
10	BOARD CHAIRMAN ZANE: Okay.
11	BOARD MEMBER NADEAU: Thank you. I would just
12	make a motion that the item for Invictus International
13	Holdings, LLC be moved to the next regularly scheduled
14	PILB meeting, and in the interim they be contacted.
15	And I don't really want to include the audit,
16	an audit piece in the motion, unless you think it's
17	absolutely necessary. But I think there should be some
18	requirement by the Board as to who all is involved. So.
19	BOARD CHAIRMAN ZANE: We have a motion. Is
20	there a second?
21	BOARD MEMBER COLBERT: Second.
22	BOARD CHAIRMAN ZANE: Okay. Any Board
23	questions or comments on the motion?
24	BOARD MEMBER NADEAU: Does Kevin need, does
25	Kevin need the audit piece in the motion? If not, then

1	it will not be included.
2	MR. INGRAM: No, it's not required. We can do
3	that at any time.
4	BOARD MEMBER NADEAU: So that is not, the audit
5	is not part of the motion, just to be clear.
6	BOARD CHAIRMAN ZANE: Okay.
7	BOARD MEMBER NIXON: Can I ask a question?
8	BOARD CHAIRMAN ZANE: Sure.
9	BOARD MEMBER NIXON: Does this get postponed
10	until I mean when do we say you haven't showed up,
11	you know, you're denied?
12	BOARD CHAIRMAN ZANE: I would assume, if it
13	gets on the next agenda, I'd have a hard time voting to
14	let it go past that.
15	BOARD MEMBER NADEAU: And I'd probably fully
16	agree with that.
17	BOARD CHAIRMAN ZANE: In the discussion portion
18	for the motion, I wanted to make sure that the record is
19	clear that I wasn't pronouncing my little jaunt through
20	the Web, to the Secretary of State's office, as evidence
21	of any nature. That would be up to staff to conclude
22	the veracity of the I was just trying to recollect
23	my reasoning for not wanting to handle it in a block
24	vote at the last meeting.
25	So I'm not saying that this is research. I'm

not supposed to be the investigator. So I'm just saying 1 2 that's what caused me to have that at the last meeting. So whatever I just said wasn't -- I'm not basing it on 3 any fact, just what I saw. 4 So, all in favor? 5 (Board members said "aye.") 6 7 BOARD CHAIRMAN ZANE: Any opposed, say "no." Carries unanimously. 8 MR. INGRAM: The next trailed item is item 9 number 22, R & G Securities LLC. Ms. Garnetta Brown was 10 notified. And Board staff was under the impression that 11 she would be present today. 12 13 BOARD CHAIRMAN ZANE: Can we have a motion to postpone to the next meeting? Or I make the motion. 14 15 BOARD MEMBER NIXON: I second. BOARD CHAIRMAN ZANE: We have a motion and a 16 second. Any Board discussion or comment on the motion? 17 All in favor, say "aye." 18 (Board members said "aye.") 19 20 BOARD CHAIRMAN ZANE: Any opposed, say "no." Carries unanimous. 21 MR. INGRAM: And we already put on the record 22 that item number 27 would be withdrawn. 23 The next trailed item I have is item number 36, 24 2.5 Johnny Hardwick.

1	BOARD CHAIRMAN ZANE: Okay. Item number 36,
2	Johnny Hardwick. Is he, Hardwick, here?
3	Which one's next?
4	MR. INGRAM: The next item is number 39, Steve
5	Larkey.
6	BOARD CHAIRMAN ZANE: Steve Larkey, item number
7	39?
8	MR. INGRAM: Next item, 45.
9	BOARD CHAIRMAN ZANE: Sarah Schayes, item
10	number 45?
11	MR. INGRAM: Next item is 48, Crystal Sunier.
12	BOARD CHAIRMAN ZANE: 48, Crystal Sunier.
13	MR. INGRAM: And that's the last trailed item I
14	have.
15	BOARD CHAIRMAN ZANE: I move we deny the
16	appeals for item number 36, Johnny Hardwick; 39, Steve
17	Larkey; 45, Sarah Schayes; 48, Crystal Sunier.
18	BOARD MEMBER NADEAU: Second.
19	BOARD CHAIRMAN ZANE: Any Board comment or
20	questions regarding the motion?
21	All in favor, stay "aye."
22	(Board members said "aye.")
23	BOARD CHAIRMAN ZANE: Any opposed, say "no."
24	Carries unanimous.
25	That brings us to Board comment and future

1	agenda items.
2	MR. INGRAM: Mr. Chairman, I have a couple of
3	items. First of all, I'd like to introduce our newest
4	investigator to the Board. Shawn Mahan, who is up there
5	in our Carson City office, has been on board for a short
6	period of time with us. And he come to us from Storey
7	County Sheriff. He also has a couple of degrees in
8	mental health counseling. And he's come on board and is
9	learning very quickly. And we're glad to have him as
10	our investigator in the north.
11	MR. MAHAN: Thank you. Thank you very much,
12	Kevin.
13	MR. INGRAM: The other thing, a couple other
14	items. We have had a request by a couple of individuals
15	now who are asking if they can purchase one of our Board
16	pins that we've had made. They like them. They collect
17	them.
18	And at the original time when the pins were
19	discussed, there was discussion amongst the Board, but
20	not a vote. The only vote was that, yes, I could move
21	forward to use some money to purchase the pins. Okay.
22	There was discussion of who should have access to the
23	pins. And in an informal discussion, it was decided
24	that only Board members and Board staff would have
25	access to the pins.

1	And it has been brought to my attention that
2	there's others who would like to purchase them. So I
3	didn't know if that's an item that we need to agendize
4	for future to actually have a vote on it, or if an
5	informal decision might be made on that.
6	BOARD CHAIRMAN ZANE: From my perspective, I
7	view them and consider them as something similar to a
8	patch. And, you know, they're not a designation of any
9	authority. So if somebody covers the cost and they want
10	to be accept FOB, you know, more power to them. But
11	that's just me.
12	BOARD MEMBER NADEAU: Mr. Chair, I agree.
13	BOARD MEMBER COLBERT: I don't have a problem
14	with that. That would be fine.
15	BOARD MEMBER NIXON: I have no problem.
16	MR. INGRAM: Rosalie, do we need to make a
17	formal, do we need to agendize this and have a formal
18	vote, or can we do this informally?
19	MS. BORDELOVE: Well, I would have to look
20	into, I guess, the extent that you need a vote. But to
21	the extent that it's happening during a meeting in an
22	agenda item that's about future agenda items, I don't
23	think any decision can be made right now, under open
24	meeting law concerns, because we're under number 52,
25	which doesn't

1	MR. INGRAM: Right. It also says "Board
2	Comment."
3	MS. BORDELOVE: Right. So a little comment can
4	be done. I wouldn't make any decisions here. Whether
5	it I can discuss with you further whether it's
6	something that the Board has to officially decide on.
7	MR. INGRAM: Okay.
8	MS. BORDELOVE: But I would recommend probably
9	not making any official or unofficial decisions under
10	this agenda item.
11	MR. INGRAM: Okay. Thank you.
12	One last item, pursuant to Administrative Code
13	648.280, I'm required to just put on the record of a
14	quarterly board meeting any, the number of individuals
15	that I have approved authorization to work on a case in
16	Nevada that started in another jurisdiction. And for
17	this quarter, we had three requests. They provided all
18	the documentation that was required. And three
19	approvals were granted for short periods of time. And
20	so, again, just wanted to put that on the record
21	pursuant to NAC 648.280.
22	That's all I have.
23	BOARD CHAIRMAN ZANE: Let's see. I have an
24	informal issue that doesn't necessarily make a decision,
25	but it could be something that Kevin might need some

1	assistance on. I don't even know if it comes to
2	fruition. But I've got, in my private business I've got
3	an issue with a complainant that we're trying to work
4	on, apparently, not to his satisfaction all along the
5	process. But the individual's name is Michael Gudgeon,
6	G-U-D-G-E-O-N. And this is involving a repossession
7	activity.
8	Mr. Gudgeon, in his last foray with me
9	personally had indicated that he expected to what
10	does it say here? He figured out that I'm a Board
11	member and said that he was going to escalate his
12	complaints because I won't resolve them within my
13	company. So, of course, I haven't gone beyond that
14	little piece of extortion.
15	But in the event that he does make a complaint,
16	I wanted to have I didn't want to have anything
17	whatsoever to do with it. So I first anticipated, based
18	upon the nature of his communications with me, that he
19	might have showed up here today and wanted to dance a
20	little bit. But since he didn't and I take him at
21	his word that he's not going to go away. But I also
22	don't want to deprive him of his opportunity to be
23	heard.
24	So I'm hoping that if Mr. Gudgeon makes a
25	formal complaint to the Board, and to the extent that

1	there needs to be any assistance at the Board level,
2	that I can put a rope around your neck, Mr. Nadeau, to
3	act as Chairman on the individual complaint for Michael
4	Gudgeon, if one happens upon us?
5	BOARD MEMBER NADEAU: Whatever you direct me,
6	Mr. Chair.
7	BOARD CHAIRMAN ZANE: Thank you. I don't know
8	that it would come to that, and I don't know that any
9	complaint's going to come. I welcome him to take me to
10	court or anywhere else he'd like to go. But he's
11	tends to want to do something. I don't know what.
12	But I wanted to make sure Kevin could have some
13	assistance if he shows up on his doorstep and wants to
14	make a problem. I don't want to be the guy on the phone
15	with Kevin telling Kevin what he should or shouldn't do,
16	based upon the nature of whatever his claim might end up
17	being. So I'd just like to have it as clean as
18	possible.
19	MR. INGRAM: Absolutely.
20	Rosalie, we'll be there together.
21	MS. BORDELOVE: Say that again.
22	MR. INGRAM: I said you and I would be dealing
23	with that together, so.
24	MS. BORDELOVE: Yes.
25	MR. INGRAM: I'll wait to see if anything is

1	filed.
2	BOARD CHAIRMAN ZANE: I wouldn't have brought
3	it up, except for I didn't want it to come as a surprise
4	and then have you reach out to me, and then with us have
5	to go behind it. I just put you in front of it and say,
6	up to Nadeau, or Mr. Nadeau.
7	MR. INGRAM: Thank you.
8	BOARD MEMBER NADEAU: Mr. Chair?
9	BOARD CHAIRMAN ZANE: Yes.
10	BOARD MEMBER NADEAU: For a couple of maybe
11	agenda items, if the rest of the Board would be
12	interested, is it possible that for one of our agenda
13	items we could get a legal update as far as existing
14	lawsuits that may be in the process? I don't know if
15	that's if our counsel would allow that. But it would
16	just seem to me that that might be an idea.
17	The other thing is, when we were working in the
18	workshop and we passed the regulation, we were talking
19	about reciprocality and that type of thing. And I was
20	just going to ask. Kevin, how and not for
21	deliberation, but are we going to have some kind of a
22	report at our Board meetings on who is granted
23	reciprocation and that type of thing?
24	MR. INGRAM: Yes, absolutely. And, in fact,
25	based on the last discussion at the Board, we were able

1	to finalize I received from the Governor the signed
2	approval of the endorsement. We've now, the next step
3	is moving that regulation forward through the regular
4	administrative process. So that will be going forward
5	to make that permanent.
6	BOARD MEMBER NADEAU: That'll be going to
7	the
8	MR. INGRAM: And if it
9	BOARD MEMBER NADEAU: That'll be going to the
10	Legislative Commission?
11	MR. INGRAM: Yes, so it'll go to LCB again,
12	through the formal process. And as of right now, any
13	applications that are being received with out-of-state
14	licensing, we will follow that regulation to the T, that
15	was passed. And then, at the next Board meeting or at
16	any Board meeting where we have to make determinations
17	based on that, a report will be provided to the Board as
18	a whole.
19	BOARD MEMBER NADEAU: Is there a plan to post
20	reciprocal states on our website or anything of that
21	nature?
22	MR. INGRAM: That's something we could do, if
23	the Board so chooses. You know, we're still in the
24	process of the transition from the old database to the
25	new.

1	BOARD MEMBER NADEAU: Right.
2	MR. INGRAM: They're on a very tight deadline
3	to bring everything to fruition, which gives them about
4	another week to finalize everything. I can tell you
5	that we've made tremendous progress. We will then be in
6	control of our website wholly. And updates can be made
7	there very quickly.
8	Chief of Operations Lori Irizarry is our
9	resident website guru, and she'll be training a couple
10	more on how to make updates to the website. She's done
11	a phenomenal job. And so anything that we decide we
12	want to post for public record, we can do that fairly
13	quickly. And I think it is a good idea, because of the
14	regulation requiring us to do so, that we do make it
15	public record.
16	So in a long way, I'm telling you, yes, I think
17	that's a good idea and, yes, we will do that.
18	BOARD MEMBER NADEAU: But I mean we can't
19	deliberate on issues. It was just a comment.
20	MR. INGRAM: Correct. It's only if it's I
21	don't think it's a decision that has to be voted upon.
22	You know, I have to make public records accessible to
23	the website. So that's something that I'll do in an
24	informal process.
25	BOARD MEMBER NADEAU: Okay. Thank you,

Mr. Chair. 1 BOARD CHAIRMAN ZANE: Also, I wanted to give a 2 short update on our appearance before the Sunset 3 Committee. 4 MR. INGRAM: 5 Yes. BOARD CHAIRMAN ZANE: We're probably going to 6 7 have to go back before them again this month. I think, we were able to answer all of their questions except for 8 the comparison of how much we charge versus what other 9 states charge and whether or not we were nice to 10 business. So it came along the lines of, you know, can 11 we be cheaper than anybody else. But I can ask for some 12 13 comparisons that Kevin's trying to put together, but 14 there's a lot of apples to oranges, because a lot of 15 state agencies are General Fund funded. They're not self-funding entities. 16 So, but that didn't seem to want to hit the 17 right spot in that meeting with a few of the, you know, 18 government, less government is best government-type 19 20 legislators. 21 BOARD MEMBER NIXON: Is there any comment on that as to how long it takes other agencies to get, 22 issue guard cards? 23 BOARD CHAIRMAN ZANE: Well, we talked at length 24 2.5 about the level of efficiencies that we're doing, and we

1	put a comparison up to what we're doing in comparison to
2	California. As a matter of fact, in my testimony, I
3	said, you know, I'm licensed in California and nobody's
4	ever knocked on the door and said boo. I've been cited
5	twice by my own agency.
6	BOARD MEMBER NIXON: Yeah.
7	BOARD CHAIRMAN ZANE: So that tells you a story
8	about who's doing what, where.
9	BOARD MEMBER NIXON: In Arizona, it takes
10	and in New Mexico anywhere from four to six weeks for
11	an employee to get a guard card.
12	MR. INGRAM: Yeah, they were more keyed into
13	the licensing fees. Our licensing fees are higher than
14	most other states, in fact, all the other the states.
15	But, in comparison, when I did the comparison for
16	licensing, original licensing and renewal licensing
17	fees, I added in the expenses of what we charge for
18	branch offices versus other states, significantly lower.
19	What we charge for guard cards or work cards versus
20	other states, tremendously lower.
21	So even if they were to come back and say, yes,
22	I think we need to bring our licensees, licensing fees
23	more in line with the other states, we would more than
24	make up for that in bringing our fees for our work cards
25	up to the level that's an average of the other states.

1	We would still be able to sustain, you know, our budget
2	the way that we do right now, and actually put more
3	money into the budget to allow for more staff to be
4	hired to do a better job of compliance checks.
5	BOARD MEMBER NIXON: Because that's the only
6	thing. I mean it takes them so long to get employees
7	licensed in Arizona that they have, you know, other
8	costs. So it's not business-friendly, because they're
9	paying overtime and everything else because they can't
10	get employees on staff. Whereas here, it is.
11	MR. INGRAM: And I don't know if during the
12	Sunset Committee if they allow for additional witnesses
13	to speak on behalf of the agency. I mean that's
14	something I could inquire about. You know, I don't know
15	of any instance where somebody who's trying to get
16	licensed here said, nope, it cost too much, I'm not
17	going to move forth with licensure. I've never had
18	somebody tell me that, and in my, what, five and a half
19	years now.
20	BOARD MEMBER NIXON: And there's a lot of
21	programs that go along with that, too, JobConnect, issue
22	vouchers if they need help.
23	MR. INGRAM: And right now, our turnaround,
24	what's our turnaround time for work cards?
25	MS. IRIZARRY: Regular work cards is about one

1	or two weeks, expedites about one to two days.
2	MR. INGRAM: Yeah. So one to two weeks versus
3	one to two days on expedites. You know, even when we
4	were down, even when the website was down for those two
5	weeks, we were still turning out work cards. There was
6	absolutely no delay. It's just that they couldn't apply
7	online. They had to apply in-house. But we made some
8	accommodations to make sure that it didn't put a burden
9	on the licensees having to send their staff into our
10	office. In fact, in the north, Investigator Mahan would
11	go to local business offices and pick up applications or
12	bring them to Carson City with him, to prevent them from
13	having to drive to Carson City, and that was
14	well-received.
15	So we'll see how that goes. Steps have been
16	provided to the Sunset Committee. I'll be sending you a
17	copy. And I believe we'll do the best we can to answer
18	the questions.
19	BOARD CHAIRMAN ZANE: Yeah. I think, that's
20	all I have.
21	That brings us to item number 54. All right.
22	Motion to adjourn.
23	MS. BORDELOVE: Don't forget public comment.
24	BOARD CHAIRMAN ZANE: Hey, good job.
25	Anybody have public comment?

1	MR. INGRAM: No public.
2	BOARD CHAIRMAN ZANE: No public in the north?
3	BOARD MEMBER COLBERT: Nothing north.
4	BOARD CHAIRMAN ZANE: Nothing in the south.
5	Now I move for adjournment.
6	MR. INGRAM: But nobody wants to second.
7	BOARD MEMBER NIXON: Second.
8	BOARD CHAIRMAN ZANE: All in favor, say "aye."
9	(Board members said "aye.")
