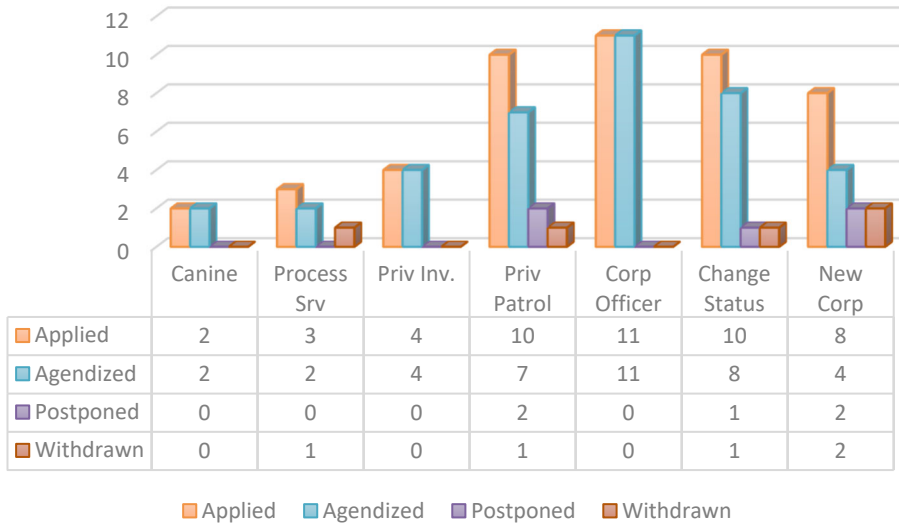

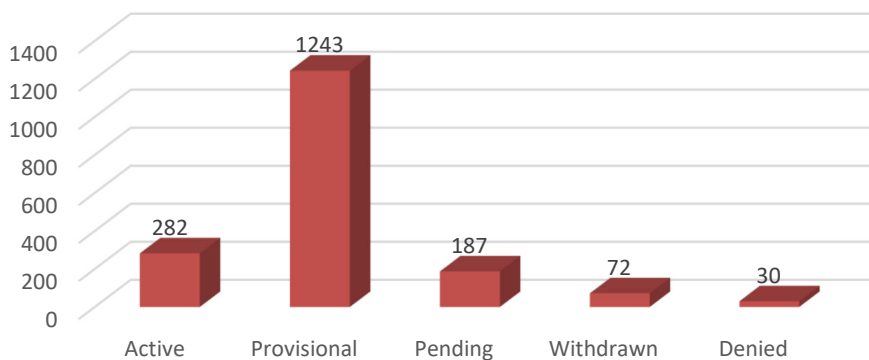

Dec 1st to Feb 26th



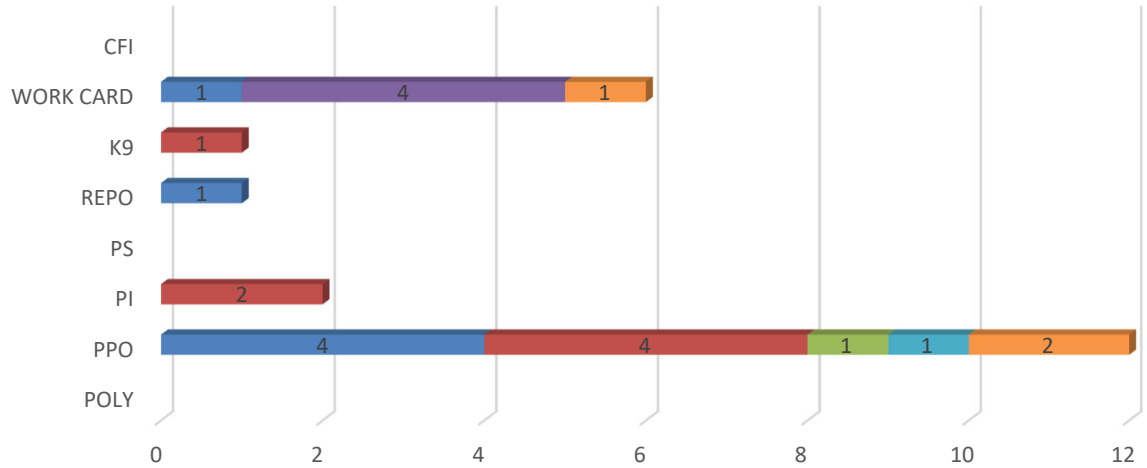
Highlights:

- **187 Pending:**
 - 102 are pending because we are missing information
 - Investigators approx. 1 week on reviewing for provisional
- **1243 Provisional:**
 - Criminal Repository taking approx. 10-12 weeks
 - Extended 3 weeks from last quarter
- **Comparisons:**
 - 270 Decrease from Q4

Active	Completed the work card process and their permanent card has been mailed to them.
Provisional	They are in provisional status. We are waiting for their fingerprint results to determine whether they can be made active or if they need to be denied.
Pending	Applications received and inputted awaiting to be made provisional.
Withdrawn	The applicant was missing information not allowing us to make a proper determination, so their application was withdrawn.
Denied	Their card was denied pursuant to NRS 648.1493.

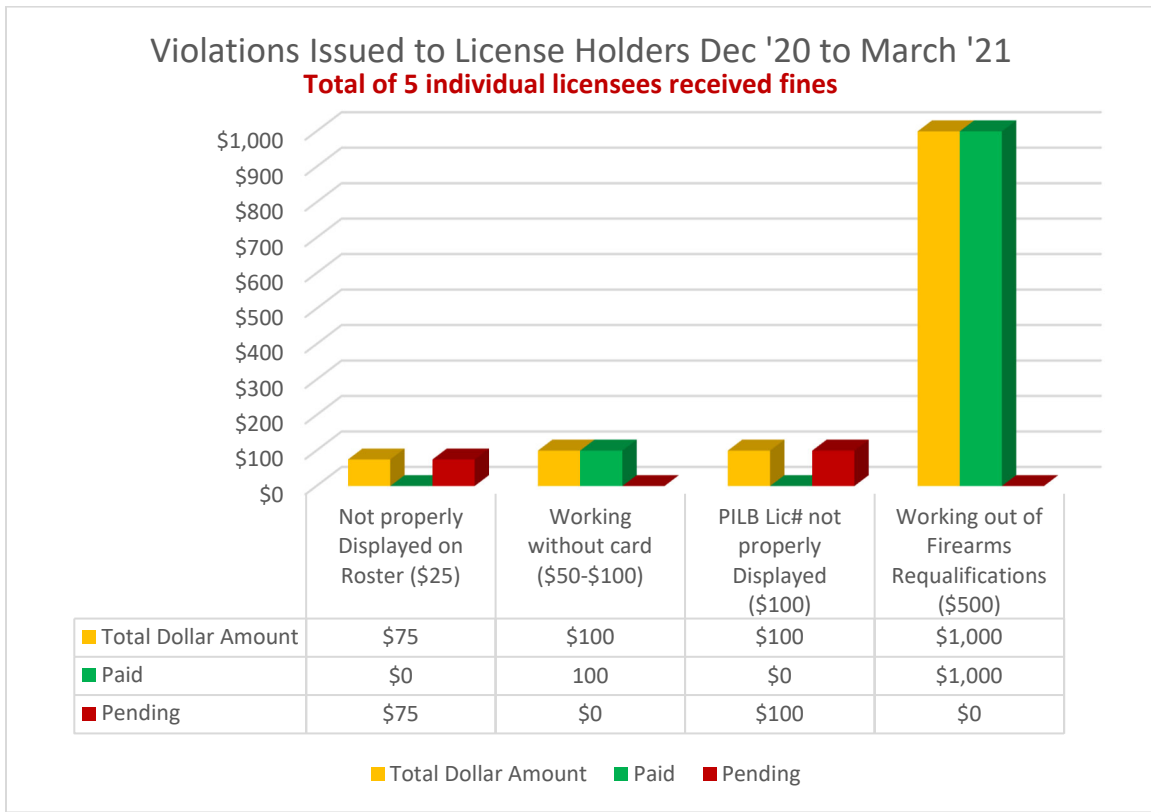

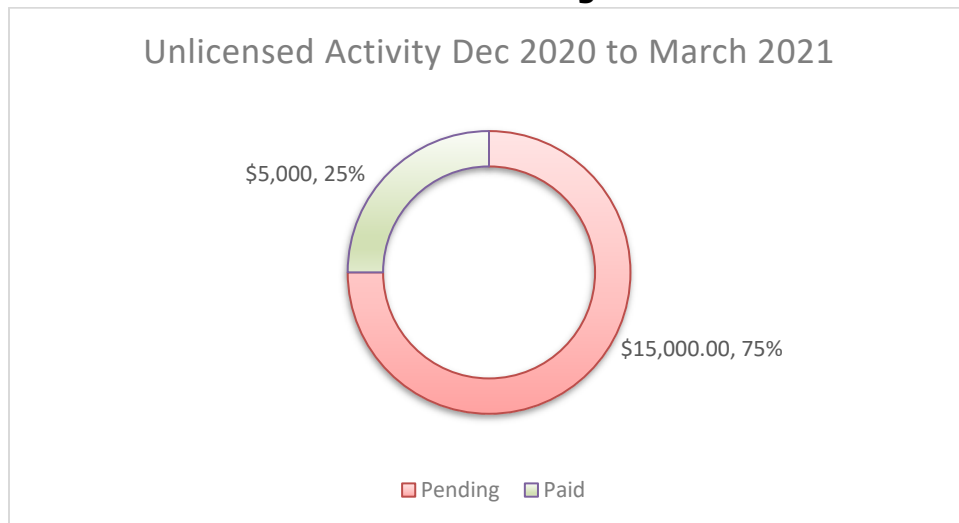

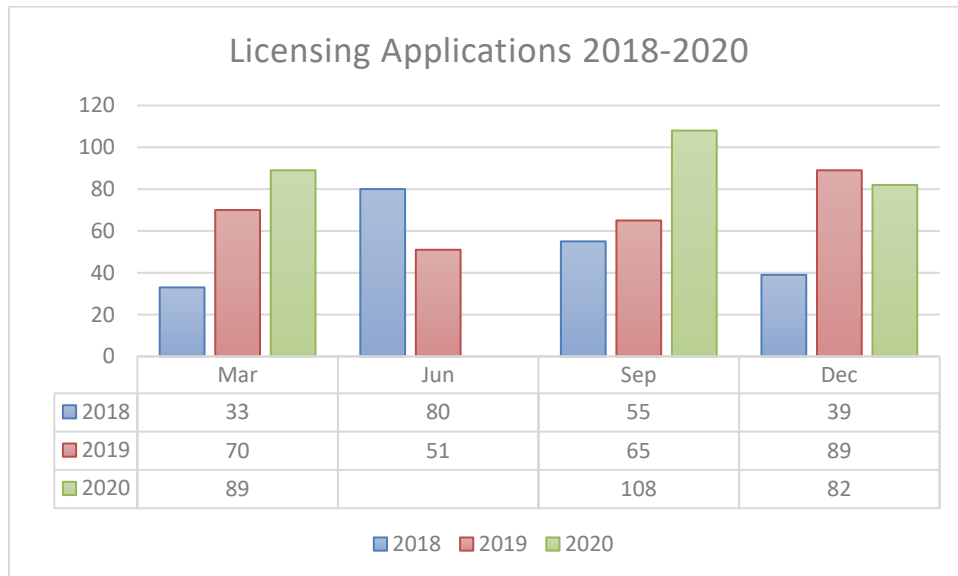

Total cards processed in 2018: 9,800

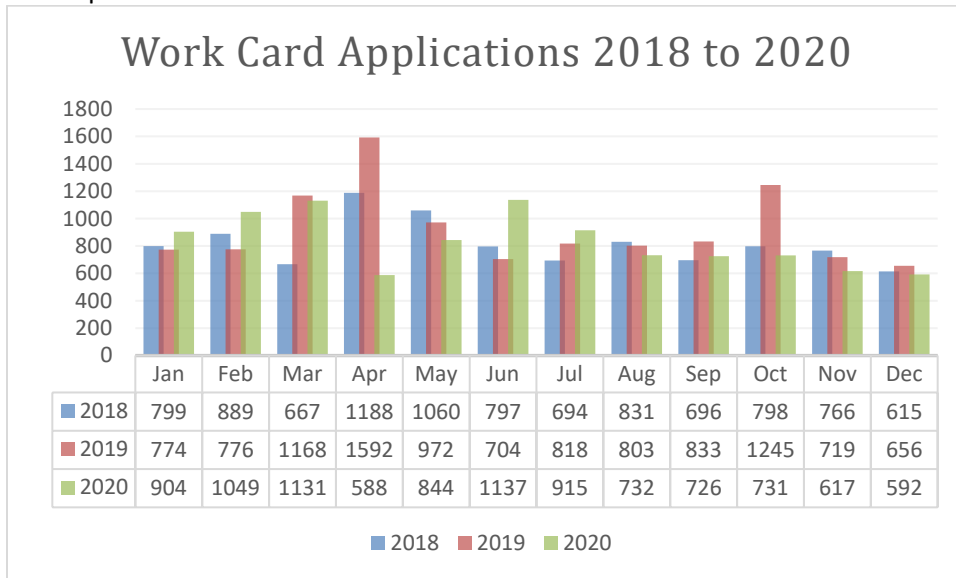
Total cards processed in 2019: 11,021
