3 BOARD CHAIR NIXON: So I'll go ahead and call the
4 meeting to order.

5 Executive Director, could you please do roll
6 call.

7 MR. INGRAM: Thank you, Madam Chair. We'll start
8 with Chair Nixon.

9 BOARD CHAIR NIXON: Here.

10 MR. INGRAM: Board Member Bezick?

11 BOARD MEMBER BEZICK: Here.

12 MR. INGRAM: Board Member Brown?

13 BOARD MEMBER BROWN: Here.

14 MR. INGRAM: Board Member Cortez?

15 BOARD MEMBER CORTEZ: Here.

16 MR. INGRAM: Board Member Gronauer?

17 BOARD MEMBER GRONAUER: Here.

18 MR. INGRAM: So all are present and accounted
19 for. We do have a quorum. We have counsel, Sophia Long from
20 the Attorney General's Office, representing the Board today.

21 BOARD CHAIR NIXON: Okay.

22 MR. INGRAM: Thank you.

23 BOARD CHAIR NIXON: Okay. So this is the section
24 where we'll entertain public comment. Members of the general
CAPITOL REPORTERS (775)882-5322

1 public may comment on matters appearing on the agenda or may
2 bring up matters not appearing on the agenda to the attention
3 of the Board.

4 The Board may discuss the matters not appearing
5 on the agenda but may not act on the matters at this meeting.
6 If the Board desires, the matters may be placed on future
7 agenda items or future meetings. Public comments may be
8 limited to five minutes per person at the discretion of the
9 Chairman. They will not be restricted according to
10 viewpoint.

11 So is there anybody down south that would like to
12 have public comment? Okay. Seeing there's no public
13 comment, is there any public comment up in the north?

14 BOARD MEMBER BROWN: No, ma'am.

15 BOARD CHAIR NIXON: So hearing there's no public
16 comment we'll move on. The next agenda item is --

17 MR. INGRAM: Mr. Welin, are you on the phone?
18 Nils Welin?

19 MR. WELIN: Yes.

20 MR. INGRAM: Excellent. Okay. So he is on the
21 phone. This is item number 15, the carryover from yesterday,
22 where the Board has questions for him.

23 BOARD CHAIR NIXON: Okay. So before we get
24 started, I'm going to have Counsel Long go ahead and swear

1 everybody in.

2 MS. LONG: Mr. Welin, will you please raise your
3 right hand and let me know when you've done so.

4 MR. WELIN: I've done so. Yes.

5 (Whereupon, the oath was administered.)

6 MS. LONG: Great. Thank you.

7 BOARD CHAIR NIXON: Thank you, sir, for calling
8 in. We appreciate it. We had -- some of the Board Members
9 had questions on your application.

10 Board, are there any questions for Mr. Welin?

11 MR. INGRAM: For those that are calling in, if
12 you're not speaking please mute your phone. Thank you.

13 BOARD CHAIR NIXON: Sorry. Please hold. We're
14 looking up some questions.

15 BOARD MEMBER GRONAUER: Mr. Welin?

16 MR. WELIN: Yes.

17 BOARD MEMBER GRONAUER: Okay. This is
18 Commissioner Gronauer. I just have a couple of questions for
19 you, please. Do you have a license now?

20 MR. WELIN: Can you be more specific.

21 BOARD MEMBER GRONAUER: A license in Nevada for
22 whatever your business is going to be or want it to be.

23 MR. WELIN: Yeah, I have a license that's in --
24 on hold right now.

1 BOARD MEMBER GRONAUER: In abeyance?

2 MR. WELIN: Yes.

3 BOARD MEMBER GRONAUER: Okay. So what do you
4 want to do with your license now?

5 MR. WELIN: I want to move to my new company that
6 I have and be able to operate in Nevada.

7 BOARD MEMBER GRONAUER: You don't operate in
8 Nevada now?

9 MR. WELIN: No, we do not.

10 BOARD MEMBER GRONAUER: Okay. So why do you want
11 to transfer -- I'm not understanding. Oh, from individual to
12 corporate. I got it. Okay. So now if you're -- do you have
13 any -- sorry for being a little bit back. Any business
14 license for the State of Nevada?

15 MR. WELIN: Yeah. I've applied for the licenses
16 needed to be able to operate in Nevada, yes.

17 BOARD MEMBER GRONAUER: No. No. A business
18 license from the State of Nevada, not from the Investigator's
19 Board, from the State of Nevada?

20 MR. WELIN: No. No. Yes. Yes, I do.

21 BOARD MEMBER GRONAUER: Okay.

22 MR. WELIN: I applied for -- huh?

23 BOARD MEMBER GRONAUER: Are you registered with
24 the Secretary of State?

1 MR. WELIN: Yes, I am. That's -- that was in my
2 package that I submitted.

3 BOARD MEMBER GRONAUER: Do you have a city or a
4 county business license?

5 MR. WELIN: Probably not at this point.

6 BOARD MEMBER GRONAUER: You don't have a business
7 license, a DBA for the city or the county?

8 MR. WELIN: No, because we haven't picked the
9 city where we're operating out of. But I'm a little confused
10 about the process because I'm following the steps that I've
11 been instructed from your -- from your staff to get this in
12 place. So I would be happy to answer any questions. But I'm
13 a little confused on why there's confusion.

14 MR. INGRAM: Madam Chair, if I could give a
15 little back history. Kevin Ingram for the record. So
16 Mr. Welin has been licensed with us for quite some time now.
17 He's currently not doing business in Nevada. He wants to
18 move into Nevada with a corporate license now. So he's
19 applying for his corporate license. He did apply for the
20 Nevada Secretary of State license. He was granted that.

21 He's coming before us today to change from an
22 individual to a corporation. And then once granted that then
23 he would move forward with his city and county licenses to be
24 able to operate in those jurisdictions.

1 So this is just to maintain compliance with our
2 laws right here in Nevada for him to transfer as an
3 individual to a corporation. He is in good standing.

4 BOARD MEMBER GRONAUER: I understand. Thank you.

5 MR. INGRAM: You bet. Thank you.

6 BOARD MEMBER GRONAUER: The thing is I think I'm
7 in a little fog here. That's all. In my notes I didn't have
8 it totally written out.

9 Okay. Thank you, Mr. Welin. Thank you for your
10 patience and calling in.

11 BOARD CHAIR NIXON: Are there any further
12 questions from the Board? Okay. If there's no further
13 questions I'll entertain a motion.

14 BOARD MEMBER GRONAUER: This is Gronauer. I'll
15 make the motion. I make the motion to grant ProGuard
16 Security Services applying for a new corporate private
17 patrolman license. If approved, Nils Welin, license number
18 1856 is requesting that his individual license be placed in
19 abeyance so that he may become a qualifying agent, member for
20 Nils Welin. This is subject to all statutory and regulatory
21 requirements is to approve it.

22 BOARD CHAIR NIXON: We have a motion. Do we have
23 a second?

24 BOARD MEMBER BROWN: Brown. Second.
 CAPITOL REPORTERS (775)882-5322

1 BOARD MEMBER CORTEZ: Cortez. I'll second the
2 motion.

3 BOARD CHAIR NIXON: Okay. I have a motion. I
4 have a second. All in favor say aye.

5 (The vote was unanimously in favor of the
6 motion.)

7 BOARD CHAIR NIXON: Okay. Motions passes. Thank
8 you very much, sir, for your patience. Congratulations.

9 MR. INGRAM: And, Mr. Welin, Shelly will be
10 reaching out to you to finalize all of this. And, again,
11 thank you for calling in while you're abroad. We greatly
12 appreciate it.

13 BOARD CHAIR NIXON: Okay. So will Counsel Long,
14 I think we need to swear in the rest of the group and then we
15 can get started on the work card appeals.

16 MS. LONG: So everyone in the audience, if you're
17 on the agenda today or will be providing testimony would you
18 please raise your right hand.

19 (Whereupon, the oath was administered.)

20 MS. LONG: And I will go one by one because we do
21 need an audible answer.

22 (Everyone answered in the affirmative.)

23 MS. LONG: Perfect. Thank you.

24 MR. INGRAM: For the record, Madam Chair, number
CAPITOL REPORTERS (775)882-5322

1 75 has been postponed. Item number 76 is recently deceased.
2 So that brings us to starting with agenda item 77.

3 BOARD CHAIR NIXON: Okay. So for now agenda item
4 number 77. Is Devonda Lawton here? Good morning. Go ahead
5 and thank you for coming in. Good morning.

6 MS. LAWTON: Thank you. Good morning.

7 BOARD CHAIR NIXON: Investigator Saladino, could
8 you tell us why we declined Ms. --

9 MS. LAWTON: Lawton.

10 BOARD CHAIR NIXON: -- Lawton's work card,
11 please.

12 INVESTIGATOR SALADINO: Investigator Saladino for
13 the record. We denied the applicant's work card for
14 failure -- failure to disclose a 2015 felony possession of a
15 schedule controlled substance out of Nevada where she
16 received five years probation. The applicant disclosed the
17 arrest. However, during the initial background the arrest
18 did not come up since it was out of Elko County, Nevada.

19 In 1999 there was a gross misdemeanor out of
20 Nevada for attempted receiving or transferring stolen
21 vehicle. She received three years probation, suspended jail
22 sentence, community service and restitution. The applicant
23 did disclose the arrest. The applicant received a
24 dishonorable discharge from probation on June 28th of '05.

1 In 2005, in February there was a misdemeanor for
2 petty larceny. She received credit for time served. That
3 was also out of Nevada. I misspoke earlier. These were all
4 disclosed. However, being that it was out of Elko County,
5 Clark County doesn't pick it up when we run the initial
6 background. So once we got the fingerprints back that's when
7 we started conversations trying to figure out if it was a
8 felony, in fact. And the applicant was very helpful with it.

9 BOARD CHAIR NIXON: Okay. Board, are there any
10 questions for Ms. Lawton?

11 MS. LAWTON: Lawton, like Oklahoma, Lawton.

12 BOARD CHAIR NIXON: This is Board Member Cortez.
13 Investigator Saladino, you indicated that they were all
14 disclosed. I have the 2015 but it was disclosed?

15 INVESTIGATOR SALADINO: Yes, that is correct.

16 BOARD MEMBER CORTEZ: Okay. And I have 2005, but
17 it was not disclosed. So per your testimony they were all
18 disclosed?

19 INVESTIGATOR SALADINO: Yes, they were all
20 disclosed.

21 BOARD MEMBER CORTEZ: So a typo.

22 INVESTIGATOR SALADINO: Correct.

23 BOARD MEMBER CORTEZ: Got it. Thank you.

24 BOARD MEMBER GRONAUER: Good morning, Ms. Lawton.
 CAPITOL REPORTERS (775)882-5322

1 MS. LAWTON: Good morning.

2 BOARD MEMBER GRONAUER: How are you doing?

3 MS. LAWTON: I'm good.

4 BOARD MEMBER GRONAUER: What do you do now?

5 MS. LAWTON: Right now I'm not doing anything.

6 I'm a stay-at-home mother for a four-year-old.

7 BOARD MEMBER GRONAUER: What are you planning on
8 doing with your work card?

9 MS. LAWTON: Working. I was working until it was
10 denied. Like, I had a temporary provision card.

11 BOARD MEMBER GRONAUER: Okay.

12 MS. LAWTON: And I was working with the company
13 until they stopped it. And once they stopped it they let me
14 go. Once I am granted, if I am granted this opportunity I
15 will continue to better my life. A lot of things have
16 happened in the past, and some of the things I'm not proud
17 of. I lost a lot of people, and now it's only me and my
18 children. So I have to stand firm and move forward if
19 possible.

20 BOARD MEMBER GRONAUER: Have you been in any
21 trouble at all since 2015?

22 MS. LAWTON: No, sir.

23 BOARD MEMBER GRONAUER: Your work, are they going
24 to hire you back or be hired somewhere else?

CAPITOL REPORTERS (775)882-5322

1 MS. LAWTON: I will be hired there and I have
2 other obligations, I mean opportunities as well.

3 BOARD MEMBER GRONAUER: Okay.

4 MS. LAWTON: Thank you.

5 BOARD CHAIR NIXON: Are there any other questions
6 for Ms. Lawton? Okay. If there's no further questions I'll
7 entertain a motion.

8 BOARD MEMBER CORTEZ: This is Board Member
9 Cortez. I'm motioning to grant the appeal and overturn the
10 denial for Ms. Lawton and grant her the work card.

11 BOARD CHAIR NIXON: I have a motion. Do I have a
12 second?

13 BOARD MEMBER BROWN: Brown will second.

14 BOARD CHAIR NIXON: I have a motion. I have a
15 second. All in favor say aye.

16 (The vote was unanimously in favor of the
17 motion.)

18 BOARD CHAIR NIXON: Congratulations, ma'am.

19 MS. LAWTON: Thank you guys so much.

20 BOARD MEMBER GRONAUER: Good luck to you.

21 BOARD CHAIR NIXON: Yeah, good luck. The PILB
22 will get in contact with you for the next steps, okay.

23 Agenda item number 78 is Mr. Ricky O'Neal. Okay.
24 We'll trail that.

1 Okay. You know what throws me is I can see us in
2 that little square so I think it's up north.

3 Okay. Item number 79, Christopher Purdum. I'm
4 sorry. We're trailing 78. Christopher Purdum? Okay. We'll
5 trail number 79 as well.

6 And you said 80, oh, 80 is here.

7 MR. INGRAM: 80 is here.

8 BOARD CHAIR NIXON: Agenda item number 80, Jamell
9 Jenkins. Are you here, sir?

10 MR. JENKINS: Yes.

11 BOARD CHAIR NIXON: Come on up.

12 So I guess, Investigator Saladino, you are up
13 again. Why did we decline Mr. Jenkins' guard card?

14 INVESTIGATOR SALADINO: Investigator Saladino for
15 the record. The applicant was denied for a failure to
16 disclose numerous arrests. We got a 2017 out of Nevada, a
17 gross misdemeanor for attempt carrying a concealed firearm or
18 other deadly weapon. He received nine months in CCDC
19 suspended. Two years probation.

20 The applicant was arrested on 3-23 of '18 for a
21 probation violation. Probation was revoked on 5-17 of '18.
22 The applicant did provide court documents for this case.

23 2021, in October in Nevada was a felony for
24 obtain or possess credit or debit card without cardholder's
CAPITOL REPORTERS (775)882-5322

1 consent and theft. This case is ongoing. This case was
2 filed on the September 27th of 2021 and was for an incident
3 that happened in August 4th of '19. The case is currently
4 going back to court on 2-7 of '22.

5 The applicant, his condition of release is
6 electronic monitoring for medium status. There's also a
7 2021, June in Nevada for felony possess or own a gun by a
8 prohibited person. This was filed in the North Las Vegas
9 Court with no charges filed.

10 2021, in June, again in Nevada, gross misdemeanor
11 for conspiracy to commit larceny. The applicant was
12 convicted and sentenced to credit for time served. He did
13 provide court documents for this case as well.

14 2020, in December there was a dismissal for a
15 solicit to promote or distribute imitation controlled
16 substance and disorderly conduct. The D.A. denied all
17 counts.

18 2020, in November, there was a felony dismissed
19 for possess or sale, schedule one and obstructing of a public
20 officer. The D.A. denied all counts.

21 March 8th of 2020 there was a misdemeanor
22 conviction for petty larceny. Convicted. Stay out of
23 trouble. Did 25 hours of community service in lieu of fine.
24 The original charge was grand larceny. On 7-7 of '21 the
CAPITOL REPORTERS (775)882-5322

1 case was closed with a note the defendant did not stay out of
2 trouble.

3 February of 2020, misdemeanor possession of
4 controlled substance. Convicted and sentenced to time
5 served. The D.A. dismissed the two and three counts for
6 possession of a schedule one and buying or receiving stolen
7 property.

8 2019, misdemeanor trespass, not amounting to
9 burglary. Credit for time served.

10 2019, in October, misdemeanor trespass not
11 amounting to burglary. The D.A. denied that charge.

12 2012, misdemeanor possession of marijuana. Was
13 convicted. This was prior to his first work card being
14 assigned. The applicant was arrested for warrants on this
15 case on June 28th of '13 and 10-21 of '14. And, yes, all
16 these were not disclosed.

17 BOARD CHAIR NIXON: Thank you.

18 Board, are there any questions for Mr. Jenkins?

19 BOARD MEMBER GRONAUER: Good morning,
20 Mr. Jenkins.

21 MR. JENKINS: Hey, good morning.

22 BOARD MEMBER GRONAUER: This is Gronauer. Did
23 you graduate high school?

24 MR. JENKINS: No. I received my GED.
CAPITOL REPORTERS (775)882-5322

1 BOARD MEMBER GRONAUER: You did receive your GED?

2 MR. JENKINS: Yeah.

3 BOARD MEMBER GRONAUER: So you read and write?

4 MR. JENKINS: Correct. Yes.

5 BOARD MEMBER GRONAUER: Did you read the
6 application?

7 MR. JENKINS: Yes. I was under the impression
8 that like because I have zero felony convictions. In terms
9 -- that's why the D.A. haven't filed that felony weapon
10 because I'm not a felon. They made a mistake. So I was
11 under the impression that, you know, because I come from
12 California and their rules are if you're a convicted felon
13 you disclose that. Anything else other than that is pretty
14 much you got a chance at getting your card.

15 So I wasn't maliciously not trying to disclose
16 it. I just, I know I have zero felony convictions. So
17 that's why I didn't disclose them. I've had my work card in
18 the state. I received it in 2016 and it just expired in
19 2021. So that's the reason why I didn't disclose them
20 because I thought that it was just strictly felony
21 convictions, and I have zero felony convictions.

22 BOARD CHAIR NIXON: So, sir?

23 MR. JENKINS: Yes.

24 BOARD CHAIR NIXON: If you can indulge me.
CAPITOL REPORTERS (775)882-5322

1 MR. JENKINS: Yes.

2 BOARD CHAIR NIXON: And for everybody else that's
3 here, I'm going to read out, it's bolded and highlighted now
4 in red.

5 MR. JENKINS: Yeah.

6 BOARD CHAIR NIXON: It says list all charges
7 regardless of how long ago the incident occurred. If you do
8 not recall the exact date then approximate date, so all. It
9 doesn't say felonies. It says all. List all charges
10 regardless if they were expunged, dismissed or denied. So
11 that's, you know, all.

12 MR. JENKINS: Right.

13 BOARD CHAIR NIXON: All charges regardless if
14 they were dismissed or reduced under California C1203.4. All
15 charges regardless of which state you put in. All charges
16 and citations regardless of if you were placed in handcuffs.
17 So, and I can continue because we tried to cover everything.

18 MR. JENKINS: Right.

19 BOARD CHAIR NIXON: So as the licensing Board we
20 don't want to waste your time and money.

21 MR. JENKINS: Right.

22 BOARD CHAIR NIXON: And we don't want to waste
23 ours. You'll only be denied if it's a felony or if it's a
24 weapons charge, right.

1 MR. JENKINS: Right.

2 BOARD CHAIR NIXON: That's one of the big ones
3 that get denied. But not disclosing is an automatic. You
4 don't get it.

5 So I just want to make sure it's clear to
6 everybody here. You have to disclose. It doesn't matter
7 when it happened. That's my soapbox moment.

8 But anybody else have any questions?

9 BOARD MEMBER GRONAUER: I have -- I have to
10 finish up, Madam Chair.

11 BOARD CHAIR NIXON: Okay.

12 BOARD MEMBER GRONAUER: You applied for this work
13 card --

14 MR. JENKINS: Yes.

15 BOARD MEMBER GRONAUER: -- August 17th.

16 MR. JENKINS: Yes.

17 BOARD MEMBER GRONAUER: Okay. And then you got
18 arrested October.

19 MR. JENKINS: Yes.

20 BOARD MEMBER GRONAUER: In '21, August.

21 MR. JENKINS: Yeah. It was for charges that
22 happened prior to this. They just eventually filed the
23 complaint. So it made it seem like I just keep getting in
24 trouble but it's just they filed the complaint.

1 BOARD MEMBER GRONAUER: Okay. That's enough.
2 But what I'm trying to get at, okay, you were arrested for
3 that. And it says it was -- it happened in 19 -- in 2019, I
4 get that, okay. But, again, I'll just reiterate, okay, as
5 far as we have to read what you have to do on the
6 application. And I think Madam Chair said it correct, want's
7 to save you money, the applicant, wants to save time and
8 effort for everybody.

9 So the idea to me is that it was very well
10 written, you should do, you shouldn't do. And saying I came
11 from California. This is what California does. This is not
12 California. This is Nevada. You seem like you're quite
13 intelligent. So I just can't go over it. So that's all.
14 You don't have to explain anything else. I'm just giving the
15 background there. Thank you.

16 BOARD CHAIR NIXON: Are there any other Board
17 questions?

18 Okay. If there's no other questions I'll
19 entertain a motion.

20 BOARD MEMBER BROWN: This is Board Member Brown.
21 I move to --

22 BOARD CHAIR NIXON: Sorry.

23 BOARD MEMBER BROWN: I'm sorry? Am I good to go?

24 BOARD CHAIR NIXON: You're good to go. Sorry
CAPITOL REPORTERS (775)882-5322

1 about that.

2 BOARD MEMBER BROWN: Okay. I move that we uphold
3 the denial for failure to disclose and also because we have
4 one felony case that's still ongoing.

5 BOARD CHAIR NIXON: Okay. I have a motion. Do I
6 have a second?

7 BOARD MEMBER GRONAUER: Gronauer. Second.

8 BOARD CHAIR NIXON: I have a motion. I have a
9 second. All in favor say aye.

10 (The vote was unanimously in favor of the
11 motion.)

12 BOARD CHAIR NIXON: And when your cases are done
13 and they're cleaned up, if you want to come back and apply,
14 please get a list from the PILB of all of the stuff that's on
15 there and they will help, right. So sit down with them.
16 They will help you get through this, okay.

17 MR. JENKINS: All right.

18 BOARD CHAIR NIXON: All right. Thank you, sir.

19 Item number 81, Andre Moore. We'll trail 81.

20 Item number 82, Patrice Burnley. Good morning.

21 Since people are walking in, I'm going to ask
22 you, are you under oath?

23 MS. BURNLEY: Me?

24 BOARD CHAIR NIXON: Yeah. Have you been sworn
CAPITOL REPORTERS (775)882-5322

1 in?

2 MS. BURNLEY: Yes.

3 BOARD CHAIR NIXON: Okay. So, Investigator
4 Saladino, why did we decline her work card?

5 INVESTIGATOR SALADINO: Investigator Saladino for
6 the record. The applicant was denied for a 2015 felony,
7 cruelty to child with possible injury or death, obstruct or
8 resist executive officer, DUI and traffic related. Received
9 five years probation. The probation was completed early on
10 May 16th of 2018. The applicant was also granted a 1203.4,
11 17 (b) reduction and dismissal on this case on September 18th
12 of 2019.

13 There was a 2011 misdemeanor vandalism and
14 obstruction. This case was dismissed by the courts.

15 2008 there was, April, out of California a
16 misdemeanor DUI and with drugs and DUI with alcohol. Count
17 One was dismissed. And on Count Two she received 36 months
18 probation for the DUI.

19 The applicant did disclose this on her
20 application. She also stated in her appeal that she's been
21 clean and sober for five years and seven months and that's
22 why we're here for the appeal.

23 BOARD CHAIR NIXON: Thank you.

24 Board, are there any questions?
CAPITOL REPORTERS (775)882-5322

1 BOARD MEMBER BROWN: This is Board Member Brown.
2 Ma'am, can you give us a description of what the 2015 felony
3 charge was for child cruelty.

4 MS. BURNLEY: Yes, sir. So in 2015, I believe it
5 was in March, I actually recently reunited with my birth
6 family. And my older sister had two kids. She was homeless.
7 We actually ended up living in the same city. One night I
8 got a phone call from her and her and the kids were on the
9 side of the road. And I was at a friend's house at a
10 barbecue. I let her know I had been drinking. Of course we
11 were there all day.

12 And she had called a couple of people. I ended
13 up getting someone to take me over to where they were
14 located, and she was extremely tired and I get in the car and
15 told her, you know, I'll drive. We actually went to go to a
16 friend's house who was literally two blocks down to the
17 right. Of course, giving them a call first, letting them
18 know the situation.

19 And so instead of her driving, now mind you, they
20 came from Sacramento down to Solano, the Fairfield Solano
21 County area. And she had already I guess fell asleep on the
22 road and hit the side -- her side mirror was missing, things
23 like that. So, of course, being put in that situation I had
24 a choice to make, and I chose to drive them to a friend's

CAPITOL REPORTERS (775)882-5322

1 house. And by the time I made it to the light I was pulled
2 over. Once pulled over, you know, I definitely complied in
3 every way.

4 The -- the charge for I guess it was like they
5 tried to give me child endangerment but it did not get filed
6 against me until two months later because we ended up getting
7 pulled over again but for no reason. My sister was actually
8 driving her car. Her two kids were in the back. And the
9 officer came up and said I'm going to file child endangerment
10 against you. At that point he asked for their names and in
11 that course that was filed against me.

12 BOARD MEMBER BROWN: Thank you.

13 MS. BURNLEY: Thank you.

14 BOARD CHAIR NIXON: What are you currently doing?

15 MS. BURNLEY: I currently work a couple of
16 part-time jobs. I also own a record label. I'm an
17 entertainer, a mentor. I'm currently still in my sobriety.
18 I also, I run and design graphic arts and marketing for
19 different companies in Nevada. I've been here a year as a
20 couple of days ago. And I work also part-time as a cashier.
21 I do -- I do music constantly. I write. I work with
22 programs that are still with my hometown in San Diego,
23 building things around music for children, youth.

24 My sobriety and this, this happening in 2015,
CAPITOL REPORTERS (775)882-5322

1 completely changed my life. Knowing that when odds are
2 against you and you make choices sometimes you have to own
3 them. And, you know, I literally got sentenced a year. And
4 I was not expecting that, a county year. And because I was
5 homeless myself because of that situation, the judge sat me
6 down. I spent almost seven months and that whole time I
7 chose to try to stay in solitude because literally there was
8 no way around it honestly. There was no way around it.

9 Yes, I had alcohol in my system and yes, I knew
10 that before even going there. I absolutely did. I did not
11 try to fight the case. What I did try to do is tell the
12 truth. My public defender let the Court know. They showed
13 video. They said she was driving absolutely correct. You
14 wouldn't have even know she was drunk. She signaled, did not
15 crash, pulled over.

16 And just to be honest, you know, it's not about a
17 race thing for me. I never played the race card. It's not.
18 Some people are just very frustrated and they want to get you
19 to a point that they have a reason, you know, and I'm not one
20 of those people. I don't like to give you a reason. I would
21 rather protect myself.

22 So this took off to a place that I ended up
23 having three years probation, 18 months DUI, 52 weeks
24 parenting class. And I did every single one of them. And I

1 paid all my restitution. And still to this day I have not
2 even been in contact with a police officer.

3 BOARD CHAIR NIXON: Fantastic. Thank you.

4 MS. BURNLEY: Thank you.

5 BOARD CHAIR NIXON: Any further questions for the
6 Board? Hearing no further questions I'll entertain a motion.

7 BOARD MEMBER CORTEZ: This is Board Member
8 Cortez. First and foremost, congratulations on your
9 sobriety. I know --

10 MS. BURNLEY: Thank you so much.

11 BOARD MEMBER CORTEZ: -- that that is difficult
12 to overcome.

13 MS. BURNLEY: Yes.

14 BOARD MEMBER CORTEZ: I encourage you to stay on
15 that path. For that reason I am going to motion that we
16 grant the appeal and overturn the denial for Ms. Burnley and
17 grant her the work card.

18 MS. BURNLEY: Thank you very much.

19 BOARD CHAIR NIXON: Hang on. We have to vote on
20 it.

21 MS. BURNLEY: Okay.

22 BOARD CHAIR NIXON: I have a motion. Do we have
23 a second?

24 BOARD MEMBER BEZICK: This is Bezick. I second.
CAPITOL REPORTERS (775)882-5322

1 BOARD MEMBER GRONAUER: Gronauer. I second.

2 BOARD CHAIR NIXON: Okay. I have a motion. I
3 have a second. All in favor say aye.

4 (The vote was unanimously in favor of the
5 motion.)

6 BOARD CHAIR NIXON: Thank you for being
7 transparent on your application. Good luck to you.

8 MS. BURNLEY: Thank you so much.

9 BOARD MEMBER GRONAUER: You're the example. I'm
10 just going to put this on. You're an example what we like to
11 see. You put the paperwork together. You get with the
12 investigators. You get this squared away because what we see
13 on paper is not always what it is.

14 MS. BURNLEY: Absolutely.

15 BOARD MEMBER GRONAUER: Okay. But that's all we
16 have to go on.

17 MS. BURNLEY: Yes.

18 BOARD MEMBER GRONAUER: So and in the environment
19 in the music industry and everything else it's even harder to
20 stay on that straight path.

21 MS. BURNLEY: It is.

22 BOARD MEMBER GRONAUER: It just is. It's the
23 environment.

24 MS. BURNLEY: It is.

CAPITOL REPORTERS (775)882-5322

1 BOARD MEMBER GRONAUER: So I applaud you for
2 that. You're going to have to keep walking that straight
3 line. It's hard.

4 MS. BURNLEY: Yes. Yes.

5 BOARD MEMBER GRONAUER: God bless you.

6 MS. BURNLEY: Thank you so much.

7 BOARD CHAIR NIXON: Thank you.

8 Item number 83, Marvin Rogers. Is Marvin Rogers
9 here? Okay. We'll trail that one.

10 Item number 84, Rodney Hymon.

11 MR. HYMON: Hymon.

12 BOARD CHAIR NIXON: Hymon, okay. Sorry about
13 that.

14 MR. HYMON: Good morning, everyone.

15 BOARD CHAIR NIXON: Good morning.

16 Officer Saladino, excuse me, Investigator
17 Saladino, can you list why we declined.

18 INVESTIGATOR SALADINO: Investigator Saladino for
19 the record. Madam Chair, there's quite an extensive arrest
20 history here. The ones that did get him denied was the 2011
21 felony for trafficking in cocaine. That was in Nevada. He
22 received a sentence, a minimum of 12 months to 30 months with
23 Nevada Department of Corrections. This ran concurrent with
24 another case. It looks like he was released from prison on
CAPITOL REPORTERS (775)882-5322

1 2-17 of '13.

2 2008, it was a felony possession, unlawful
3 possession of controlled substance, not for sale, ex-felon in
4 possession of a firearm, altered serial number. The
5 applicant was hit with a probation violation on 2-15 of '11.
6 The probation was revoked on 5-5 of '11. And the applicant
7 was sent back to prison and released on that February date.

8 And they continue to go. Do you want me to
9 continue reading them or?

10 BOARD CHAIR NIXON: Board, are there any
11 questions for Mr. Hymon?

12 BOARD MEMBER GRONAUER: This is Gronauer. Good
13 morning, Mr. Hymon.

14 MR. HYMON: Good morning, sir.

15 BOARD MEMBER GRONAUER: I appreciate you
16 disclosed all that.

17 MR. HYMON: Yes, sir.

18 BOARD MEMBER GRONAUER: That was a big deal. Now
19 you were released in 2013.

20 MR. HYMON: Yes, sir.

21 BOARD MEMBER GRONAUER: Okay. That was Nevada.

22 MR. HYMON: Yes, sir.

23 BOARD MEMBER GRONAUER: Department of
24 corrections?

CAPITOL REPORTERS (775)882-5322

1 MR. HYMON: Yes, sir.

2 BOARD MEMBER GRONAUER: Since then what have you
3 been doing?

4 MR. HYMON: Since then -- since I've been out I
5 have been back to work in public service. I was a manager up
6 there, head lead line --

7 BOARD MEMBER GRONAUER: I can't understand you.

8 MR. HYMON: I said I was in public service. I
9 was the head lead. I stayed there for probably maybe about
10 seven months. And then after that there I end up going to
11 the doctor and finding out about I'm a diabetes and my bullet
12 wounds and everything where I got shot back in 2006. So they
13 completely put me on permanent disability.

14 So at that time so I've just been laying around
15 just trying to, you know, do little odds and ends at work I
16 can. You know what I'm saying, trying to keep something
17 coming in to the household.

18 BOARD MEMBER GRONAUER: What are you -- I'm sorry
19 to cut you off but I got it.

20 MR. HYMON: Well, my intention --

21 BOARD MEMBER GRONAUER: If you get approved what
22 do you plan to do?

23 MR. HYMON: Well, if I get approved my intention
24 is right now I see that there's a lot of positions to open up
CAPITOL REPORTERS (775)882-5322

1 for security work. And I'm not going to sit here and lie to
2 you because I'm a man of God now. I preach the word now for
3 Gospel Temple of Jesus Christ.

4 I'm not going to lie to you. I had a couple of
5 guys that has their own company. They pulled me to the side
6 and had me work for them doing security work. And a lot of
7 people that I work for have called me back. And I let them
8 know and explain to them I do not have a guard card. I'm
9 trying to work on getting that. You know what I'm saying.
10 Once I get that then I can be able to come back and work for
11 you guys at your banquet halls and special entertainments and
12 special events for kids and stuff like that. So and then
13 I've just been maintaining.

14 BOARD MEMBER GRONAUER: You're looking at armed
15 or unarmed?

16 MR. HYMON: Unarmed. No armed. Unarmed. I want
17 to stay like I am, unarmed.

18 BOARD MEMBER GRONAUER: How long have you been
19 clean?

20 MR. HYMON: How long have I been clean? What ya
21 mean clean?

22 BOARD MEMBER GRONAUER: With drugs.

23 MR. HYMON: I haven't used no drugs. If you want
24 to you can piss me right now, do whatever you want to.

CAPITOL REPORTERS (775)882-5322

1 BOARD MEMBER GRONAUER: No. No.

2 MR. HYMON: I haven't used no drugs. I haven't
3 -- to be honest I haven't used no drugs. I haven't been on
4 no drugs since 1983. 1993 I was a cocaine -- I was on
5 cocaine. I'm going to admit I did catch a DUI not too long
6 ago back in 2001, but I haven't had alcohol to drink since
7 then.

8 BOARD MEMBER GRONAUER: Okay. Congratulations.

9 BOARD CHAIR NIXON: So I just wanted to confirm,
10 I did notice in your application that you noted the felonies
11 but you did not disclose the misdemeanors.

12 Investigator Saladino, is that correct?

13 INVESTIGATOR SALADINO: Give me a second to
14 check.

15 MR. HYMON: I paid all that stuff off.

16 BOARD MEMBER CORTEZ: Madam Chair, can I ask a
17 question?

18 BOARD CHAIR NIXON: Sure.

19 BOARD MEMBER CORTEZ: This is Board Member
20 Cortez. Mr. Hymon, question. You indicated that you've been
21 sober. What was the 2020 DUI?

22 MR. HYMON: The 2020 DUI?

23 BOARD MEMBER CORTEZ: One count.

24 MR. HYMON: 2020 DUI, let me think back on that.
CAPITOL REPORTERS (775)882-5322

1 I think that was -- wasn't that -- let me think.

2 BOARD MEMBER CORTEZ: Alcohol or drugs?

3 MR. HYMON: That was alcohol. Alcohol. Alcohol.

4 BOARD MEMBER CORTEZ: Alcohol again for the 2009
5 conviction.

6 MR. HYMON: 2009, that's the misdemeanor, right?

7 BOARD MEMBER CORTEZ: Correct.

8 MR. HYMON: That had to be for a DUI too. I
9 think on my record it should show about three DUI's that got
10 all got broke back down to two DUI's or back down to a number
11 one. Everything has been paid off and time served for
12 everything.

13 BOARD MEMBER CORTEZ: Thank you.

14 BOARD MEMBER BROWN: This is Board Member Brown.
15 Question for Investigator Saladino. On the arrest listed,
16 number 8, 2020 DUI, I want to confirm that there are, there
17 were charges although they were dismissed, there were charges
18 for possession of schedule one, two, three, four controlled
19 substances and use or under the influence of those same
20 controlled substances.

21 INVESTIGATOR SALADINO: Yes, that is correct.

22 And the court documents show that he was only convicted on
23 Count One for the DUI and sentenced to 120 days and a 685
24 dollar fine.

1 MR. HYMON: Exactly.

2 INVESTIGATOR SALADINO: Counts Two through Four
3 were dismissed. Madam Chair, to answer your question
4 earlier, the applicant, when he came in in August he did
5 disclose felony arrests. So he knew going into the
6 application that he was going to be denied.

7 BOARD CHAIR NIXON: Okay.

8 INVESTIGATOR SALADINO: We would, you know, go
9 ahead with the appeal process.

10 BOARD CHAIR NIXON: Okay. So then you guys work
11 through after the -- the admission of the felonies you worked
12 through the actual misdemeanors?

13 INVESTIGATOR SALADINO: Correct.

14 BOARD CHAIR NIXON: Okay. Got it, okay.

15 Any further questions from the Board? Hearing no
16 further questions I'll entertain a motion.

17 BOARD MEMBER BEZICK: This is Bezick. I move to
18 overturn the denial and grant the work card.

19 MR. HYMON: Thank you, Lord.

20 BOARD CHAIR NIXON: I have a motion. Do I have a
21 second?

22 BOARD MEMBER GRONAUER: What's the motion?

23 BOARD CHAIR NIXON: He moved to grant the appeal.

24 BOARD MEMBER GRONAUER: Gronauer. I'll second.
CAPITOL REPORTERS (775)882-5322

1 BOARD CHAIR NIXON: I have a motion. I have a
2 second. All in favor say aye.

3 BOARD MEMBER BEZICK: Aye.

4 BOARD MEMBER GRONAUER: Aye.

5 BOARD MEMBER BROWN: Nay.

6 BOARD MEMBER CORTEZ: Nay.

7 BOARD CHAIR NIXON: So you have two ayes and one
8 -- I'm sorry, two ayes. No, I think --

9 MR. INGRAM: I have two ayes and three nays.

10 BOARD CHAIR NIXON: Okay. So two ayes and three
11 nays. That means unfortunately the motion doesn't pass. I'm
12 a nay because I think it's time and distance.

13 MR. HYMON: Uh-huh.

14 BOARD CHAIR NIXON: You know, clearly you have an
15 issue with substance abuse. And your last actual incident
16 with the law was in 2020. So for me it's a time and distance
17 issue.

18 MR. HYMON: So what's the time frame?

19 BOARD CHAIR NIXON: The time frame?

20 MR. HYMON: Yeah, what's the time frame?

21 BOARD CHAIR NIXON: Okay. So you can come back
22 and reapply in one year. You know, don't have any issues
23 with law enforcement. And for me that gives you a little bit
24 more time and distance. But you just had an incident in
CAPITOL REPORTERS (775)882-5322

1 2020. So it's a little too soon for me.

2 MR. HYMON: Okay, ma'am.

3 BOARD CHAIR NIXON: Thank you.

4 MR. HYMON: So do I have to be -- while I'm here,
5 since I went down to North Las Vegas Metro and got all my
6 police reports, I mean everything that happened. And all I
7 got a question to ask you. I'm not going to get in no more
8 trouble until next year this time and after next year this
9 time I'm not going to get in no trouble. The Lord blessed
10 me. I still have my health and strength with all the stuff
11 that's going on right now today in this world.

12 I just want to know, do I have to go back and put
13 all of the stuff I had on my application, everything all over
14 again?

15 BOARD CHAIR NIXON: Yes, sir. But they will have
16 your application and if you go and speak with them, they will
17 help you through that process.

18 MR. HYMON: Okay. Thank you.

19 BOARD CHAIR NIXON: Okay.

20 MR. HYMON: God bless you.

21 BOARD CHAIR NIXON: Thank you. Take care.

22 Okay. Agenda item number 85. Steven Gumbus, are
23 you in the room? Steven Gumbus, okay. We'll trail that.

24 Agenda item number 86, Barry Chapman. Barry
CAPITOL REPORTERS (775)882-5322

1 Chapman? Nope. Okay. We'll trail that. I'm sorry? No,
2 it's Barry Chapman? No. We'll trail that.

3 The next one is agenda item number 87, Mills,
4 Marquace Mills. Thank you, sir. Just to clarify, because
5 people have been walking in, are you under oath? Okay,
6 gotcha.

7 Investigator Saladino, will let us know why we
8 declined his work card.

9 INVESTIGATOR SALADINO: Investigator Saladino for
10 the record. The applicant was denied for failure to
11 disclose. In 2020, in August there was a felony arrest for
12 possession of a schedule one and or two counts of possession
13 to sell. D.A. did deny this case.

14 2017, it was a gross misdemeanor conspiracy to
15 commit a crime. Convicted. Sentenced to nine months in CCDC
16 and three years probation. And the case also started as a
17 possession of schedule one, two, three and for sale.

18 He did receive a probation violation on 7-20 of
19 '18. He was dishonorably discharged from probation on 1-22
20 of 2020.

21 2016, there was a misdemeanor possession of
22 drugs. He was convicted on Counts One, Three and Four which
23 was a false statement. And I can't see the other one.

24 2016, misdemeanor possession of drugs not for
CAPITOL REPORTERS (775)882-5322

1 sale. 60 days jail suspended and drug counseling.

2 2015 there was a felony, convicted for possession
3 of marijuana. There was a charge on there for possess or own
4 firearm by a prohibited person, domestic battery and
5 hindering or obstructing an officer.

6 When the applicant was arrested for the 2015
7 charge there was also five bench warrants for other cases.

8 2020 there was a felony arrest for possession or
9 sale of schedule one, two controlled substance. This was
10 denied by the D.A.

11 2017 in February in Nevada, gross misdemeanor
12 conspiracy to commit a crime. I'm sorry page two is
13 repeating itself over again.

14 BOARD CHAIR NIXON: Okay. Board, are there any
15 questions for Mr. Mills?

16 BOARD MEMBER CORTEZ: This is Board Member
17 Cortez. Mr. Mills, why did you fail to disclose?

18 MR. MILLS: I didn't read it all the way through.

19 BOARD MEMBER CORTEZ: Fair enough.

20 MR. MILLS: And I'm -- I'm in the process of
21 getting my record sealed right now.

22 BOARD MEMBER CORTEZ: Okay.

23 MR. MILLS: My record sealed. This is my SCOPE
24 right here. I have everything.

CAPITOL REPORTERS (775)882-5322

1 BOARD MEMBER CORTEZ: Okay. I heard you say
2 you're going to get your record sealed. But, again, should
3 you be denied, you do understand you need to disclose
4 everything regardless of what the status is of your criminal
5 history.

6 MR. MILLS: Uh-huh.

7 BOARD MEMBER CORTEZ: Clear understanding?

8 MR. MILLS: I understand now.

9 BOARD MEMBER CORTEZ: Perfect.

10 BOARD CHAIR NIXON: Okay. Any further questions
11 from the Board? Hearing no further questions I'll entertain
12 a motion.

13 BOARD MEMBER CORTEZ: This is Board Member
14 Cortez. I motion to uphold the denial based on failure to
15 disclose a number of those.

16 BOARD CHAIR NIXON: I have a motion. Do I have a
17 second?

18 BOARD MEMBER BROWN: This is Brown. I'll second.
19 Also for recency, time and distance.

20 BOARD CHAIR NIXON: I have a motion. I have a
21 second. All in favor say aye.

22 (The vote was unanimously in favor of the
23 motion.)

24 BOARD CHAIR NIXON: Okay. Motion to continue
CAPITOL REPORTERS (775)882-5322

1 with the denial of your work card. So unfortunately it did
2 not pass. You have an opportunity to work with PILB and come
3 and apply.

4 MR. MILLS: One year, okay. Thank you. Come
5 back and fill this all out.

6 BOARD CHAIR NIXON: Make sure you list
7 everything.

8 BOARD MEMBER CORTEZ: You still have to disclose.

9 MR. MILLS: Regardless?

10 BOARD CHAIR NIXON: Yep.

11 Item number 88, Timothy Baden?

12 BOARD MEMBER CORTEZ: Baden, B-a-d.

13 BOARD CHAIR NIXON: Okay. We'll trail that item.

14 BOARD MEMBER GRONAUER: Sir, why don't you sit up
15 front. You seem to have a hard time understanding us. Why
16 don't you sit up front here so you can hear, okay, because he
17 keeps asking. Thank you. I'm sorry.

18 BOARD CHAIR NIXON: Item number 89, Anthony Hues?
19 Anthony Hues? We'll trail number 89.

20 Number 90, Lui Taulua.

21 BOARD MEMBER CORTEZ: Taulua.

22 BOARD CHAIR NIXON: There we go. There we go.

23 BOARD MEMBER GRONAUER: I don't think he was
24 sworn in.

CAPITOL REPORTERS (775)882-5322

1 BOARD CHAIR NIXON: No. Yeah.

2 MR. INGRAM: We have several different. So
3 anyone that's here that's going to be speaking today, if you
4 have not already been sworn in, please stand. Raise your
5 right hand.

6 BOARD CHAIR NIXON: Mr. Taulua, you as well.
7 (Whereupon, the oath was administered.)

8 MS. LONG: Thank you.

9 BOARD CHAIR NIXON: Okay. You're good now.
10 Thank you.

11 Investigator Swarthout, can you please let us
12 know why we declined --

13 INVESTIGATOR SALADINO: Saladino.

14 BOARD CHAIR NIXON: Huh?

15 INVESTIGATOR SALADINO: Saladino.

16 BOARD CHAIR NIXON: Watching people walk in is a
17 mess. Okay. Go ahead. Sorry.

18 INVESTIGATOR SALADINO: Investigator Saladino for
19 the record. The applicant was denied for disclosure. He did
20 disclose a 2006 felony out of Hawaii for bail jumping. He
21 was sentenced to five years in prison for this.

22 2006, promote dangerous drugs.

23 1996, felony robbery. Felon, firearm possession.

24 Convicted on all counts and was sentenced to 20 years in
CAPITOL REPORTERS (775)882-5322

1 prison.

2 The applicant did disclose this. There was one
3 parole violation in December 7th of '06.

4 2006 there was a false impersonate. It showed up
5 on the fingerprints but there was no -- no record of it in
6 the courts.

7 In 2006, carried a deadly weapon. The
8 prosecution declined to prosecute. And that's it.

9 BOARD CHAIR NIXON: So is this the same where you
10 got the original felonies that declined and then the rest of
11 them because I see -- this is a repeat. I see from six --
12 from -- I'm sorry, from '05 through the end the disclosed was
13 no.

14 INVESTIGATOR SALADINO: That's correct. But we
15 had disclosure on the felony. So we knew we weren't going to
16 issue the provisional and that's when we worked with the
17 applicant to make sure we had the arrest history noted
18 correctly.

19 BOARD CHAIR NIXON: Okay, perfect.

20 Are there any questions for, I'm going to call
21 you Mr. T. Sorry. Are there any more questions for Mr. T?

22 BOARD MEMBER BROWN: This is Board Member Brown.
23 And I know there's some confusion. I actually spoke with
24 Investigator Swarthout about this. For some reason there's a
CAPITOL REPORTERS (775)882-5322

1 duplicate of the charges on another page. But as I see it,
2 there was the felony bail jumping twice in 2006. It says
3 that he did not disclose that, as well as the drugs from
4 2006. There was the disclosure of the robbery. And then
5 false impersonation and carrying a deadly weapon. Those also
6 show disclosed on the report that I have, not disclosed on
7 the report that I have.

8 And then my question to Mr. T would be why did
9 you not disclose those particular charges?

10 BOARD CHAIR NIXON: So, Investigator Saladino, do
11 you want to answer the first part of that.

12 INVESTIGATOR SALADINO: That is correct the way
13 it's written on the report.

14 BOARD CHAIR NIXON: Okay. But --

15 INVESTIGATOR SALADINO: Yeah, we have disclosure
16 on the felony robbery --

17 BOARD CHAIR NIXON: Uh-huh.

18 INVESTIGATOR SALADINO: -- from 1996. Then the
19 other ones were not disclosed at the time of the application.

20 BOARD CHAIR NIXON: Did he do his application
21 on-line? I'm sorry. You need to answer Brown's, his first
22 question to you.

23 MR. TAULUA: Well --

24 BOARD CHAIR NIXON: Could you repeat your
CAPITOL REPORTERS (775)882-5322

1 question.

2 BOARD MEMBER BROWN: This is Board Member Brown
3 for the record. For, Mr. Taulua, why did you disclose some
4 but failed to disclose other felonies.

5 MR. TAULUA: With the robbery?

6 BOARD MEMBER BROWN: No. It shows that you
7 disclosed the robbery. There's two other felonies that I see
8 on here that were not disclosed other than the robbery. One
9 in 2006 involving the promotion of dangerous drugs, drug
10 paraphernalia, DUI, reckless driving. And then another in
11 '96. I'm sorry, there was another one in 2006 for bail
12 jumping. It looks like there's two counts. Those were not
13 disclosed. Why did you fail to disclose those?

14 MR. TAULUA: I was incarcerated at the time so I
15 don't know how --

16 BOARD CHAIR NIXON: So during your application it
17 asks you about all of your arrests. Did you -- why did you
18 disclose some of them but not all of them.

19 MR. TAULUA: I thought it all came together. I
20 got sentenced for that case right there. It was all into
21 one.

22 BOARD CHAIR NIXON: So what do you call --

23 MR. TAULUA: So I didn't know.

24 BOARD MEMBER BROWN: Were you -- were you in
CAPITOL REPORTERS (775)882-5322

1 prison in 2006?

2 MR. TAULUA: Yes.

3 BOARD MEMBER BROWN: Okay. So I guess my
4 question there is how did you get charged with felonies when
5 you were in prison, bail jumping and promotion of dangerous
6 drugs, DUI. I guess if you were in prison it's hard for you
7 to drive a car intoxicated. I'm a little confused. And you
8 may not be able to explain it. I don't know if Investigator
9 Saladino can explain it.

10 MR. TAULUA: It might have been because I was
11 incarcerated in '94 when this happened, when this case
12 happened. '95 I went in. I got sentenced in '96. I did
13 almost ten years. I got out. And I went back in for -- for
14 the same thing. So violation of the parole. The DUI was
15 in -- was in L.A.

16 BOARD CHAIR NIXON: So in 2006 or 2005 were you
17 on parole?

18 MR. TAULUA: I was incarcerated.

19 BOARD CHAIR NIXON: You were incarcerated.

20 MR. TAULUA: Yes.

21 BOARD CHAIR NIXON: When were you on parole?

22 MR. TAULUA: In 2002.

23 BOARD CHAIR NIXON: You were on parole in 2002.

24 BOARD MEMBER CORTEZ: This is Board Member
CAPITOL REPORTERS (775)882-5322

1 Cortez. I'm going to need some clarification.

2 MR. TAULUA: That came from the same case, the
3 violation.

4 BOARD MEMBER CORTEZ: So it's my understanding
5 you were charged in 1996, okay. And I'm seeing here that the
6 parole violation occurred in '06, 2006, right?

7 MR. TAULUA: No. 2002.

8 BOARD MEMBER CORTEZ: Okay. So I've got
9 information that you were arrested for a parole violation
10 based in 2006. In 2006 you were also convicted of bail
11 jumping. You indicated that you were out of jail in 2005.

12 MR. TAULUA: I think so.

13 BOARD MEMBER CORTEZ: Okay. So after being
14 released you picked up some more charges; is that correct?

15 MR. TAULUA: I picked up a DUI in '86 in L.A.

16 BOARD MEMBER CORTEZ: No. No. I'm talking about
17 the 2006. If you were released from prison over in 2005,
18 we've got convictions in 2006 that were not disclosed.

19 MR. TAULUA: They picked me up for being a
20 fugitive in Hawaii because I was wanted. I went to L.A.
21 County before I went back to Hawaii. I went to go do the
22 DUI.

23 BOARD CHAIR NIXON: Okay. So in 2006 you were
24 picked up for bail jumping, promoting dangerous drugs, a DUI,
CAPITOL REPORTERS (775)882-5322

1 false impersonation, special circumstances, carrying a deadly
2 weapon, bail jumping. Oh, so this is like a repeat.

3 BOARD MEMBER BEZICK: Right.

4 BOARD CHAIR NIXON: So page two is a repeat.

5 BOARD MEMBER BEZICK: Right.

6 BOARD CHAIR NIXON: So page one -- 2006 you were
7 picked up for quite a few; is that correct?

8 MR. TAULUA: Yes.

9 BOARD CHAIR NIXON: Okay. Why did you not
10 disclose the stuff that happened in 2006?

11 MR. TAULUA: I don't know. Because I didn't go
12 in for that.

13 BOARD MEMBER CORTEZ: This is Board Member Cortez
14 again. I'm a little confused about your statement because
15 you had to know that you were convicted of additional
16 charges.

17 MR. TAULUA: I understand.

18 BOARD MEMBER CORTEZ: So our confusion is why
19 would you not disclose the most current charge even though
20 you were convicted. I get what you're saying because you're
21 under the impression that it was all lumped together.
22 However, these occurred -- what you're trying to say is you
23 got released from prison and then you picked up an additional
24 charge literally within the year later.

CAPITOL REPORTERS (775)882-5322

1 MR. TAULUA: Right.

2 BOARD MEMBER CORTEZ: My other concern is you
3 failed to disclose. It's a technicality that you've been --
4 we've said over and over again. The application is very
5 clear regardless of the disposition of the situation. That's
6 all I have.

7 MR. TAULUA: I understand because I didn't know
8 because I thought I went back in for the same case, the
9 robbery. That's what the parole board gave me. So I went
10 back in to do my eight years.

11 BOARD MEMBER GRONAUER: Sir, excuse me. Sir,
12 excuse me. Again, just trying to put it in chronological
13 order, it all doesn't work together, okay, because in '96 is
14 when most of the charges came together, okay, not all of
15 them. So it's not the same case.

16 '96 was you went to -- you went to prison for
17 robbery, felony firearm possession, possession of other
18 weapons, and you were convicted of all counts, sentenced to
19 20 years. You disclosed that. I get that, okay. Now then
20 you got out of prison at some time, right?

21 MR. TAULUA: Yes.

22 BOARD MEMBER GRONAUER: When did you get paroled?
23 Yeah, paroled.

24 MR. TAULUA: When did I get paroled?
CAPITOL REPORTERS (775)882-5322

1 BOARD MEMBER GRONAUER: Or probation, sorry.

2 MR. TAULUA: 2016.

3 BOARD MEMBER GRONAUER: 2018 you were in prison.
4 '96 to 2018, that's 12 years.

5 MR. TAULUA: 2016 when they paroled me, January.

6 BOARD CHAIR NIXON: That's 20 years. So you did
7 all your time.

8 MR. TAULUA: I did eight. I was on the work
9 credit program.

10 BOARD MEMBER GRONAUER: Okay.

11 MR. TAULUA: I went back in.

12 BOARD MEMBER GRONAUER: All right. It's totally
13 confusing because none of this seems to work exactly right.
14 I mean, there's a charge for promoting dangerous drugs. It
15 doesn't fit in that time frame of you being in prison. It's
16 all over the place. So it's a whole different charge. And
17 you didn't -- you didn't -- you did not disclose that.

18 So I suggest if you ever have to do this again on
19 any application, whether it's here or for someone else, that
20 you put it in chronological order and if there's years that
21 you're in prison you parenthesize it or you talk to the
22 investigators wherever that may be, okay, before you submit
23 an application because it's very confusing, sir. I mean,
24 it's even confusing to you, all right. So that's it. Thank

CAPITOL REPORTERS (775)882-5322

1 you. I appreciate it.

2 BOARD CHAIR NIXON: Investigator Saladino, were
3 you able to get anything out of that, out of the paperwork?

4 INVESTIGATOR SALADINO: So looking over the
5 fingerprint report it looks like he was sentenced originally
6 for the robbery in January 16th of 1997. In doing the math
7 it was ten years when they charged him with in April 26 of
8 '07 for the bail jumping and stuff like that so that would
9 meet that time frame from where he did his eight to ten
10 years. Then was out and then was on probation, then picked
11 up the other cases.

12 BOARD MEMBER GRONAUER: He picked up the other
13 cases. They are not all stemming from the same case except
14 the bail jumping, if he got bailed out. I don't know how he
15 got out of prison. It might have been just you do half your
16 time, all right.

17 BOARD CHAIR NIXON: Board, are there any further
18 questions?

19 BOARD MEMBER BROWN: Yes, unfortunately. This is
20 Board Member Brown. All that aside, in reading the applicant
21 information work card history it appears by the report that
22 this gentleman had been previously denied in 2018. So I'm
23 wondering if this is a situation where we saw this and said
24 there's too many felonies. Please come back in a year. He's

1 waited multiple years. Is that what is occurring here?

2 I don't know if we have a record of that from
3 2018. It doesn't show a date that he applied. But it shows
4 that he had a work card or he applied in 2018, and we denied
5 him because of the felonies. So I'm wondering if in all of
6 the confusion this is a gentleman that has done what we've
7 asked him to do and he has come back after a number of years
8 to request a new work card.

9 INVESTIGATOR SALADINO: Investigator Saladino for
10 the record. Looking at the record he was denied originally
11 in 2018. The denial was upheld at the March 2019 Board
12 meeting where he was told to reapply in a year. So, yes,
13 Mr. Brown, you are correct.

14 BOARD CHAIR NIXON: And so he came back and
15 reapplied and still didn't get --

16 BOARD MEMBER BROWN: Still failed to disclose.

17 INVESTIGATOR SALADINO: I'm not sure what
18 happened with the first denial but I think it was a failure
19 to disclose on the first. When he came back he already knew
20 he was going to appeal because of the felony robbery.

21 BOARD CHAIR NIXON: Okay.

22 INVESTIGATOR SALADINO: I think the other ones,
23 you know, were added to it, to the denial report this go
24 around.

1 BOARD CHAIR NIXON: So in his application is it
2 paper or on-line? Because just if I might, for the on-line
3 application, once you initially write down the robbery it
4 stops you and it has you call the office and work with the
5 team to put in. So then it can be put down as a no
6 disclosure, right, because technically they did because they
7 stopped with a felony.

8 If he did it on paper and didn't admit to all of
9 the other ones then that's different. So that's why I'm
10 asking that question. Is that?

11 MR. INGRAM: And for the record Kevin Ingram.
12 That is correct.

13 BOARD CHAIR NIXON: Okay.

14 MR. INGRAM: And Board's indulgence.
15 Mr. Saladino is covering for Mr. Swarthout because of the
16 death in the family. So it takes him a little bit longer for
17 him to get this information for you, but he will get you the
18 information.

19 BOARD CHAIR NIXON: Yeah.

20 MR. INGRAM: Thank you.

21 BOARD MEMBER CORTEZ: This is Board Member
22 Cortez. Mr. Taulua?

23 MR. TAULUA: Yes.

24 BOARD MEMBER CORTEZ: Did you apply on paper or
 CAPITOL REPORTERS (775)882-5322

1 on-line?

2 MR. TAULUA: Excuse me?

3 BOARD MEMBER CORTEZ: Did you apply on a paper or
4 did you do it on-line?

5 MR. TAULUA: I filed the paper. I went to the
6 office.

7 BOARD MEMBER CORTEZ: So you filed on paper?

8 MR. TAULUA: Yeah.

9 BOARD MEMBER CORTEZ: I was not a Board Member in
10 2019 I believe. Do you recall why you were denied?

11 MR. TAULUA: Yeah. I was denied but they told me
12 to come back in a year.

13 BOARD MEMBER CORTEZ: Okay. And when you were
14 told to come back in a year what specifically were you told
15 to do, do you recall?

16 MR. TAULUA: Well, because of the COVID.

17 BOARD MEMBER CORTEZ: Okay. At any moment did
18 they tell you to disclose everything?

19 MR. TAULUA: No.

20 BOARD MEMBER CORTEZ: Okay. And when you applied
21 on paper did you read the disclosure that says you need to
22 disclose all of your criminal history regardless of the
23 disposition? I just want to make sure you had a clear
24 understanding of what the instructions were.

1 MR. TAULUA: Yeah, I didn't know.

2 BOARD MEMBER CORTEZ: Okay. No worries.

3 MR. TAULUA: Because I thought it was just for
4 that felony right there. I did not know. I apologize.

5 BOARD CHAIR NIXON: Investigator Saladino,
6 whenever you're ready.

7 INVESTIGATOR SALADINO: The applicant did apply
8 on paper, paper, and he did disclose the robbery where he
9 served as a felon for 20 years.

10 BOARD CHAIR NIXON: Okay.

11 INVESTIGATOR SALADINO: That was the only one
12 disclosed on the new application.

13 BOARD CHAIR NIXON: Okay. So he did disclose the
14 rest of them, the 2006 stuff?

15 INVESTIGATOR SALADINO: No. Only -- we only had
16 the felony robbery on there which would cause the denial.
17 And then, you know, being that he was denied before we did
18 put the felony down again.

19 BOARD CHAIR NIXON: And so the rest -- the other
20 ones, the 2006 and everything else is found by the
21 fingerprints.

22 INVESTIGATOR SALADINO: Correct.

23 BOARD CHAIR NIXON: Anymore questions for the
24 board. Okay. If there's no more questions I'll entertain a
CAPITOL REPORTERS (775)882-5322

1 motion.

2 BOARD MEMBER GRONAUER: This is Gronauer. My
3 motion is to uphold the denial of Lui Taulua because of
4 failure to disclose and that's it.

5 BOARD CHAIR NIXON: I have a motion. Do I have a
6 second?

7 BOARD MEMBER CORTEZ: This is Board Member
8 Cortez. I am going to second the motion. I can't stress
9 enough you have to read the fine print and it's actually
10 bolded. So it's not even fine. This was the second round.

11 BOARD CHAIR NIXON: We have a motion. We have a
12 second. All in favor say aye.

13 (The vote was unanimously in favor of the
14 motion.)

15 BOARD CHAIR NIXON: Motion passes. So you will
16 not get your work card this time. And, look, if you have a
17 hard time understanding the paperwork, this team over here,
18 the office team, they will help you. So when you go to
19 apply -- you can apply in one year. When you go to apply go
20 sit down with them and talk to them. They will help you walk
21 through it step by step. They have your record so they will
22 walk through and make sure you get everything, okay, but they
23 will help you. So just go sit down. They are a good team.

24 MR. TAULUA: So I have to go redo everything
CAPITOL REPORTERS (775)882-5322

1 again?

2 BOARD CHAIR NIXON: Yes, sir, one year.

3 BOARD MEMBER CORTEZ: Please disclose everything.

4 MR. TAULUA: All right.

5 BOARD MEMBER CORTEZ: That's the technicality
6 that frustrates us the most.

7 MR. TAULUA: All right.

8 BOARD CHAIR NIXON: But work with that team.
9 They will help you, okay?

10 MR. TAULUA: All right.

11 BOARD CHAIR NIXON: Okay. Thank you, sir.

12 Okay. We're going to take a ten minute break,
13 team. So come back at 10:25.

14 (Whereupon, a brief recess was taken.)

15 BOARD CHAIR NIXON: Okay. So we're on agenda
16 item number 91, Cari Kramer. Are you here? Good morning.

17 I just want to make sure since we had people
18 walking in, are you under oath, ma'am?

19 MS. KRAMER: Yes.

20 BOARD CHAIR NIXON: You are.

21 Investigator Saladino, please let us know why we
22 declined Ms. Kramer.

23 INVESTIGATOR SALADINO: Investigator Saladino for
24 the record. The applicant was denied for disclosing a 2001
CAPITOL REPORTERS (775)882-5322

1 felony involuntary manslaughter, reckless homicide.
2 Convicted of six years in prison. The applicant was paroled
3 on 8-10 of '05 and was discharged from parole on 8-10 of '07.
4 That was out of Illinois.

5 1973 there was a felony out of Florida for
6 possession of barbiturates and disorderly intoxication. The
7 adjudication was withheld with two years probation out of
8 Florida. Court documents show that probation ended
9 January 31st of 2013.

10 1987 out of Illinois there was a misdemeanor for
11 prostitution. This appears to only be an arrest. The
12 applicant did list her arrest on her application. And she
13 was forthright when asked about the reckless homicide and
14 about, you know, talked about the conviction and the prison
15 time and we're here today.

16 BOARD CHAIR NIXON: Okay. Quick question for the
17 investigator. So I'm wondering if this is a typo. In 1973
18 she was arrested for a felony. It said she was suppose to be
19 withheld two years probation. But the Court docs found that
20 Florida -- from Florida show that probation ended in 2013.
21 That's a lot more than two years.

22 INVESTIGATOR SALADINO: That's correct.

23 BOARD CHAIR NIXON: Okay. Are there any
24 questions for Ms. Kramer?

CAPITOL REPORTERS (775)882-5322

1 BOARD MEMBER GRONAUER: Good morning.

2 MS. KRAMER: Good morning.

3 BOARD MEMBER GRONAUER: This is Gronauer. What
4 have you been doing since 2007?

5 MS. KRAMER: I went to a culinary school in
6 Chicago called Greater Chicago Food Depository. I got my
7 sanitation license. I went to work for Compass Group which
8 is a corporate food service. I worked there for two years.
9 And then I left there and went to a better job which is
10 Wishbone Restaurants in Chicago. I baked for three
11 restaurants. I was a baker. I baked for three restaurants
12 there.

13 And then my old Compass Group called me back and
14 said we have a great opportunity for you. We can give you
15 your own kiosk called Carious Creations. It was a name I
16 made up. And then I baked for them, for them in Chicago in
17 Chase Bank and the basement with all of the kiosks of the
18 food court.

19 And then when I was 58 I got -- I contracted
20 plantar fasciitis in my feet, you know, being on my feet, all
21 that. And so I worked like that for two years and paid and
22 then I said I'm done. I couldn't do it anymore. And that
23 was the only profession I knew. And then I got on
24 disability. And then I've been retired with my husband. We

CAPITOL REPORTERS (775)882-5322

1 moved here three years ago. So I'm 65 now. I was 58 when I
2 stopped working.

3 And now I want to go back to work. I found a job
4 that I can do that won't require me being on my feet. It
5 will be fun. It would bring us extra money because things
6 are very tight now. We're both on social security. So I
7 wanted to be a secret shopper.

8 BOARD MEMBER GRONAUER: Excuse me, what job is
9 that?

10 MS. KRAMER: A secret shopper.

11 BOARD MEMBER GRONAUER: Okay. All right.

12 MS. KRAMER: You know, it's very part-time.

13 BOARD MEMBER GRONAUER: Okay.

14 MS. KRAMER: Very flexible.

15 BOARD MEMBER GRONAUER: I'm sorry. I didn't mean
16 to cut you off. I have the answer. So that's what you plan
17 on doing if you get approved for the work card?

18 MS. KRAMER: Yes.

19 BOARD MEMBER GRONAUER: Is this the first time
20 you've applied for a work card?

21 MS. KRAMER: Yes.

22 BOARD CHAIR NIXON: Can I ask why the probation
23 went so long.

24 MS. KRAMER: What happened was I was very young.
CAPITOL REPORTERS (775)882-5322

1 I think I was 17 years old. And we were in Florida visiting
2 my grandmother, my mother and I. And then I had this charge
3 because I was reckless, young teenager. And then I was sent
4 -- put on probation. And I said -- you know, they said you
5 have to finish your probation in Chicago.

6 Well, my mother said to me, oh, don't worry about
7 it. It's in Florida. You don't have to do it. So I
8 listened to my mother. And then we were on a cruise. And
9 then they arrested me on the cruise for this 1974 conviction.
10 And then, of course, that was let go. That was dismissed,
11 and that's why the probation didn't end until then. I never
12 did any probation for the 1974. I was young. I was
13 listening to my mother.

14 BOARD CHAIR NIXON: Okay. Board, are there any
15 other questions? Okay. Hearing no other questions I'll
16 entertain a motion.

17 BOARD MEMBER GRONAUER: This is Gronauer. I'll
18 make a motion to approve the appeal of Ms. Cari Kramer and a
19 reason for that is time and distance.

20 BOARD CHAIR NIXON: We have a motion. Do we have
21 a second?

22 BOARD MEMBER BROWN: Brown. I'll second.

23 BOARD CHAIR NIXON: So sorry.

24 BOARD MEMBER BROWN: Brown. Second.
CAPITOL REPORTERS (775)882-5322

1 BOARD CHAIR NIXON: Okay. I have a motion. I
2 have a second. All in favor say aye.

3 (The vote was unanimously in favor of the
4 motion.)

5 BOARD CHAIR NIXON: Congratulations.

6 MS. KRAMER: Thank you very much. I appreciate
7 it.

8 BOARD MEMBER GRONAUER: Thank you for following
9 all of the rules. That's the biggest.

10 BOARD CHAIR NIXON: Okay. Item number 92,
11 Antonio Outten. Good morning.

12 MR. OUTTEN: Good morning.

13 BOARD CHAIR NIXON: Hang on one second.

14 MR. OUTTEN: Sure.

15 BOARD CHAIR NIXON: Investigator Saladino, why
16 did we move to decline Mr. Outten?

17 INVESTIGATOR SALADINO: Investigator Saladino for
18 the record. The applicant was denied for disclosing a 2000
19 felony grand theft conviction. The applicant was granted his
20 California 1203.4 and 17 (b) reduction for this case on
21 July 28th of 2021. The applicant provided the court
22 documents. He was not made provisional, as he did disclose
23 on his application, and he's here today for the appeal.

24 BOARD CHAIR NIXON: Were there any questions for
CAPITOL REPORTERS (775)882-5322

1 Mr. Outten?

2 BOARD MEMBER GRONAUER: You pronounce it

3 Mr. Outten?

4 MR. OUTTEN: Yes, sir.

5 BOARD MEMBER GRONAUER: Mr. Outten, if you're
6 approved what do you plan on doing with your card?

7 MR. OUTTEN: A process server. That incident
8 happened when I was a college student.

9 BOARD MEMBER GRONAUER: I didn't understand.

10 MR. OUTTEN: As a process server.

11 BOARD MEMBER GRONAUER: Oh, okay.

12 MR. OUTTEN: I've been a process server working
13 in the legal field for like the last 20 plus years. That
14 incident happened when I was in college. I had my own
15 process serving company in Los Angeles, working for various
16 law firms, also in Arrowhead and in DC. And I moved here
17 right before the pandemic hit.

18 And I work for First Legal right now as a process
19 server specialist running the servers in the middle part of
20 the country. But I wanted to get my license back here. And
21 I knew that application had to disclose everything even if it
22 was dismissed or not.

23 BOARD MEMBER GRONAUER: I'm sorry. Where are you
24 working now?

CAPITOL REPORTERS (775)882-5322

1 MR. OUTTEN: First Legal under Chris Dobb which
2 is my supervisor. They do great legal work here. They're an
3 attorney service.

4 BOARD MEMBER GRONAUER: How long have you been
5 working for First Legal?

6 MR. OUTTEN: Two years now. I moved out here
7 right before the pandemic hit in February. That was my goal
8 to get with them and eventually process serve. But now I run
9 the service right now so that's the next step up so I can
10 serve for them.

11 Also in the future I want to get my, well, near
12 future my notary license and possibly my private
13 investigator's license, you know.

14 BOARD MEMBER GRONAUER: Mr. Ingram, First Legal,
15 your license or the attorney office?

16 MR. INGRAM: I have to defer to Investigator
17 Saladino. He has access to those records, First Legal. He
18 has to look that up.

19 I have to address something. Mr. Outten?

20 MR. OUTTEN: Yes, sir.

21 MR. INGRAM: You are aware that what you're
22 applying for is a registered work card, correct?

23 MR. OUTTEN: Yes, sir.

24 MR. INGRAM: Not a license. Okay. So the
CAPITOL REPORTERS (775)882-5322

1 registered work card allows you to work for a licensed
2 company --

3 MR. OUTTEN: Yes, sir.

4 MR. INGRAM: -- only, not independent.

5 MR. OUTTEN: Yes, sir.

6 MR. INGRAM: Okay. I just wanted to make sure.

7 MR. OUTTEN: Uh-huh.

8 BOARD CHAIR NIXON: Thank you.

9 INVESTIGATOR SALADINO: What's the full name of
10 the company?

11 MR. OUTTEN: First Legal attorney service out of
12 Henderson, Nevada, North Valley Parkway.

13 INVESTIGATOR SALADINO: It sounds like it's an
14 actual attorney's office. You don't have them in the
15 database.

16 MR. INGRAM: Can you verify that in the internet.
17 Thank you.

18 BOARD CHAIR NIXON: And what do you do for them
19 now again?

20 MR. OUTTEN: I'm a service and process
21 specialist. I run the dispatch, all the work for the process
22 servers in the middle part of the country from like Utah,
23 Colorado, Chicago, Tennessee.

24 BOARD CHAIR NIXON: Are you actually running the
CAPITOL REPORTERS (775)882-5322

1 process servers here in Nevada?

2 MR. OUTTEN: No. That's not my -- another
3 co-worker runs the Nevada part. You know, I just run the
4 middle part of the country, dispatching work to them.

5 BOARD MEMBER GRONAUER: So you never served
6 process here?

7 MR. OUTTEN: No, not yet because I have to get my
8 work card. You know, Nevada is pretty strict in their
9 requirements.

10 INVESTIGATOR SALADINO: It is a legal firm in
11 Henderson, Nevada.

12 BOARD CHAIR NIXON: Are there any further
13 questions?

14 BOARD MEMBER GRONAUER: Yeah. Investigator
15 Saladino, they're a legal firm. Are they lawyers?

16 MR. OUTTEN: No.

17 BOARD MEMBER GRONAUER: Are there attorneys?

18 INVESTIGATOR SALADINO: Correct. Yes. There are
19 attorneys.

20 MR. OUTTEN: They are an attorney service.

21 INVESTIGATOR SALADINO: Attorney service?

22 MR. OUTTEN: Yes.

23 BOARD MEMBER GRONAUER: So you understand what
24 I'm trying to get at. If they're is served for a licensed
CAPITOL REPORTERS (775)882-5322

1 firm, licensee or a straight attorney can serve.

2 MR. OUTTEN: Yeah, they are licensed.

3 BOARD MEMBER GRONAUER: Pardon?

4 MR. OUTTEN: They are licensed. And their
5 headquarters is based out of Cali but they have a big branch
6 out of Nevada as well, I mean Henderson.

7 BOARD CHAIR NIXON: While we're looking that up,
8 are there any further questions for Mr. Outten?

9 BOARD MEMBER BROWN: This is Board Member Brown.
10 One quick question. Your conviction in 2000, was that
11 involving a repossession? It states grand theft, money,
12 labor, property?

13 MR. OUTTEN: It was a check when I was in
14 college. I deposited a bad check into my account. You know,
15 I needed rent. I just lost my mother, you know, young
16 college student back then. That's no excuse for that. You
17 know, I paid my restitution, probation. Paid everything I
18 needed to on that. And, again, it was a mistake which
19 followed me for a little while.

20 BOARD MEMBER BROWN: Okay. Thank you. Nothing
21 further.

22 INVESTIGATOR SALADINO: Investigator Saladino for
23 the record. So, yes, First Legal DBA, they are operating
24 under the name American Legal Investigation Services, Nevada
CAPITOL REPORTERS (775)882-5322

1 Inc. DBA First Legal, license number 1452.

2 BOARD MEMBER GRONAUER: Thank you. All right.
3 Mr. Executive Director, you understand what I was trying to
4 get at apparently?

5 MR. INGRAM: Oh, absolutely. And I apologize.
6 My laptop is my tower at the office. So, therefore, I don't
7 have the ability to VP in --

8 BOARD MEMBER GRONAUER: Yeah.

9 MR. INGRAM: -- to do the search. That's why I
10 have to defer to Investigator Saladino.

11 BOARD MEMBER GRONAUER: I appreciate you looking
12 that up.

13 MR. INGRAM: Absolutely.

14 BOARD CHAIR NIXON: Okay. So if there's no
15 further questions, are there any further questions from the
16 Board? There's no further questions I'll entertain a motion.

17 BOARD MEMBER BROWN: This is Board Member Brown.
18 I move that we grant the appeal and allow Mr. Outten to get
19 his work card.

20 BOARD MEMBER CORTEZ: This is Board Member
21 Cortez. I'll second that motion.

22 BOARD CHAIR NIXON: We have a motion. We have a
23 second. All in favor say aye.

24 (The vote was unanimously in favor of the

2 BOARD CHAIR NIXON: Congratulations, sir. The
3 motion passes.

4 MR. OUTTEN: Thank you very much.

5 BOARD CHAIR NIXON: Item number 93, Larson.

6 MR. LARSON: Abe.

7 BOARD CHAIR NIXON: Abe. That is easy. Good
8 morning.

9 MR. LARSON: Good morning.

10 BOARD CHAIR NIXON: Investigator Saladino, can
11 you please let us know why we declined --

12 BOARD MEMBER GRONAUER: Were you sworn in?

13 BOARD CHAIR NIXON: Oh, I'm sorry. Were you
14 sworn in?

15 MR. LARSON: Yes.

16 BOARD CHAIR NIXON: I saw that too. Yeah. Thank
17 you.

18 INVESTIGATOR SALADINO: Investigator Saladino.
19 The applicant was denied for failure to disclose a 2008
20 felony possession of controlled substance for sale, transport
21 controlled substance, possession of controlled substance
22 paraphernalia. He was convicted on all counts. Sentenced to
23 prison. He was stayed and placed on probation for three
24 years out of California.

1 On August 13th of '13 the applicant was granted a
2 1203.4 reduction and dismissal for this case. Documents were
3 located.

4 2016, this one was disclosed for misdemeanor
5 possession of a controlled substance paraphernalia. It has
6 been yet to have been adjudicated because he has an active
7 warrant for this case.

8 2002, felony arrest out of California for
9 possession of controlled substance, possession of a
10 controlled substance paraphernalia. This was dismissed. The
11 applicant did enter a deferred entry of judgment program for
12 this case for 18 months.

13 The applicant listed that he had an active
14 warrant on the application. And he's also circled yes for
15 being a convicted felon but did not disclose what the felony
16 convictions were for.

17 BOARD CHAIR NIXON: Any questions from the Board?

18 BOARD MEMBER BROWN: This is Board Member Brown.
19 I'll ask the question we asked a lot of these folks. Why did
20 you fail to disclose these arrests, sir?

21 MR. LARSON: I didn't -- I actually didn't mean
22 to not disclose. The situation surrounding the application
23 was a group -- was a group setting. It was sort of
24 expedited. I didn't mean to actually just overlook it. I do
CAPITOL REPORTERS (775)882-5322

1 apologize for that. That is no excuse. But I wanted to make
2 sure that I disclosed everything, you know, everything
3 actually, just details were a little foggy.

4 I knew I was going to actually probably -- I
5 actually knew I was going to do this. So I was ready for it.
6 So I apologize for that, you know, being negligent on the
7 application process. But I didn't want to be responsible
8 for.

9 BOARD MEMBER BROWN: Okay. Going along with that
10 you said you would be ready for this. Have you taken care of
11 that warrant?

12 MR. LARSON: Not yet. I'm sorry about that. The
13 situation around that time I was moving back and forth from
14 California to here. So I just haven't gotten to it and --

15 BOARD CHAIR NIXON: That was five or six years.

16 MR. LARSON: Four. Well, actually 2017. My
17 dates are mixed up. Yeah, five years.

18 BOARD CHAIR NIXON: 2016.

19 MR. LARSON: Yes. Yeah, 2016 so, yeah, six
20 years, I know. It's -- that's not right. I know I can take
21 care of it now.

22 BOARD CHAIR NIXON: Okay.

23 BOARD MEMBER GRONAUER: This is Gronauer. If
24 you're moving back and forth for five years, sooner or later
CAPITOL REPORTERS (775)882-5322

1 you're going to be in somebody else's car moving back and
2 forth just going one way.

3 MR. LARSON: Yes.

4 BOARD MEMBER GRONAUER: You have to get that
5 taken care of.

6 MR. LARSON: Yes, sir.

7 BOARD MEMBER GRONAUER: I'm just going to leave
8 it there. Thank you.

9 BOARD CHAIR NIXON: Any further questions from
10 the Board?

11 MR. LARSON: Can I?

12 BOARD CHAIR NIXON: Hearing no further questions
13 I'll entertain a motion.

14 BOARD MEMBER GRONAUER: This is Gronauer. My
15 motion is to uphold the denial for Mr. Larson. And the
16 reason is he has active warrants out and failed to disclose.

17 BOARD CHAIR NIXON: I have a motion. Do I have a
18 second?

19 BOARD MEMBER BROWN: Brown. I'll second.

20 BOARD CHAIR NIXON: I have a motion. I have a
21 second. All in favor say aye.

22 (The vote was unanimously in favor of the
23 motion.)

24 BOARD CHAIR NIXON: So your appeal is not
CAPITOL REPORTERS (775)882-5322

1 granted. However, you do have the possibility to come back
2 later.

3 MR. LARSON: Uh-huh.

4 BOARD CHAIR NIXON: Please take care of that
5 warrant and make sure you disclose everything.

6 MR. LARSON: Okay.

8 it a little bit better. Thank you.

9 MR. LARSON: Uh-huh.

10 BOARD CHAIR NIXON: Item number 94, Brett Smith.
11 Brett Smith? Okay. We'll trail that.

12 Item number 95, Vincent Stevenson. Vincent
13 Stevenson? Okay. We'll trail 975.

14 Item number 96, Damon Deas. Damon? Good
15 morning, sir.

16 MR. INGRAM: Madam Chair?

17 BOARD CHAIR NIXON: Are you under oath, sir?

18 MR. DEAS: Yes.

19 BOARD CHAIR NIXON: Investigator Saladino, can
20 you please let us know why we declined Mr. Deas.

21 MR. DEAS: Thank you.

22 INVESTIGATOR SALADINO: Investigator Saladino for
23 the record. The applicant was denied for a 2006 felony
24 trafficking in controlled substance out of Nevada. He was
CAPITOL REPORTERS (775)882-5322

1 convicted and placed in NSP for a minimum of 24 to
2 120 months. The original arrest had nine counts, all dealing
3 with drugs, transfer, sale. The applicant was granted parole
4 on 11-24 of '09 and was rearrested on 5-17 of '11 for parole
5 violation and sent back to High Desert State Prison.

6 2000 out of Nevada there was a felony where he
7 was convicted for unlawful -- unlawful person to import,
8 transport, manufacture controlled substance. He was also
9 convicted to NSP again for 12 to 32 months.

10 1998, a felony out of Nevada for unlawful
11 possession of sale substance classified as a schedule one.
12 Convicted of 12 months to 24 months. Suspended. To be
13 placed on three years probation.

14 The applicant was rearrested -- was arrested on
15 1-29, 2000 and 5-5 of 2000 for parole -- for probation
16 violations. On 6-5 of 2000 the applicant's probation was
17 revoked.

18 2012 there was a traffic offense where he wasn't
19 registered as a felon. The D.A. denied that charge.

20 My notes here says the applicant did not disclose
21 any of his arrests. And when he appealed he did disclose
22 some of them. The applicant is required to register as a
23 convicted person and appears to be currently registered. On
24 the application he circled no if he had ever been convicted

1 of a felony.

2 BOARD CHAIR NIXON: Any questions from the Board?

3 BOARD MEMBER BROWN: Sir, this is Board Member
4 Brown. Good morning to you. The simple first question is
5 why did you fail to disclose these arrests?

6 MR. DEAS: What happened was when I got the
7 application, my fiance, if you look at the application, you
8 can see her handwriting. And if you look at the answers on
9 the test and also my signature you can tell that that's my
10 handwriting.

11 Now she did tell me make sure you overlook the F
12 before you turn it in. Two days went by because I had to
13 take a test, and I was studying for the test. And then when
14 I did, when I got done with the test, you know, put my name
15 and I just turned it in, wasn't thinking to go back and make
16 sure everything was in order. And, you know, because you can
17 look. She put down with it's her handwriting. But the
18 answers and everything was my handwriting. So I just messed
19 up.

20 BOARD MEMBER BROWN: Okay. The second part of my
21 question would be you have some trouble following rules that
22 when you fail to follow them you can go to jail. What's
23 going to give us the confidence -- what's going to give us
24 the confidence you're going to follow the rules that we have
CAPITOL REPORTERS (775)882-5322

1 even though this is something that won't put you in jail if
2 you fail to follow our rules.

3 MR. DEAS: What's going to keep me there is, you
4 know, continuing to do the right thing. I stayed out of
5 trouble since, what, 2006. I haven't been in no trouble.
6 I'm working, taking care of home. My life has turned around
7 dramatically. I just bought a home. I'm a transporter at
8 Westgate which now currently I'm getting one day a week, two
9 days a week. So now I'm looking for ship parts, just trying
10 other things to try to make up the other half of my job. I
11 currently lost my insurance. So, again, what's going to keep
12 me here is pushing for my family. Pushing for my kids.
13 Pushing for myself.

14 BOARD MEMBER BROWN: Okay. Sir, you say that
15 you've done well. You haven't had any trouble since 2006.
16 But we have arrests in 2010, 2011 and 2012. That's a number
17 of years after 2006.

18 MR. DEAS: I apologize. That was with drugs. I
19 haven't dealt with drugs since then.

20 BOARD MEMBER BROWN: Okay. But you have made
21 some mistakes since then.

22 MR. DEAS: Yeah, I haven't been no -- I stayed
23 away from drugs, selling drugs completely.

24 BOARD MEMBER BROWN: Okay. Thank you.
CAPITOL REPORTERS (775)882-5322

1 MR. DEAS: Again, my life has changed.

2 BOARD MEMBER BROWN: Okay. Thank you. Nothing
3 further.

4 BOARD CHAIR NIXON: Any further questions?

5 BOARD MEMBER CORTEZ: This is Board Member
6 Cortez. Did you really throw your girlfriend under the bus?

7 MR. DEAS: Huh?

8 BOARD MEMBER CORTEZ: Did you really throw your
9 girlfriend under the bus for your application?

10 MR. DEAS: No. Listen, I'll prove to you right
11 now.

12 BOARD CHAIR NIXON: She doesn't know you have
13 felonies?

14 MR. DEAS: No. I mean she knew that I went to
15 prison, but I don't know what she was thinking when she
16 handed this to me.

17 BOARD CHAIR NIXON: Okay.

18 MR. DEAS: Listen to me. Listen to me. I
19 promise you I can call her. She's at work. If she answered
20 that phone right now I can prove to you guys --

21 BOARD MEMBER CORTEZ: Hang on one second.

22 MR. DEAS: -- I'm telling the truth.

23 BOARD MEMBER CORTEZ: I would prefer you just
24 took responsibility instead. I made the mistake in having

CAPITOL REPORTERS (775)882-5322

1 somebody else fill out my application.

2 MR. DEAS: And I own up to that, seriously, I
3 really do.

4 BOARD MEMBER CORTEZ: All right. That's all I
5 have.

6 BOARD CHAIR NIXON: Any questions from the Board?
7 Yes, sir, go ahead.

8 MR. DEAS: If I may speak. I'm going to ask for
9 your guys' to help me out with my life. I'm just here trying
10 to take care of my family and continue to be a better person
11 and with you guys help that will put me in line to do that.
12 Right now I'm trying to apply to get my license, and I need
13 your guys' help. Please. Thank you.

14 BOARD CHAIR NIXON: I appreciate that.

15 Any questions from the Board?

16 BOARD MEMBER GRONAUER: I have more of a
17 statement than anything. Mr. Deas, you asked us for our
18 help, okay.

19 MR. DEAS: Yes.

20 BOARD MEMBER GRONAUER: And I understand that.
21 But you were sitting here for a while and heard previous
22 people of not reporting their things.

23 MR. DEAS: Yes.

24 BOARD MEMBER GRONAUER: All right. It seems like
CAPITOL REPORTERS (775)882-5322

1 you're putting yourself back on the right track and I
2 appreciate that. But you just have to understand, I think
3 Commissioner Brown said it best, you know, you have to learn
4 how to follow all the rules.

5 MR. DEAS: Yes.

6 BOARD MEMBER GRONAUER: No matter where you're
7 at. You have to help yourself, okay.

8 MR. DEAS: Yes.

9 BOARD MEMBER GRONAUER: Don't let anybody else
10 fill out your application. I don't care what -- no. Hold
11 on. I'm giving you some direction. That's all, all right.

12 MR. DEAS: Yes, sir.

13 BOARD MEMBER GRONAUER: And so if you fill out an
14 application again anywhere, anywhere in the world, okay, you
15 make sure you fill it out. You answer the questions. Make
16 no mistakes, and that way it will be better because right now
17 you saw earlier all of the things that we were talking about
18 to everybody.

19 MR. DEAS: Understood, yes.

20 BOARD MEMBER GRONAUER: Not particular to you or
21 anything else what happens here, okay.

22 MR. DEAS: Yes.

23 BOARD MEMBER GRONAUER: Whatever happens here is
24 particular to you. But I'm just saying understand this whole
CAPITOL REPORTERS (775)882-5322

1 process. It's not we don't like you or whatever you. It has
2 to do with you have to help yourself. Thank you.

3 BOARD CHAIR NIXON: I can tell you, sir, as a
4 Board Member and we all feel the same way, we want nothing
5 more than to approve these licenses and put you to work. I
6 mean, we do.

7 MR. DEAS: Yes.

8 BOARD CHAIR NIXON: We understand people have
9 hard times.

10 MR. DEAS: Yes.

11 BOARD CHAIR NIXON: And unfortunately we have to
12 go through the voting process and there is a process to
13 follow.

14 So are there any questions from the Board? Okay.
15 Hearing no further questions I'll entertain a motion.

16 BOARD MEMBER GRONAUER: This is -- this is
17 Gronauer. As much as it is, I think a motion to deny the
18 appeal of Mr. Damon Deas, the reason for mainly not
19 disclosure. That's it.

20 BOARD CHAIR NIXON: We have a motion. Do we have
21 a second?

22 BOARD MEMBER BROWN: This is Board Member Brown.
23 I will second.

24 BOARD CHAIR NIXON: I have a motion. I have a
CAPITOL REPORTERS (775)882-5322

1 second. All in favor say aye.

2 (The vote was unanimously in favor of the
3 motion.)

4 BOARD CHAIR NIXON: Sir, come back in one year.
5 Please note everything on your application.

6 BOARD MEMBER GRONAUER: Meet with the
7 investigators so you can get some information.

8 BOARD CHAIR NIXON: I have number 97, Jeremy
9 Webb. Is Jeremy Webb in? We'll trial number item is 97.

10 Item number 98, Asia Clark-Moore. Good morning.

11 MS. CLARK-MOORE: Good morning.

12 BOARD CHAIR NIXON: Are you under oath, ma'am?

13 MS. CLARK-MOORE: Yes, I am.

14 BOARD CHAIR NIXON: Investigator Saladino, can
15 you.

16 INVESTIGATOR SALADINO: Investigator Saladino.
17 The applicant want was denied for a 1998 felony assault with
18 a deadly weapon. The applicant was granted a 1203.4
19 reduction and dismissal on this conviction on November 23rd
20 of 2020.

21 There was also a 2005 misdemeanor battery that
22 was dismissed. It was not disclosed but it was found on the
23 fingerprints but it was dismissed.

24 There was a 2000 misdemeanor for vandalism under
CAPITOL REPORTERS (775)882-5322

1 \$400 out of California. That was also dismissed.

2 The applicant, once she applied, she provided the
3 1203.4 documents and disclosed the arrest for that 1998
4 conviction.

5 BOARD CHAIR NIXON: Are there any questions for
6 Ms. Moore?

7 BOARD MEMBER CORTEZ: This is Board Member
8 Cortez. As we asked everybody else, Ms. Clark-Moore, why did
9 you fail to report the 2005 and the 2000 conviction or
10 arrest?

11 MS. CLARK-MOORE: Honestly, I recently filed for
12 custody for my niece because she was in the system. I wasn't
13 going to do anything with the family. I've been making do.
14 Oh, I've been making do with it. So I was excited that they
15 allowed me to be a foster parent. Once I was able to get all
16 of this disclosed -- all of that expunged.

17 So once I did that I was so excited about it that
18 honestly I didn't even remember those two because they were
19 dismissed in my life. I didn't even remember them. Just
20 dealing with the felony alone all these years and having to
21 go back and talk about it so many times in order for me to
22 just live a normal life again, I honestly forgot about it.

23 BOARD MEMBER CORTEZ: Just so I'm clear, failed
24 to disclose because you applied or was granted a foster
CAPITOL REPORTERS (775)882-5322

1 parent.

2 MS. CLARK-MOORE: Say that again. I'm sorry.

3 BOARD MEMBER CORTEZ: You failed to disclose or
4 you did not disclose it because you were in the process of
5 being a foster parent?

6 MS. CLARK-MOORE: No. No. No. I didn't
7 disclose it because I forgot about it. I totally, it's been
8 so long even with the felony. The felony has always been the
9 issue for me not being able to do a lot of things when it
10 comes to licensing and things like that.

11 And once I got the actual foster care license and
12 passed all the backgrounds and everything I decided to fill
13 out for this. I do need extra jobs. But for the most part I
14 honestly forgot about them. I didn't even think about it.
15 So I didn't even remember them honestly.

16 BOARD MEMBER CORTEZ: So you recall the 1998
17 felony but did not recall the 2005?

18 MS. CLARK-MOORE: Yeah. When they just mentioned
19 it right now I'm like oh, my God. So I didn't --

20 BOARD MEMBER CORTEZ: Thank you.

21 MS. CLARK-MOORE: Honestly I didn't even
22 remember.

23 BOARD CHAIR NIXON: And they were just arrests.

24 INVESTIGATOR SALADINO: Correct. No charges were
CAPITOL REPORTERS (775)882-5322

1 filed. They were arrests only.

2 BOARD CHAIR NIXON: Again, it was under \$400.

3 Any further questions from the Board? No further
4 questions I'll entertain a motion.

5 BOARD MEMBER CORTEZ: This is Board Member
6 Cortez. I do grant the appeal and overturn the denial based
7 on time and distance and that they were charges that were
8 dismissed. However, you've heard it all this morning.

Was sentenced to nine days in jail and one year probation. This case was dismissed under 1203.4 on March 21st of '08. And the applicant did provide court documents for this arrest.

1994, misdemeanor domestic violence out of California. This was dismissed.

1983, misdemeanor for receiving known stolen property, take vehicle without owner's consent. Convicted on both counts and sentenced to 24 months probation. The applicant did provide court documents for this arrest as well.

The applicant was originally denied and was upheld on September 1st, 2020, for nondisclosure for the DV and the receiving known stolen goods.

The applicant disclosed all of the arrests at this time. He does have an active California or did have an active California guard card from October 6th of '97 to

2 disclosure on all the arrests.

10 forgery in the second degree out of Oklahoma where she
11 received a five-year deferred sentence, 40 hours of community
12 service and supervised probation.

13 This wasn't originally disclosed on the
14 application. However, when she applied in July she came back
15 and brought the arrest history form in October. For some
16 reason it didn't get uploaded correctly. So I didn't have a
17 chance to see that she did disclose after, you know, being
18 made provisional.

19 Reviewing the court documents and the fingerprint
20 report it does show, the way the dates go they kind of went
21 backwards. And once the deferred sentence was approved and
22 restitution was paid, it was reduced to a misdemeanor. So I
23 do have that in the fingerprint report that it did get
24 reduced to a misdemeanor.

13 resist public officer. Count One, disorderly conduct was
14 dismissed and was convicted on the obstruct and resist public
15 officer. That was a misdemeanor.

16 1990, misdemeanor for possession with intent to
17 cocaine based and possession of a firearm during drug
18 trafficking in Illinois. This was also dismissed.

19 1990, out of Tennessee, it was theft of property
20 over \$500. This appears to only be an arrest.

21 1989, there was a misdemeanor out of Illinois for
22 aggravated assault where he was convicted.

23 1988, misdemeanor for obstruct or unlawful
24 possession of cannabis. Count One for the obstruction was
CAPITOL REPORTERS (775)882-5322

1 dismissed. Convicted and served some jail time for the
2 possession of cannabis out of Illinois.

3 1988, misdemeanor theft, less than \$300, first
4 offense. There was a conviction.

5 1986, out of Illinois, criminal damage to
6 property. He was convicted.

7 The applicant came into the office and stated he
8 did not remember all of his arrests that they were all from
9 the late '90s. Court staff did help him find the arrest out
10 of Illinois which the applicant disclosed on his application.

12 as a poster child of how to do this and sit down with the
13 Board or with the licensing. Poster child on how to do this,
14 right, because this was a long time ago.
