UNIFORM & VEHICLE PRE-APPROVAL REQUEST GUIDELINES

Uniform and/or marked vehicle requests **must be submitted on company letterhead** by the current QA or current Corporate Officer/Member of the company. **Please attach your request to an email and send it to sbarroso@pilb.nv.gov.**

Please Note: If you do not follow these guidelines, your request will be denied.

The following information **must** be included in your request:

- Company Name, License Number
- Qualifying Agent/Corporate Officer/Member Name
- Address, City, State, Zip Code
- Phone Number
- Email Address

Full-length photos of the uniform or mockup showing the location of lettering, badges, patches and/or logos **must** be attached:

- Front
- Back
- Each Side

Provide a description of the colors of the uniform, badges, patches, and logo, as not all colors show up well in a photo. The word "Officer" may not be used, you may substitute it with the word "Guard".

You **must** also include **close-up** photos of the following:

- Badges
- Patches
- Logos

A marked vehicle must be clearly identified as "Security" and may not be marked similar or deceptively similar to a Law Enforcement vehicle. You **may not** use the word "Patrol" on the vehicle. If your company intends to use marked vehicles, you must submit a mockup illustration depicting the location of the logos, lettering and wraps on:

- Each side of the vehicle
- Front and Rear of the vehicle

License numbers must be permanently affixed to the driver's side, passenger side and rear of the vehicle and each letter must measure at least 2 inches in height, 1 inch wide and formatted as "PILB1234".

Prohibited items include, but are not limited to:

- The term "Agent", "Officer" and "Investigator"
- Uniform colors of (forest green/tan), (forest green/black), (navy/navy), (tan/tan), (black/black), yellow shirts, pants with stripes
- Star shaped badges, patches or logos
- Shield shaped patches or logos (Shield shaped badges may be used)
- Use of the Nevada State Seal
- Use of a uniform, badge, patch, logo or marked vehicle that are similar or deceptively similar to a law enforcement agency in this State
- The word "Patrol" on marked vehicles
